Checks should be sent to Ms. Yglesias atFood Bank, made out to Emergency Services Fund. Representa tives from Issaquah Community Baptist Church told of Issaquah Food Bank. MSP to accept Ms. Yglesias's report.

Bonnie King described outline of events as submitted by Buzz Kahn in December for Eastside program on Baptism, Eucharist, and Ministry document. The two-day confernce on Feb. 6 and 7 sponsored by Washington Association of Churches was mentioned. This will be held at University Lutherna Church. Shindler suggested EISCC wait until after that to plan its events. Applewhite (who was chairing the meeting) proposed this be item on Feb. agenda.

Nadine Shannon reported on Asian Resettlement Center which is still operating on funds received from churches and individuals. Board being reorganized. Esther Ho now director with Bob Keller as Financial Director. Applewhite spoke on evaluation by committee appointed to advise city council. Pat Meehan added that Walfred Erickson and Paul Sander now are on ARC board.

Shindler agreed to represent EISCC at Interservice Club meeting Jan. 9. Vendeland reported high bank charges; Attwood will assist. Vendeland reporte on Shoalwater Jobs project. \$25,000 raised so far for firewood project. Etc.

IN-HOUSE BUSINESS

Minutes approved as corrected. See pg.1 of 12/10/85 minutes under "Goals for future of EISCC", #2: Bill Hollingsworth recommended a quarterly publication which tells of what we do. Also— The background description of the Human Service Advisory Committee can be found in the 11/12/85 minutes.

A big THANK YOU was extended to LeeAnne Knechtel and Lyn Lambert for the stand up name cards for everybody! Names and faces can't help but be connected.

Quarterly mailing updating churches on the activities of EICSS was mentioned as being in the works. Should St. Margaret's use their bulk mailing permit? Tim Johnson asked for ideas about the type of information that should be included. To whom should it be sent? Just Eastside pastors? Social action lay people?

REPORTS

FISH, 1968-80. Goeff Ethelston This program was formed at St. Margaret's to provide emergency services to those in need in the community. FISH worked to get a core of people (30) to take the phone and refer to others for a 'hands on' response to need. Beginning services included: temporary youth shelter, babysitting, meal packages, gathering up appliances/furniture needed. Non-emergency services included companionship for the elderly, hospital visiting, helping the blind, prayer chain (which could be emergency). FISH ended from burn out of volunteers and the fact that social agencies were beginning to really pull a help network together in the community.

The story of FISH is a good story. Volunteers in the church moved into a gap and filled it well. This story holds a lesson. The churches should always be looking for gaps and then call to the community for help.

REPORTS CONT'D

- Telecare. Nadine Shannon. Overlake Medical Center has this program in which people agree to call elders, people recovering from sickness, etc., being a caring voice and kind of security check. If there is no answer when caller tries to make contact, 911 is sent out immediately. Would this kind of service be a good one for church volunteers?
- Elder Gift Boxes. Carla Vendeland. Over a dozen youth assembled 108 gift boxes which were distributed to the Highland Sr. Center, No. Shore Senior Center, Bellevue Food Bank, Evergreen Care Network. Cost was over 500 dollars. Participating as donors were: St. Margaret's Thrift Shop, Overlake Park and youth year around aluminum recycling. More churches (youth) are needed for next year. Plans include an assembling party AND a small program put on by the staff of Evergreen Care Network to help youth understand some of the problems faced by elder citizens.

For 1986: Newport Presbyterian has requested a report. St. Margaret's Thrift Shop is on board. Girl Scouts are taking over the hand-made candle project, and a member of Aldersgate UMC has donated holiday greeting cards. WE NEED MORE YOUTH!!!!

CRISIS LINE. Debbie Brown. There are three lines in the system: 1) Handles crises 24 hours a day and Holidays...Paid supervisor on hand to help volunteers. 2) Community info. line, M-F, 9-5, staffed by volunteers and refers to local agencies with off hour recording sending people back to #1. 3) Day care referral line which draws on 1500 facilities in King County. The whole complex of lines is served by a computer set up containing 1800 local agencies.

For emergency housing, the Crisis Line has a daily bed bank. BUT THERE ARE NO SHLETERS ON THE EASTSIDE*NOR ARE THERE PLACES FOR HOT MEALS. (*Bothell)

BELLEVUE EMERGENCY SERVICES FUND. Mary Ann Yglesias. Quarterly report handed out. Corrections and additions are included in the report attached to these minutes.

SPECIAL NOTE: St. Margaret's Thrift Shop has just pledged \$250.00 per quarter to BESF. Thrift shop volunteers will be working with BESF to provide clothing too. (Latter is not an accomplished fact: they are working toward this.)

Food Bank Information: 320-360-families being served per week. 600 families received Christmas baskets.

WEEKEND NEED.

According to Crisis Line food and shelter needs are requested during the weekend. Nadine feels that there should be somewhere, like a fire station that might be a place for getting food on the weekends. Overlake Park, as Emergency Feeding outlet, would donate some food boxes. (They already give extra food out on Fridays before weekends.) Overlake Park cannot supply any volunteers. They desperately need volunteers to help during the week days. These are poeple who are on call at home from either 9:30-12:00 or 1:30-4:30 several days per week. When a referral comes through that person is called to come to the church to give out a food box. OPPC IS NOT a good place to distribute food on weekends.

Shelter needs were passed onto the Executive Committee.

ANNOUNCEMENTS: Time is ripe to write state legislators about the housing bill. Info. enclosed. Feb. 8 is the almost annual housing conference of the Church Council of Greater Seattle. St. Thomas passed out "Noel" pamphlet--Nat'l. Organization of Episcopalians for Life. All in secretary's notebook.

I am here tonight to speak on behalf of the need to establish a Human Service Commission.

DRAFT RESOLUTION

We, the Eastside Interfaith Social Concerns, believe that (name of organization)

a community must be concerned about the welfare of all its citizens, including the needy. Therefore, we support the concept that the Bellevue City Government has a role in the functions of planning, facilitating, and funding human services in cooperation with providers and other regional governments. To this end, we support the formation of a Bellevue Human Services Commission made of citizen members to continually assess human services needs and recommend solutions which stress regional cooperation.

Now as we are all aware, any change from the norm attracts those who are supportive as well as those who are opposed. Some of the more noticeable comments which have been made in opposition to the Commission are: just another bureauocracy. concern over cost...the city shouldn't get too involved, etc. As we all know, these concerns are real and certainly have some validity.

However, these concerns become insignificant compared to the real direct problem of accurately assessing the needs & providing the best resources to meet these needs with most effective cost measures. A fresh approach to our Eastside problems, which are real, must be made if we are to succeed. The Human Service Commission is one of the tools that is being developed and is worthy of your support.

This commission will give us the added dimension and forum to:

- -Provide both short and long range goal planning;
- -To allow the effective proactive course taken to meet needs rather than reactive to the problem;
- -Avoids pitting agency against agency in vieing for survival funds...instead they may work cooperatively to meet the needs of individuals as the agency is designed to do;
- -Provide grass roots knowledge of needs as well as needs currently unmet;
- -No strings to any one group so can be free to be objective;
- -Cost effectiveness;
- -Act as advocates for implementing your decisions.

With these as a start, the bottom line is to provide intervention in such a manner that the individual can mainstream into our society again. The Human Service Commission provides the required dimension to accomplish this.

Meeting called to order at 12:05.

Question raised about banks' practise of charging \$5 to cash SS and welfare checks. MSP (moved by Hollingsworth) the committee of 3 be appointed to draftproposal. (Chair later apptd Fisher, Dougan, Vendeland.)

Cresca described plans by St. Margaret's to bring 12 children from Northern Ireland for respite time/learning time to Bellevue area in coming summer.

Jacke reported developments on Eastshore's Latin American refugee sanctuary program; first refugee family has moved on; Eastshore reevaluating, considering anoher; welcomes help, offers peakers. Much discussion ensued.

MSP with one"no"vote: chair to appt committee to draft information sheet to be brought before EISCC in March with a view to passing on to churches. (Chair apptd Jacke, Hollingsworth, Weeks.)

Kahn reported for committee asked to suggest ways for EISCC to promote study of Baptism, Eucharist, Ministry document among Eastside churches. Discussion followed. MSP-EISCC encourages each church to hold at least 3 meetings to study BEM document. EISCC will sponsor general meeting on the afternoon of May 19th at Holy Cross Lutheran Church. Churches should note that Eastgate Congregational has a series planned for 5 Sunday evenings in March and they can look there for guidance and materials. Call acting pastor Fields for information.

Applewhite expressed concern about implications of possible moving of the South African consulate office to Bellevue.

Erickson turned chair over to Meehan because he wanted to discuss matters pertaining to Asian Resettlement Center of which he is now a board member. He reviewed his brief experience with that agency and a meeting he attended of agency representatives and the advisory committee appointed by the city. He believes there is validity in the advisory committee recommendations; also believes problems can be solved. He recommended EISCC go on record stating 1, stating the importance of the agency, 2, stating confidence in ability of ARC board to solve its problems, 3, asking community to support it. He asked churches to be thinking of what support they can give, suggesting a goal of 50 churches giving \$500 per year for three years through individuals and groups like circles and classes. Applewhite, who had served on the advisory committee, said he is not willing to support the recommendation. Much discussion followed. There was a motion to table the recommendation.

The meeting broke up by a show of feet.



REPORTS

Operation Blessing, Richard Bray. Operation Blessing has been created as a direct needs outlet with Christian counselling of the 700 Club of the Christian Broadcasting Network. Money is contributed from the TV show (appeals). Pat Robinson determined that his Christian network should help the needy in 1978. This is how OB got its start. No funds are taken from the appeals for administration. The latter comes from membership fees in the 700 Club. Estimates of helped individuals in Western Wa. for 1984: 250,000.

OB is also designed to help smaller churches develop a social action agenda; it supplies resource people*and refers people in need to churches hoping to match the grant suppplied by the church. Flow chart:



*The Union Gospel Mission will give food for any church wishing to start a feeding program other than a food bank (soup kitchen, etc.).

A new project was announced: Operation Warm Heart. WAnt to supply blankets for the homeless on seattle streets. Price of blanket is good-\$5.00 and Tyee MIddle School is trying to purchase 1500 blankets. (Full report is filed in the secretary's notebook which is brought to every meeting and any part will be copied upon request.)

OB also sponsoring a Crisis Pregnancy Center to "help young ladies keep their babies" at Crossroads Baptist Church. Call OB for more information.

Overlake Serivce League, Kay King. Kay plus two time staff work to help people "stay even". OSL formed in 1911 and helps families within the Bellevue School District. Current load: 100-120 families/ month. Other requirement for help besides geography, a home visit. Funds supplies from the proceeds of the Overlake Service League Thrift Shop in Bell Square. Vounchers are also given to families to shop in the thrift shop. Baby to kid's clothing need the most. (All clothing, etc. is donated.) Shop no. 747-6777

Educational aid is given to Bellevue H.S. grads. This can be vocational or formal schooling. Aid amounts to 1000-1500 dollars per year. A new Kemper Freeman Sr. scholarship will go to a 3rd or 4th year student.

HUMAN SERVICES ADVISORY COMMITTEE, Harry Applewhite. The City Manager of Bellevue has appointed a committee made of 7 people from all walks of life-- church, business, etc.-- to examine what the City of Bellevue can do in the way of human services with so much federal and state withdrawal of aid. This Human Ser. Ad. Comm. will be meeting every 3 weeks (first meeting already occurred). To date, the city only gives block grant monies. Biggest problem: Where does one start?

M/S/P: A subcommittee was formed to develop a draft statement and circulate it to churches. The subcommittee will work to put together church input through Harry. SCommittee members to be: Mary Meda, Carla, Nadine, Walfred, with resource people-- Mary Ann, David Bloom, etc. First meeting, 25 Nov. Noon, Harry's church.

REPORTS

St. Vincent de Paul, Pat Meehan.

St. Vincent's was founded 153 year ago in Paris by 6 students. In one year afterwards, 12 conferences were established. Today, St. Vincent's is international in scope with conferences in almost every country in A conference is a Catholic parish organization with about 10-18 volunteers. There are 45 active conferences in the Seattle area including 450 volunteers. Overall, there are only 2 paid staff.

St. Vincent store s are separate from the conferences. But their profits support the work of the conferences (plus work for handicapped people).

All type of help/aid is given by the conferences. When help is requested, 2 members of a conference go out for a home visit. St. Vincent's helps all regardless of race, religious orientation, sex. St. Vincent's cooperates with other direct help organizations in the community when possible. no federal aid or United Way funds. 95% of all aid goes to non-Catholic people. Funds are also given from churches. Last year over 50,000 in kind contributions and 20,000 in cash.¥

Goals for future of EISCC (All members suggesting)
