SHELTER TASK FORCE. Darlene Sabah, et al. The Shelter Task Force brought forth a proposal which laid out a formation of an Eastside Coalition for the Homeless. Concerns around the proposal centered on the process of formation of said Coalition. Members wanted to include their congregations in on the very base line and did not want to present to them a fait accompli. After good exchange, the following proposal (using the Shelter Task Force's proposal as a base) was placed up for motion by Sally Wing, seconded and passed:

Eastside Interfaith Social Concerns Council requests that the EISCC SHelter Task Force call a meeting to consider the formation of an Eastside Coalition for the

Homeless to foster awareness and stimulate action on meeting the needs of the homeless on the Eastside. This proposal is supported by:

-A United Way report recommendation

-The EISCC November Report

-EISCC perception of a coalition as the best vehicle for implementing EISCC shelter committee proposals

We propose that we invite representatives of <u>congregations</u>\*, business<u>es</u>, social service agencies, service clubs and other interested citizens and groups on the Eastside including Eastside Human Services Council to an organizational meeting to to consider the creation of a coalition to:

-Increase community awareness

-Advocate for policies/programs to assist the homeless

-Assist congregations in sponsoring shelter or finding other ways they can be more directly involved.

\*Secretary changed 'church' to congregations and business'to businesses.

All members of EISCC are to go back to their congregations and put the proposal before the appropriate groups to sound out interest levels and gather any commitment of persons with expertise and/or interest.


LEGISLATIVE TASK FORCE REPORT. Elizabeth Fisher replaces Bill Hollingsworth as Chair. Carla Vendeland reported on the Legislative Conference sponsored by the Washington Association of Churches, 24 January. Two "hot" topics were the usual bafflement about where to get funds and the sruggle over who's going to get the funds. Welfare "reform" in the guise of the Family Independence Program might just unceremoniously slip through—but without extra funding. This is very hard to take, for extra funding for subsidized day care without any fashionable "reform" would take many women off the dole of several programs immediately. An article will be enclosed with the minutes. Carla also handed out copies of the latest ALERT, the weekly legislative update put together by WAC and the Washington State Catholic Conference about legislative happenings and the Statement of Legislative Principles. Hopefully we will sponsor this event next year, and get more of us interested in attending.

YES and FOY join hands to work common problems. Claude Carlson and Pat Helgren described how Youth Eastside Services and Friends of Youth are doubling up to meet more problems of youth by sharing their expertise. YES tends to the bookkeeping andfurnishes a part time counselor in Issaquah. FOY tends to counselors and tangible shelter space and foster homes. There are large numbers of runaways on the Eastside. Youth have either been thrown out or they have to get out of their family scene. Not only is shelter needed for runaways, but also the increasing number of pregnant teens need a group home setting. ONe of the biggest needs is the need for volunteer shelter home. There are 12 to date from Maple Valley to Woodinville, but none in Bellevue. To find out more about this need, contact the Issaquah Youth and Family Program, 392-6367. YES offers employment workshops for youth, has an extensive drug abuse program. For more information, call 747-4937.



# CONSTITUTION AND BYLAWS OF THE EASTSIDE INTERFAITH SOCIAL CONCERNS COUNCIL (Adopted 12/11/84; Revised 1/13/87)

#### ARTICLE I - NAME

Section I

The name of the organization shall be the Eastside Interfaith Social Concerns Council.

#### ARTICLE II - PURPOSE

Section I

The purpose of the EISCC is to provide a means of communication between eastside congregations and the community in the field of social concerns. It will provide a means for developing cooperative interaction between congregations. The Council will endeavor to promote activities relating to human needs. Member congregations will also participate in various activities, including celebrations and opportunities for dialogue, to improve community awareness and service.

#### ARTICLE III - MEMBERSHIP

Section I

Membership in EISCC is on a voluntary basis. Membership is open to all eastside congregations incorporated as "non-profit religious organizations" under the laws of Washington State. Membership shall be by congregational action. A roster of member congregations shall be established at the September meeting and maintained throughout the year.

Section II

Each member congregation shall select two (2) voting representatives, preferably one clergy and one lay representative.

Section III

Each member congregation shall contribute twenty dollars (\$20.00) annually to EISCC, prior to the October meeting.

## CONSTITUTION (Cont'd)

#### ARTICLE IV - OFFICERS

Section I

The officers of the EISCC shall be Chairperson, Vicechairperson, Secretary and Treasurer, and these shall constitute the Executive Committee.

Section II

The election of the officers of the EISCC shall be made by the Council at the October annual meeting. A nominating committee elected by the Council at the May meeting shall propose a slate of officers to the September meeting. Further nominations may be made from the floor at the annual meeting. The term of office shall be one (1) year.

Section III

Upon the occurrence of a vacancy within the term of an officer, the unexpired term shall be filled by appointment of the Chairperson from the remaining members of the EISCC, subject to confirmation by the membership.

#### ARTICLE V - MEETINGS

Section I

The EISCC will meet monthly. The Annual Meeting shall be the October meeting.

Section II

Special meetings may be called by the Chair with not less than ten (10) days notice of time, place and agenda being made to the congregational representatimes.

Section III

A quorum shall be constituted when one-third (1/3) of the member congregations are represented.

Section IV

Actions and voting procedures of meetings shall be governed by Roberts Rules of Order except in the case where EISCC addresses issues of social concern with recommendation for local congregation or community policy or action. In this case, the Procedures contained in the Bylaws shall be followed.

#### ARTICLE VI - COMMITTEES

Section I

Standing committees and Task Forces will be appointed by the Chairperson, as required, to perform tasks of the EISCC.

#### ARTICLE VII - AMENDMENTS

Section I

The articles of this consititution may be amended by a two-thirds (2/3) vote of the representatives present and voting from the member congregations provided that a thirty (30) day prior written notice of the amendment has been given.

#### BYLAWS

ARTICLE I - PROCEDURES FOR PUBLIC RECOMMENDATION AND ACTION

The following procedures for public recommendation and action outline steps designed to encourage broad study, discussion of alternatives, and concensus building prior to a vote of EISCC representatives and the reporting of their action.

# BYLAWS (Cont'd)

- Issue is raised by local congregation, social agency or EISCC subcommittee at a reqularly scheduled meeting. Alternative courses of action are considered. Where anticipated, a description of the issue to be discussed should be included in a meeting notice.
- A proposed study statement is drafted and submitted to local congregations for discussion and action prior to the next meeting. (This statement is not for public release.)
- 3. Local congregations individually act upon the proposed study statement.
- 4. At the next EISCC meeting, the proposed statement is discussed, language tightened, amended and voted upon by EISCC representatives. A quorum being present, two-thirds (2/3) of the representatives assenting shall constitute approval.
- 5. Public release of the Final Statement should include the following:
  - a) A "Disclaimer" stating that the statement represents the thinking of the EISCC board of local congregational representatives and does not imply official endorsement of the specific congregations or denominational bodies.
  - b) A tally of the final vote indicating "for", "against" and "abstain".
- 6. When any issue requires urgent response by the EISCC, a proposal may be presented to the council at a regular meeting. The proposal will be discussed, language tightened, amended as appropriate, and voted upon by the EISCC representatives. A unanimous assent of those present and voting shall be required for approval. Any release shall carry a notice that due to time constraints, the congregations have not yet voted upon this issue.
- 7. When any issue requires urgent response by the EISCC, but the draft proposal fails to receive unanimous consent of those present and voting, the officers may meet to draft a proposal which shall be sent to members with a notice of meeting, the date of said meeting to be no less than ten days from the date of posting. The proposal shall be discussed and acted upon as described in Bylaw #4. Any release shall carry a notice that due to time constraints the congregations have not yet voted upon this issue.
- 8. These Bylaws may be amended by a two thirds (2/3) vote of the representatives present and voting from the member congregations, provided that a 30 day prior written notice of the proposed amendment has been given.

#### ARTICLE II - ASSOCIATE MEMBERSHIPS

- 1. Associate memberships may be extended to constituent groups in the areas of social and health services whose philosophies are consistent with the purposes of EISCC.
- 2. Associate members shall have voice but not vote.
- Associate members shall pay a fee of \$10.00 annually, upon application and thereafter prior to the October annual meeting, to cover administrative costs.
- 4. Associate members shall receive the monthly mailings of the EISCC.

# OFFICE OF THE ATTORNEY GENERAL

#### FACT SHEET

Cause No. U-86-131 Produced by Public Counsel April 1, 1987

#### BACKGROUND

Puget was one of four investor owned utilities (IOUs) that contracted with WPPSS for a share of WPPSS #3. Puget had a 5% share. In the spring of 1983, with the plant two-thirds built, WPPSS found that it could no longer finance the remaining construction. The plant was "mothballed" and construction was suspended until financing could be found and until the power was needed. The plant remains "mothballed" at this time and may never be completed. Puget's investment in WPPSS #3 currently is approximately \$170 million. In addition, ratepayers have paid to Puget \$30 million in Construction Work In Progress (CWIP) for WPPSS #3 before the State Supreme Court ruled the inclusion of CWIP in rates illegal.

After construction was halted, Puget and the three other investor owned utilities sued WPPSS and BPA for a breach of contract, claiming that the parties had a duty to continue building the plant. Eventually, an out-of-court settlement was reached, known as the "Settlement Exchange Agreement". As part of the settlement, Puget and the other IOUs in effect traded their investment in WPPSS #3 in exchange for BPA selling to the IOUs an amount of power roughly proportional to their investment in the project and at the approximate cost that it would have cost had WPPSS #3 been finished. This power is supplied in the winter months for 30.5 years. In addition to their investment, the IOU's must also pay to BPA the variable operation and maintenance costs for the power received, as if the plant was actually operating. Finally, the IOU's must make available their combustion turbines to provide this energy to BPA if BPA cannot provide it.

#### PUGET'S REQUEST

Puget is now seeking to use the Settlement Exchange Agreement to require ratepayers to pay for its \$170 million investment in WPPSS #3. This investment consists of approximately \$103.8 million in direct expenditures, \$29.3 million in capitalized interest, and \$35 million in capitalized return to stockholders.

In addition, ratepayers have already paid \$30 million in Construction Work in Progress (CWIP). There are three parts to Puget's request. It wants: 1) to recover 100% of its \$170 million investment; 2) to recover an interest return on the \$170 million investment; and 3) to pass on the variable costs of buying the "Settlement Power" from BPA. Based upon Puget's estimates, these total costs will amount to at least \$650 million over the 30.5 year period of recovery and will require a rate increase in the neighborhood of three percent in the first year.

Puget has taken two steps that it claims will reduce the rate impacts. First, it will recover only interest and the variable costs for the first three years, with the principal recovery to begin in the fourth year. Second, Puget has created a whollyowned subsidiary, called Puget Energy, which will sell the power to Puget and use debt-only financing. Puget claims that its use of the subsidiary's ability to debt finance reduces the costs to ratepayers.

#### POSITION OF THE OTHER PARTIES

Hearings have now been held to consider the views of other parties to this proceeding. Expert testimony has been presented by the WUTC staff and Public Counsel in opposition to Puget's request. Other parties which have not filed testimony in the proceeding are BPA, People's Organization for Washington's Energy Resources (POWER) and Washington Industrial Committee for Fair Utility Rates (WICFUR).

#### A. POSITION OF WUTC STAFF

The WUTC staff challenged several important aspects of Puget's proposal. The WUTC staff consultant Charles Komanoff, has stated that a prudent utility would have terminated the WPPSS #3 project in 1979, following the Three Mile Island nuclear accident. By that time, soaring construction costs and project delays made continued construction imprudent. His analysis would allow the company to recover its investment made through 1979, but not after that time. He made no disallowance for costs caused by mismanagement or waste in the project. In addition, Puget would be allowed to recover the value of the power that it will receive from the Settlement Exchange Agreement with BPA, based upon Puget's avoided cost rate.

He states that ratepayers should not pay any more for WPPSS #3 and the BPA power than the sum of the costs of terminating the project in 1979 plus the value of the Settlement Power minus the CWIP paid by ratepayers to date. He recommended that the amount chargeable to ratepayers should not exceed \$53.2 million plus the BPA variable costs, collected on a fixed schedule. Since he

believes that these variable costs will be higher than Puget estimates, he suggests only a \$34.8 million recovery if the level of variable costs is not fixed. This would allow Puget to recover from 33.9% to 22.3% of its investment depending on the treatment of variable costs. Another Staff witness cautioned that the use of the Puget Energy subsidiary could result in additional costs to ratepayers unless capital structure adjustments were made in rate proceedings over the next 31 years.

#### B. POSITION OF PUBLIC COUNSEL

It is Public Counsel's position that Puget's presentation grossly understates the true costs to ratepayers of its proposal, which could easily exceed \$1 billion. Public Counsel has presented testimony that ratepayers should not have to pay any more for the Settlement Exchange Agreement than the power that it provides is worth. According to Public Counsel's consultant, Jim Lazar, the money that ratepayers have already contributed through the inclusion of CWIP in rates more than covers the value of the Settlement. He states that the power produced under the Settlement Agreement is nothing more than surplus hydroelectric power available in all but the driest years backed up by Puget's own combustion turbines. Puget could obtain similar power without the Settlement Agreement and without its WPPSS #3 investment. Therefore, Public Counsel has recommended that Puget should only be allowed to recover its variable costs of buying Settlement Power based upon a fixed escalation rate and should not be allowed to recover any of its investment in WPPSS #3.

The testimony also urges rejection of the use of the Puget Energy subsidiary, since it is, in effect, a shell game which hides the real costs of the transaction and may result in ratepayers paying for both 100% of Puget's \$170 million investment in WPPSS #3 and a full profit to stockholders on that investment. The use of this subsidiary for financing may also shift additional costs to residential and small commercial ratepayers from large industrial customers. Finally, Mr. Lazar states that Puget's WPPSS #3 investment is inflated by substantial waste and mismanagement costs, which should be disallowed if the positions of either Puget or the staff are adopted.

#### C. OTHER PARTIES

No other parties have presented testimony at this time. They may take positions in written briefs filed with the Commission at the end of the case.

#### April 7, 1987 Presentation

#### Bellevue Human Services Commission

What are St. Vincent de Paul, Bellevue Community College, Eastside Mental Health, Northshore MultiService Center, United Way, and Overlake Christian Church all citing as a crying need here on the Eastside? SHELTER. They are seeing an increasing need for both emergency and low cost housing.

BCC has cited instances of women with small children living on campus in their cars. A church in Eastgate gave a family permission to live in their car in the parking lot. MultiService Center of NE King County has noticed people living in their parking lot.

Let me introduce myself. My name is Geoffrey Ethelston. I am speaking here tonight on behalf of a new organization: Eastside Coalition for the Homeless. We are a newly-formed group of social service agencies, churches and concerned citizens who have gathered to respond to the growing number of housing requests we are all receiving.

We have conducted a survey of the churches here on the Eastside to determine the amount of requests they are receiving from people with emergency needs. Although the final tabulation of the survey has yet to be done, we do know that the churches that have responded are reporting a high number of requests for emergency shelter.

We studied recent reports on shelter needs done by the MultiService Centers, the City of Bellevue Planning Department, King County Housing and Community Development Division, Eastside Human Services Featuring Committee, and United Way.

We discovered that although the population of the Eastside is about 40% of the size of Seattle's, we have 6% of the shelter beds in the Metro area. Seattle has 91%. In 1986 one agency, Eastside Domestic Violence, honored 276 requests for shelter. They turned down 550. Other agencies are having similar experiences. We are not meeting the current need on the Eastside for shelter.

Bellevue's population is growing rapidly. By the year 2000 it is expected to increase by 38% over 1980 levels. The need for social services is growing even more rapidly. The growth in jobs that we are seeing is greatest among those jobs that pay the least. As a consequence lower income households are projected to increase from 4,600 in 1980 to 10,600 in the year 2000, a 129% increase.

Population density is increasing. Already half of our residents live in multifamily housing. That percentage is increasing. Our population is growing older, poorer, and more ethnically diverse. All of these are indicators that the need for social services will grow faster than the population rate.

We are proud to live here in Bellevue. We would like to see this area develop its own distinctive identity. We enjoy the high quality of life available to us here. Yet the benefits of life here are not equally available to all our citizens. We are not adequately caring for our homeless poor. Giving a person bus fare to Seattle is not giving him or her adequate care. It is time that we accepted the responsibility to care for the poorest of our citizens. People should be able to continue to live in their hometown where they have a network of friends and neighbors to support them in their time of need and assist them to become self-sufficient once again.

We urge you to listen carefully to the requests for emergency housing support that you receive. Make funding for more shelter beds in Bellevue a major priority for our community. Also, let us work together to make more desperately-needed, low-cost housing available to our low income residents.

We would like an opportunity to meet with you at a later date to discuss emergency shelter and low income housing proposals. We will contact you to set up a date.

Congratulations to each of you on your selection to this new commission. We appreciate your efforts to serve the people of our community. Thank you for the opportunity to speak at this hearing. We of the Eastside Coalition for the Homeless look forward to working with you.

EAST KING OPTIONS- Betty Smith, Volunteer Manager. They are coming up on their third birthday in the Bradford House, Bellevue First Cong. Church (U.C.C.). Most clients suffer from Altzheimer's disease.

BELLEVUE EMERGENCY SERVICES FUND- Mary Ann. In 1986, 14 churches gave \$2489 in first quarter and in 1987, 12 churches gave 2987 in first quarter. Families helped range innumber from about 38-43 per quarter. Mary Ann showed the famious "pink card" which churches should pass along with person that needs help. 


For the record, I would like to outline what has taken place to date with Mr. Riley and me. In March, Mr. Riley called requesting to speak to the Council:

Minutes were approved as corrected, substituting 5:15 for 7:30 as begining time for the Eastside Coalition for the Homeless. Sections omitted from the Bylaws are available for the asking.

Treasurer's Report. Current balance- \$292.63.

Nominating Committee. This will be a standing committee. Members are to present a slate of officers in September which will be voted on by the whole group in October. Members elected to the N.C. are Tim Johnson, Carla Vendeland (upon her consent), and Buzz Kahn.

Bellevue Emergency Services Fund; Dick Jacke. Dick requested feedback on such topics as what geographical area we should be serving and what we are missing. The committee has been seeking information from organizations providing similar services and serving the same population. (The latter is done through pretty extensive networking.) The fund is not necessarily viewed as an initial source of aid by the committee, but as a help to begin some kind of "recovery" for the person in need. The limit of help has been raised to \$125. Expansion of the hours of service is being considered. Members of committee are: Robbie Russ, Elizabeth Fisher, Carla Vendeland, Bonnie King, Dick, Dorothy Scott, Nadine Shannon.

Family Life Ministry Workshop Report; Beth Boyd. 50 participants heard Dennis Guernsey challenge them toward development of relationships, which lead them toward a primary relationship with God. He presented the concept of small groups, as in huge Korean churches, which are supportive to individuals in times of crises.

Emergency Feeding Program; Otis J. Moore and Mary Washington. Program is 10 years old, and serves up to 1400 families per month with a 2-day supply of nutritionally balanced meals for up to 5 people. A package for infants is also available. There are 29 distribution centers in King County. The outlet at Overlake Park Presbyterian Church serves 250 families per month. There has been a 50% increase over the past year in the number of persons served during January and February. On the Eastside, 17 churches contribute food, funds, and volunteer time. A part-time community resource coordinator and a part-time truck driver will be paid positions, serving the Eastside, when sufficient funds have been obtained. Christmas in July is an opportunity for giving. (Summer time is NOT a heavy donation time for dollars and food.)

EISCC Meeting Minutes May 12, 1987

PROGRAM. Anti-Semitism.

Marvin Stearn, Anti-Defamation League

ADL was founded 74 years ago to defend right or minorities. Anti-Semitism no longer affects where people live and work, but still includes attitudes. There has been an increase among young well-educated Blacks, contrasting with a decline among other demographic groups. Incidents of harassment reported to the ADL increased until in 1981 legislation in Washington and other states was passed making such harassment a felong. The degree of anit-Semitism reflects society's treatment of minorities generally. Stearn presented surveys to the groups of attitudes toward Jews, and of personal contact with Jews. He noted the importance of education in dispelling negative attitudes. Materials are available from the ADL office to assist in educating children about attitudes.

#### ANNOUNCEMENTS

Sally Wing (Grace Lutheran) was elected to the Nominating Committee of the Evangelical Luterhan Church in America.

Robbie Russ, Salvation Army, announced a campership program for children ages 8-13. (747-6392)

David Bloom, CCGS, announced publication of a "state of the city" report on homelessness. The report is intended for c ongregational study, and will have an action guide available in June. Copies are now \$3. Bloom stressed the importance of education and community-wide response.

Report- Harry Applewhite on Spanish Sabbatical. Harry studied the mytics in Spain and visited the Taize Community in France which is a monastic community. This community is known for helping Jewish refugees escape France during the Holocaust. It is founded in the Swiss Reformed Church with a current strong emphasis on reconciliation between Catholics and Protestants. Harry was struck with worship—a 700 voice choir and the freedom to leave worship when one is finished. Community supports an international youth reconciliation thrust. Harry has also just completed a 2 eleven day residencies in the SHELEM Institute delving into the spiritual realm of ministry— not as a means of escape but as a means of helping people discover a deeper journey with God.

YES- Bob Fitzgerald. Bob is a U.C.C. pastor. He feels that YES is a direct extension of his ministry into the community. He works to get churches to cooperate with the staff and programming of YES (Youth Eastside Services). YES works to prevent problems arising between youth and families and serves elementary school children (who are approaching adolescence) and their families. Service includes treatment, counselling, energetic provision of resources, networking. Bob provided an annual report and a filefolder with pertinent information. Greater Kirkland Ecumenical Parish. Walfred Erickson. An incredible demonstration of grass roots ecumenism. To: Eastside Interfaith Social Concerns Council Subject: Bellevue Emergency Services Fund Review

The Task Force reviewed the current guidelines for the Bellevue Emergency Services Fund. The general intent of the original guidelines still fits very well with our perception of the current practice and need. We have recommended that the annual limit be increased from \$100 to \$125; but most of the other proposed changes are clarifications and/or corrections of names and addresses to correspond to present facts.

The fund itself has grown dramatically since its inception in 1983. Mary Ann Yglesias of the Bellevue Multi Service Center has indicated to us that further dramatic growth would place severe stress upon the Multi Service Center. If the fund is to grow significantly, we need to find new ways to support the efforts of the Multi Service Center as administrator of the fund. This might meen additional staff for the Center, or it might mean additional volunteer staff from our congregations to assist the Center staff. These changes are seen as needing considerably more research and/or negotiation before a new plan can be determined. The present Task Force believes that such a new plan is beyond the scope of the present mandate.

The Task Force has discussed three specific ways in which the fund might grow: (1) new donations from congregations not presently contributing, (2) increased giving by present contributors, and (3) acceptance (perhaps even promotion by the fund) of contributions from the community at large. The first option is something which we believe that we should be doing now. The others should only be attempted after the problem of additional staff support has been resolved.

The Task Force also believes that there are a number of things that could be done to improve our communications about the fund which might also have a positive, if more indirect, impact on our contributions. We believe that we should have a pamphlet on the fund for interested persons/congregations, we should have trained (or at least knowledgeable) persons who would be available to make presentations on the fund for interested congregations, and we should ask for an annual pledge from those churches who wish to participate. Beacause of the high turnover in all areas, we felt that all congregations should receive materials on the fund each Fall. Better follow-up is needed in many areas with our congregations.

As you know, the EISCC is currently applying for a Recognition of Tax Exemption from the IRS which would permit us to apply for a special third class bulk mailing permit. In order to process our application, the IRS has requested proof that each of the member organizations are "churches" under their definition of law. We need to supply them with this verification if we are to receive our exemption.

Congregations which are part of a national denomination/church need only provide an official letter (signed and dated by a pastor or officer of the congregation) indicating the national denomination/church of which you are a part. Congregations which are not part of a recognized national body must fill out a copy of Questionnaire C which is attached.\*\*

These letters and questionnaires must be returned very soon to Dick Jacke; 626 108th Ave. S.E.; Bellevue, WA 98004. If you can bring the letter or Questionnaire to the August meeting, that will be soon enough; but if you cannot do that, please mail it to me before the next meeting date. If we do not get these repies in promptly, our application may be closed and we might need to start this entire process again from scratch.

#### Program

Doris Cooper, Mayor of Kirkland

The human services issue has moved to a job of putting our money where our mouth is. Our job is one of setting up some of our own individual programming and investigating and joining joint efforts with other communities. A big problem to avoid: We don't want people shopping between cities for human services. To date we have directed \$2 per person or about \$40,000 to human services.

Our human services committee is one of seven people—3 staff and 4 community. Currently we are advertising for 2 vacancies. Our biggest problem is that we can't use agency board members because of a danger of conflict of interest. The human services committee is one which funds and coordinates. There is no direct vending. Priorities toward funding are: Promotion of self sufficiency and independent living; low-income to poverty levels; accessibility. Agencies should seek a funding application now. Monies will be distributed in November.

Looking at the introduction of more health services into the communities from Bothell to Renton. Agencies working the problem now are United Way, Multi Service Center of N.E. King County and the So. King County Health Center. The latter has a \$50,000 grant to begin service on the Eastside.

Where does most of the motivation come to "do good"? Motivation lies within the council members of Kirkland for the most part. Churches are not a big voice.



# CONSTITUTION AND BYLAWS OF THE EASTSIDE INTERFAITH SOCIAL CONCERNS COUNCIL Adopted 8/11/87

#### ARTICLE I -NAME

Section I

The name of the organization shall be the Eastside Interfaith Social Concerns Council.

#### ARTICLE II -PURPOSE

Section I

The purpose of the EISCC is to provide a means of communication between east-side congregations and the community in the field of social concerns. It will provide a means for developing cooperative interaction between congregations. The Council will endeavor to promote activities relating to human needs. Member congregations will also participate in various activities, including celebrations and opportunities for dialogue, to improve community awareness and service.

Section II

No part of the net earnings of this organization shall ever inure to or for the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be empowered to pay reasonable compensation for services rendered and to make distributions and payments in furtherance of the exempt purposes for which it was formed.

Section III

Notwithstanding any other provisions of these articles, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954.

#### ARTICLE III -MEMBERSHIP

Section :

Membership in EISCC is on a voluntary basis. Membership is open to all east-side congregations incorporated as "non-profit religious organizations" under the laws of Washington State. Membership shall be by congregational action. A roster of member congregations shall be established at the September meeting and maintained throughout the year.

Section II

Each member congregation shall select two (2) voting representatives, preferably one clergy and one lay representative.

Section III

Each member congregation shall contribute twenty dollars (\$20.00) annually to EISCC, prior to the October meeting.

### CONSTITUTION (Cont'd)

#### ARTICLE IV OFFICERS

Section I

The officers of the EISCC shall be Chairperson, Vicechairperson, Secretary and Treasurer, and these shall constitute the Executive Committee.

Section II

The election of the officers of the EISCC shall be made by the Council at the October annual meeting. A nominating committee elected by the Council at the May meeting shall propose a slate of officers to the September meeting. Further nominations may be made from the floor at the annual meeting. The terms of office shall be one (1) year.

Section III

Upon the occurrence of a vacancy within the term of an officer, the unexpired term shall be filled by appointment of the Chairperson from the remaining members of the EISCC, subject to confirmation by the membership.

#### ARTICLE V - MEETINGS

Section I

The EISCC will meet monthly. The Annual Meeting shall be the October meeting.

Section II

Special meetings may be called by the Chair with not less than ten (10) days notice of time, place and agenda being made to the congregational representatives.

Section III

A quorum shall be constituted when one-third (1/3) of the member congregations are represented.

Section IV

Actions and voting procedures of meetings shall be governed by Roberts Rules of Order except in the case where EISCC addresses issues of social concern with recommendation for local congregation or community policy or action. In this case, the Procedures contained in the Bylaws shall be followed.

#### ARTICLE VI - COMMITTEES

Section I

Standing committees and task forces will be appointed by the Chairperson, as required, to perform tasks of the EISCC.

#### ARTICLE VII -AMENDMENTS

Section I

The articles of this constitution may be amended by a two thirds (2/3) vote of the representatives present and voting from the member congregations provided that a thirty (30) day prior written notice of the amendment has been given.

#### ARTICLE VIII - DISSOLUTION

Section I

In the event of the dissolution of the EISCC, any assets remaining after the payment of all its obligations shall be distributed to another organization or organizations then tax exempt as a charitable organization under Section 501(c)(3) of the United States Internal Revenue Code of 1954.

#### BYLAWS

Emergency Services Fund- Mary Ann Yglesias (Bellevue Multi Service Center) See 3rd quarterly report in these minutes. Also starting an evening food bank for people employed during the day and students who can't come in at regular hours- once a month on 2nd Wednesday from 6-7pm Waiting until after the holidays to publicize this because of holiday workload.

Church Council of Greater Seattle Urban Task Force- Bindi Shah Is working with the homeless and encourages churches to become informed about what can be done and what causes homelessness. Point was made that there is an Eastside Coalition for Homelessness on the Eastside which is also trying to help churches and be a conduit for ideas and resources. #### PUBLIC RELATIONS COMMITTEE

#### MEETING OF OCTOBER 26, 1987

The PR Committee met to discuss development of a Speakers' Bureau and direction of PR Committee. It was suggested that the Coalition try to find a community person who is knowledgeable in PR field to help with PR for Coalition beginning in January, 1988. We would like to discuss the possibility of the PR staff of one of the member agencies assisting with this task. However, it is recognized that agency staffs are usually already overburdened.

The committee discussed possible structure and organization of a Speaker's Bureau. We suggest developing a corps of speaking teams, perhaps one agency representative paired with one community/church representative. We believe we could develop 10 to 12 teams; each team to speak once a month. Church congregations, service organizations, government hearings and meetings and social organizations would be the initial target of the Speakers' Bureau. We would also target media possibilities, such as talk shows.

Discussion included the idea that the slide show prepared by Florence of FPA might be a valuable addition to our presentations. Upon approval of the coalition, Florence would be approached to explore cost and time involved in altering the slide presentation to include more Eastside representation.

Another suggestion was that a flip chart could be prepared to help present statistical information in a more interesting way.

Finally, we discussed the purpose of our presentations, and the group identified two areas on which we could focus: we can present information in order to educate eastside residents to the issues and to the magnitude of the problem; and we can ask for specific help through the development of a brochure or flier (or something along those lines) which gives specific dollar amounts needed to support specific needs. For example: \$500 would support one infant child-care slot for one month. \$400 would pay the rent for a family apartment for one month. \$300 would provide uniforms, or appropriate job interview or work clothing for 3 to 6 currently unemployed individuals. \$200 would provide before and after school day care for X children. \$100 would provide diapers and a layette for an infant in emergency shelter.

To Pastor(s) and/or Social Concerns Chairperson of Eastside Congregations:

Like most Eastside congregations, you may have little knowledge of what neighboring congregations contribute to meet human needs. Each of you, however, can and does provide considerable assistance.

A purpose of the Eastside Interfaith Social Concerns Council is "to provide a means of communication between Eastside congregations and the community in the field of social concerns..." This questionnaire provides an opportunity for congregations to see collective efforts. This questionnaire's results might point to areas that need cooperative effort in the future.

Meeting called to order by Chair, Dick Jacke Opening Prayer- Nadine Shannon Minutes approved as mailed Treasurer- \$822.62 on hand

REPORTS

HOMELESSNESS Nadine and Beth were invited to the Bellvue City Council Human Services Commission for a half hour report. The Commission listened for a full hour to them. Nadine gave the history of the EISCC (One error listed Walfred as an original member. Walfred's presence began 9/18/78.) Nadine gave EISCC goals and objectives, described present membership along with description of activities and pointed to geographical boundaries (No. to Bothell, So. to Mercer Island, E. to North Bend). They asked the city if they had a plan for the homeless. What can we do together? Who can be a central clearing house?

New meeting time for Homeless Coalition: 2nd Monday, 11:30-1:00, St. Margaret's Episcopal Church

PUGET SOUND TASK FORCE ON HUMAN RIGHTS- Robbie Stern and Oscar Eason (Co-chairs) This task force was formed by concerned lay and clergy who had been made aware of hate groups' strategies for the Northwest by Leonard Zeskin, Research Director for the Center for Democratic Renewal (Atlanta, Ga.) A symposium, "Hands Off My Neighbor" led to the formation of the P.S. Task Force on Human Rights. Goals of the group are: 1) Provide education for positive racial attitudes; 2) Provide support for victims of hate group activity; 3) Document hate group activity; 4) Provide legislation to counter/nullify hate group activity. To increase a regional outlook, the NORTHWEST COALITION AGAINST MALICIOUS HARASSMENT was formed to act as umbrella for such groups as the PSTFOHR. This coalition put on a conference in Coeur d'Alene, October 87, and is looking for more civil-rights-minded groups to join it (150 have already).

Some response: Carla had done some looking around early last spring. She obtained several copies of Leonard Zeskin's study and distributed them to several clergy because she felt that there was a lot of need for Christians to more fully understand their theologies and thereby NOT become victims to the heresy proposed by the hate groups. Study is needed.

#### BUSINESS

THANKSGIVING EXPERIENCE- SEE ATTACHED FORM. ELDER GIFT BOXES-SEE ATTACHED FORM. PLANNING AND GOAL-SETTING. Dick Jacke.

How many people went to their congregations about this? (No one did.) Dick reflected that a large number of people need to feel like they are active participants. BUT there is no clearly

defined, formal procedure to I.D. the issues in which we will be involved. (How CAN we I.D. these issues?) What can we do as a council to help our congregations become more involved in the areas we think are important? (Is there value in our agreeing on or consenting to the importance of certain issues? Doesn't this give us more support for each other also? NEEDED: Input from our congregations also (two-way street).

Suggestions: Bonnie feels the Executive Board should be formed along geographical lines. Carla: If people are going to become involved more then time will have to be taken at the meetings of a whole to provide them will support, etc. Lois: If we would hurry up and prioritize, First Pres. might consider issues in their long range planning. Incorporation by congregations is needed for success. Robert: Why am I here? I'm really trying to see how I can fit in the program. Buzz: It is nice to take out and put in according to a particular congregation's needs. Sally: Maybe we need a task force to deal with this problem and present findings, etc. to the whole group. Lois: Would it be helpful to have a task force on two tiers—community and geography?

#### ANNOUNCEMENTS

EMERGENCY FEEDING TASK FORCE looking for input; still need representatives from Kirkland, Bothell, Mercer Island. (Check with Hope Chapin, new parttime coordinator for the Eastside.

EASTSIDE SOBRIETY HOUSE is being brought forward by St. Andrews Lutheran Church and Cross of Christ Lutheran Church. (House is a place for men to live after they have received treatment.)

#### SPECIAL MENTION

Hats off to Cross of Christ Lutheran and St. Louise. The Thanksgiving Eve Service was wonderful! The combined choirs were an incredible ministry (include bell choir- all at once!) Carla.

For your information (and because we have room left) we include EISCC goals from December, 1985.

- 1. Increase membership (this is not an end in itself, but a means to other goals)
- 2. Help to make church resources available, without encouraging abuse
- 3. Increase visibility and awareness (of group & issues)
- 4. Participate in broad goals for communities (e.g., 20/20 Bellevue)
- 5. Work closely with other emerging groups (such as KIN)
- 6. Impact new policies on human services which are currently being defined by some municipalities
- 7. Learn more about what is being done now to deal with issues, what resources are available, what the gaps are, etc.
- 8. Develop a packet for new representatives to EISCC (which would include constitution, bylaws, pamphlet, other useful/necessary documents)

#### THANKSGIVING EXPERIENCE REVIEW

About 30 people who were invited showed up at the event. (There was an equal number of volunteers.) Invitations were issued that covered 223 people.

\*Worked with 12 more invitations between Visiting Nurses Service and staff of Evergreen Care Network.

The invitations mentioned above were issued <u>after</u> the individual indicated that he or she would like to receive an invitation. There was no control over the initial extending of the invitation. For example, several people asked by churches felt demeaned.. "But this event is for poor people!"

In written. publicity or flier was the message: This dinner is for people who have tight resources and/or have no place to go.

Invitations were issued 2-3 weeks before the event.

Events planned by other agencies:

Cross Roads Community Center had 90 people the Tues, before Thanksgiving

Salvation Army in Seattle had 755 people up from 625 last year; but, expected 1,000

Definite currents against this event:

- 1) Most of the people receiving invitations were families who received a turkey in their weekly food boxes. (Turkeys hit an all time low of 39¢/lb.)
- 2. Agencies serving elders reported again and again that members of elder's family showed up on Thanksgiving Day to take the elder somewhere.
- 3. Only 5 out of 33 churches/congregations informed sent back suggestions for invitations. And among these there were different interpretations.
- 4. Could not get the JA to envision publicity for this event BEFORE the event.
- 5. Although Senior Centers were given flyers to announce the event, none called to request invitations. (Should have gone back to them 2 and 3 times.)

About the volunteers: Committee members were turning volunteers away up to the event. Hindsight renders a fact that the volunteers needed company and a more meaningful way to celebrate Thanksgiving.

Funds and Contributions: \$1025 was collected from 11 congregations and 8 individuals. In-kind contributions totaled 50% of needs in expenditures. (The pie contributions were totally incredible...double the number!) EISCC is specially thankful to Brenner Bros. Bakery for all rolls donated. Surplus in funds:\$375. All churches not checked at this date, but plans are to keep money separate for another event.

RECOMMENDATION: That EISCC have another dinner at a less "active" time of the year... say Valentine's Day.

#### RECOMMENDATION OF SHELTER COMMITTEE

We believe that Eastside congregations have a role to play as the conscience of the community. Our own heritages teach us that the religious communities have always reached out to help those in need. We see that those in need on the Eastside now, and even more in the future, will lack mainly for shelter.

We want to work together with those involved in trying to close the gap between current and future needs and existing resources for meeting those needs. To this end, we make the following recommendations:

1. We should provide more shelter facilities for the

homeless on the Eastside.

- We recommend that such shelters be facility-based, rather than voucher-based. We believe that facility-based shelters provide the best opportunity for referral and support for shelter users, many of whom are by definition in crisis.

 We recommend that increased funding be made available for shelter development from local government.

- We recommend that local congregations and other interested groups work in coalition to sponsor emergency shelter facilities.
- 2. We encourage Eastside congregations to work in cooperation with other groups to form an ongoing coalition to promote the development of increased shelter resources on the Eastside.
- 3. Since the lack of affordable housing is a major contributor to homelessness on the Eastside, we urge the commitment of greater public resources at the local, state and federal levels for low-cost housing development.
- 4. Since a lack of adequate household income is a contributor to homelessness, we urge Eastside congregations to work together as advocates at the state level for adequate funding for programs that assist the poor. This should include funding for the State Housing Trust Fund and funding at 100% of the poverty level for the AFDC program.

\*are developing an Eastside Coalition for the Homeless, who hase just completed arreport for you this evening.

#### Further needs:

\*Central clearing house for all information

rationale: there is no co-ordinated area of facts that would include information from each of the following -St. Vincent de Paul -Salvation Army -Multi-Service Center of NE King County -Overlake Presbyterian Church as an example.

\*No food disbursed on weekends in Bellevue (Kirkland food bank has calls forward service for weekends). Thanks to Congregations, Catholic Community Services and the Bellevue Parks Department, hot meals are now served Mon. through Fri. at Crossroads Community Center.

\*offer incentives such as providing child care and health insurance to working mothers/fathers---more cost effective than welfare.

\*Provide common sense budgeting assistance.

\*Police awareness of referral services for the needy.

Vision of the future, in creating a caring community, must include prevention of further erosion of people becoming homeless as well as helping many who are now homeless.

Thank you for your demonstrated concern. We trust you will continue to include us to work together on these problems as we all share in creating caring communities.

# BYLAWS (Cont'd)

- Issue is raised by local congregation, social agency or EISCC subcommittee at a regularly scheduled meeting. Alternative courses of action are considered. Where anticipated, a description of the issue to be discussed should be included in a meeting notice.
- A proposed study statement is drafted and submitted to local congregations for discussion and action prior to the next meeting. (This statement is not for public release.)
- 3. Local congregations individually act upon the proposed study statement.
- 4. At the next EISCC meeting, the proposed statement is discussed, language tightened, amended and voted upon by EISCC representatives. A quorum being present, two-thirds (2/3) of the representatives assenting shall constitute approval.
- 5. Public release of the Final Statement should include the following:
  - a) A "Disclaimer" stating that the statement represents the thinking of the EISCC board of local congregational representatives and does not imply official endorsement of the specific congregations or denominational bodies.
  - b) A tally of the final vote indicating "for", "against" and "abstain".
- 6. When any issue requires urgent response by the EISCC, a proposal may be presented to the council at a regular meeting. The proposal will be discussed, language tightened, amended as appropriate, and voted upon by the EISCC representatives. A unanimous assent of those present and voting shall be required for approval. Any release shall carry a notice that due to time constraints, the congregations have not yet voted upon this issue.
- 7. When any issue requires urgent response by the EISCC, but the draft proposal fails to receive unanimous consent of those present and voting, the officers may meet to draft a proposal which shall be sent to members with a notice of meeting, the date of said meeting to be no less than ten days from the date of posting. The proposal shall be discussed and acted upon as described in Bylaw #4. Any release shall carry a notice that due to time constraints the congregations have not yet voted upon this issue.
- 8. These Bylaws may be amended by a two thirds (2/3) vote of the representatives present and voting from the member congregations, provided that a 30 day prior written notice of the proposed amendment has been given.

#### ARTICLE II - ASSOCIATE MEMBERSHIPS

- 1. Associate memberships may be extended to constituent groups in the areas of social and health services whose philosophies are consistent with the purposes of EISCC.
- 2. Associate members shall have voice but not vote.
- Associate members shall pay a fee of \$10.00 annually, upon application and thereafter prior to the October annual meeting, to cover administrative costs.
- 4. Associate members shall receive the monthly mailings of the EISCC.
