#### REPORTS

Homelessness, Beth Boyd. Beth will add to a legislative telephone tree any one who stars his/her name on attendance form. The tree will specifically deal with raising the minimum wage in Washington State.

#### PROGRAMS

Eastside Community Clinic, Carol Iverson. The Clinic is now open and is situated behind Dick's Pharmacy near intersection of Northrup and 156th N.E.. Quality care is given on a sliding income scale. (If need is proven, care is free.) Money for clinic comes from: United Way, City of Bellevue, King County Phone no. 562-1208 (APPOINTMENTS ONLY). Hours to date: Mon., Tues., Wed., Fri. - 9-5; Thurs. - 11:30-8:00. Working to get hours on Saturday. Average Cost of a visit: 4-10 dollars..

Habitat for Humanity, David Seeley. Habitat for Humanity is an ecumenical Christian housing ministry whose objective is to eliminate poverty housing from the world and to make decent shelter a matter of conscience. By having affluent and poor work together in equal partnership, Habitat hopes to build new relationships and a sense of community as well as new houses.

Funding comes from individuals, churches, corporations, foundations, and other organizations which are moved by concern and compassion to help those in need. Mortgage payments (with no interest, usually 20 years) are put into a local fund and recycled to build new houses. No government funds are used.

Seattle Chapter of HfH began two years ago and was kicked off by Rosalyn Carter. By the end of last year, two houses have been purchased. Families have already been selected. There is a chapter forming in Snoqualmie Valley. This will be slow business here in the states. A house costs as much as 10 times what a house in poorer countries of the world costs.

#### PROGRAM

KAPPAG (Ecumenical Center for Development) an ecumenical consortium to help the very poor in Manila, Philippines, the squatters communities- Kathleen Kelley. These communities are made of people who are outside of any system of empowerment which might improve their lot. The barest community that the people do set up is from time to time relocated by the government away from the city limits and any jobs that might be had. The present KAPPAG presence in Manila consists of a doctor, nurse and about 30 other volunteers. There is some international support. Seattle "Friends of KAPPAG" is just getting started. A representative from the Philippines, Banny Saturee will be in Seattle until July. She has a slide presentation. Anyone is free to travel to the Philippines to see KAPPAG's work. For further information: Kathleen Kelley or Philip Koritz, 5456 35th Ave. S.W., Seattle, Washington 98126.

NORTHWEST AIDS FOUNDATION- Richard Kubiak and Reverend Gwen Beighle. In the beginning of 1986, there were 154 reported cases of AIDS (Acquired Immune Deficiency Syndrome). In the beginning of 1988 there were 527 known cases. (Please note: People with AIDS who live in more conservative communities relocate themselves in metropolitan areas.) NW AIDS Foundation began about three years ago. Today, it has 21 staff and many volunteers. The Foundation (322-0304) open M-F, 9-5, provides financial assistance to people with AIDS, health education and fundraising for support services for people with AIDS/ARC. Help is provided with government programming assistance also. NW AIDS Foundation works very closely with SHANTI (322-0279) which provides emotional support and friendship for individuals and loved ones facing AIDS; and Chicken Soup Brigade (328-8979) which serves AIDS patients by providing transportation, chore services, meals/food preparation. The biggest task has been the development of short-long term housing and care Alternative to the Hospital. The Adult Family Care Home being developed with funds from SSI, Seattle-King County Health Departments, DSHS and the NW Aids Foundation is the first of its kind in the U.S. (Emergency Housing and funds for such can be obtained from the Foundation.) There will be a caregiver in the house at all times.

CONGREGATIONS HELP? Sally Wing of Grace Lutheran reported that the church is providing one night a week for an AIDS support group here in Bellevue. Churches can support, financially, the N.W. Foundation. SHANTI and Chicken Soup Brigade need volunteers. Spread the good news that AIDS is preventable. Show compassion.

What can EISCC do? Should there be an educational event on the Eastside? (Sally Wing reported that YES does a commendable job with education about AIDS for teens!) MSP that an AIDS TAsk Force be formed. Shirley Croonquist, Hope Chapin, Harry Applewhite, Dennis Hughes, Iris Jewett, Mary Ann Yglesias, Betty Smith, Fitz Fitzgerald, Yuonne Wyngaard (via Pat Meehan) signed up.

HOMELESSNESS-Beth Boyd. As of Mar. 1, the Crisis Clinic (641-1300) will have information available about needs. Beth urged phone, calls to the Legislature re: HB 1544-minimum wage bill; HB 1779/SB 6591 supporting diversion of unclaimed lottery money to the Housing Trust Fund. Beth urged attendance at the Antipoverty Day in Oly. on Feb. 16.

INTERFAITH DIALOGUE- Walfred Erickson. Committee on Jan. 29. Committee is considering struggling against anti-Jewish innuendo in congregations with education and perhaps a conference on harassment. The advancement of dialogue, real dialogue, without the Christian "mission" was also discussed. Next meeting, March 17, Noon, St. Margaret's. Rabbi Mirel will be invited. Members are invited. 
The Bellevue Center's, "A Night in New York", at \$25 a ticket will profit Eastside Mental Health. Call and buy a ticket (455-4357).

#### REPORTS

Treasurer's Report

Homelessness Coalition- Beth Boyd. Beth reported on the minimum wage legislation for in state. People need to call their legislators. Betty Smith reported that Senator Dan Mc Donald doesn't hear from folks on the Eastside about such issues. Carla sees churches participating in food donating, but not legislation. Which is more just? Giving a food box worth \$40, or allowing someone \$40 to spend themselves? Interfaith Dialogue- Walfred. Meeting March 17 at St. Margaret's. All are welcome. AIDS Task Force- Dick will call the group which already volunteered and appoint a chair.

#### PROGRAM

Asian Resettlement Center- Walfred. Walfred expressed appreciation for this opportunity to update us on the center. It has slowly become more strong in the last three years. It now has a good board. Income from chruches was down last year, but this was because funds were not heavily solicited. Will be looking for more church support in the future to give the program more flexibility. Walfred introduced Betty Smith, acting Director of the Center. Betty's report follows:

Monies from King County and Bellevue and Rédmond are the "program monies". This money must go to programs called for in contracts. Need money from the churches for the little extra things that come along. Current efforts deal with adjustments more than resettlement. Some people still need help after five years. Others spin off in no time at all. Counselors (really bilingual interpretors) are needed for referral in job training, job availability (there is a job book at the center), medical/dental needs. Housing is a huge problem on the Eastside. Betty introduced Muoi Luoy who is a bilingual counselor at the Center. She gave an example of a typical day. Currently, she is seeing more Vietnamese who have come directly from Vietnam and are not eligible for public assistance. Dick asked how much additional help's needed:ARC would like to offer more language programming, need more baby and children clothing, baby cribs, family furniture, blankets and bedding (bottom sheets-they don't use top sheets). Don't just bring furniture and leave it. There is no room. Arrangements can be made. Harry Applewhite expressed gratitude for the work of Walfred and the ARC.

B. St. Margaret Episcopal's programs- Nadine. "How things are done." There are 356 on the mailing list at St. Margaret's. Have been without a minister since Jan. '87. Look for a new one after Easter. Church components are: Administration, vestry, finance committee, opportunities to volunteers. The latter has categories: Fellowship and support, spiritual growth and renewal, personnel, newsletter, stewardship, properties (inside and outside), memorials, long-range planning, worship, outreach (social action). The latter centers on the following activities: 1) The St. Margaret's Thrift Shop. Has 45 volunteers. Good place to get clothing. (Monies have gone in the past to the Bellevue Emergency Services Fund and the Elder Gift boxes-programs of EISCC.) 2) Northern Ireland Project involved 16 children from N. Ireland, both Catholic and Protestant, who stayed with families on the Eastside for a month. Four Catholic, 4 Episcopal and 1 Presbyterian Church finally became involved. 3) Crossroads supper-"The Lord's Supper II" named after primary effort in 1979) - take the dinner one night per month. 4) Sing-a-long to rest homes which includes the families with a potluck afterwards. 5) Over-eaters group which includes Bible study.

#### REPORTS

Treasurer-Buzz Kahn. Balance to date: \$775.16; two more memberships. Buzz planning to have report of dues paid for this present year at next meeting.

Homelessness Coalition Nadine and Beth. Nadine reported that an <u>Issaquah trailer park</u> was closing. The residents of said park received a letter from the owner. Some residents have lived there for 20 years. A lot of these people are low income people who must move by Feb. 1, 1989. There is one other court in Issaquah. The coalition is considering some kind of advocacy to 1) find funds (maybe from developer) to help people move; 2) affect the new rent they would have to pay via some kind of variance by the City Council of Issaquah. If people are interested to take back concern to congregation, contact Nadine for most recent info.

Beth reported on the new minimum wage (Washington State) <u>Initiative 518.</u> 200,000 signatures are needed by July 1 for the initiative to appear before Washington State voters on the November ballot. Minimumwage would be changed from \$2.30/hour to \$3.85

beginning Jan. '89, and to \$4.25 beginning Jan.'90. (These adjustments concur with the federal minimum wage increments being considered in Congress.) Discussion followed. Dick was asked to get some kind of minimum wage presentation at our next meeting. Also group wanted to know exact IRS rulings\*re: initiative in and around the congregation, etc. This will also be presented in the future. (\*for tax exempt/non profit groups) Nadine expressed need for congregations to send representatives to coalition meetings. Meetings are the second Monday of each month, 11:30-1:00, at St. Margaret's. Congregations are in the minority right now.

Nadine also reported that Cross of Christ Lutheran and St. Andrews Lutheran are working towards providing some housing for recovering alcoholics. Church of the Resurrection (Episcopal) is looking into the possibility of low-income housing on their property.

Interfaith Dialogue- Walfred. Committee has met three times, since year began. Considering some kind of Christian-initiated event on the Holocaust (Apr. 13). Could this be planned for a year from now? Announcement: Muslims in Bellevue are putting on a symposium at the Ashwood School, May 22, 2:00 pm. All interested are invited. Subject matter: "Our Views of God". (Christian, Jewish, Muslim)

Re: MOrmons. Current Mormon who is interested in dialogue and cooperation with other faiths is Daryl Anderson who has recently moved here as an official public relations representative of his faith. His mission is to improve relations with other church bodies. An open meeting will be May 7, 9:00am at St. John's Episcopal Church. Walfred has a statement, mostly written by Daryl entitled The Things That We Agree On" which came out of earlier meetings. Statement with note from Walfred is enclosed. Carla reported that Temple Beth Am's social concerns committee will work with the Init. 518. Folks will also try to inform us of important Jewish agenda items. Example: April 13 is the Governor's Holocaust Memorial, 7:00-9:00, Temple B'nai Torah, M.I. Next meeting of committee, 28 April, St. Margaret's , NOON.

AIDS Task Force- Dick Jacke. No chair as of yet. There are willing members, however. Dick looking for a chairperson.

Emergency Service Fund- Mary Ann Yglesias. 48 households were helped this past quarter with finances from the BESF. FEMA dollars (Fed. Emergency Management Agency) for emergency shelter were used this past quarter as well as the Energy Assistance Program (which will be closing down as warm weather approaches). Another helpful source of funds for people help has been the JA Home Fund. Carla suggested that we set aside a Sunday for emphasizing the Bellevue Emergency Service Fund. This has been done in Kirkland with the mayor, etc.

#### PROGRAM

Overlake Service League-Rocelia Kellogg, President. OSL has been in existence since 1911. Today income reaches \$86,000per year or more. The OSL Thrift Shop in the Bellevue Square is the main source of income. There is no solicitation of funds, but donations are very welcome. The Board meeting of the League is set for the 4th Thursday of every month. All are welcome. Special mention about the in-kind help the OSL gets: Rent is \$1 per month with \$750 in maintenance fees. The shop is staffed by 500 volunteers! The Square merchants give merchandise for the shop; and recent "New York Night" fund raiser netted \$9,200.

Some of the projects funded by OSL are: Day care, have worked to computerize OSL inner workings, have given \$18,000 in scholarships for high school seniors, vouchers in the amount of \$14,000 at J.C. Penney's, over 400 Christmas and Thanksgiving "helps". The Thrift shop is open 7 days a week. Clothing donations are welcome; so are shoes, and silk flowers, etc. Week day hours are 10-9; weekend hours are 10-6.

Pat Meehan offered to report in a future meeting. Time was running out!

#### BUSINESS

Human Service Commission of Bellevue-Walfred.

Below is a Statement of Policy re: EISCC relationships to the Human Service Commission. Walfred feels that the community in EISCC needs to be much more active in the pursuit of funding for human services. We are to consider this statement and bring our ideas to the May meeting.

#### Statement of Policy

- 1. The Eastside Interfaith Social Concerns Council goes on record that in fulfillment of their religious missions congregations should inform themselves about the human needs of the communities in which they are located and involve themselves in meeting those needs.
- 2. The Council recommends that congregations study the role of their municipalities in meeting those needs and find appropriate ways of influencing budgeting procedures and the allocations for human services.

#### Motions

With regard to Bellevue, the Council asks the chairman or his appointees to consult with the Human Services Commission and other informed persons and bring to the May meeting of the Council a recommendation as to what allocation for human services should be in the 1989 Bellevue budget; also other actions for the congregations to take may be helpful.

The Council will have as an agenda item at its May meeting the adoption of a specific dollar goal for the Human Services allocation in the Bellevue 1989 budget.

The Council at the May meeting will also consider appropriate steps for enlisting congregations to use their influence in support of this goal. This may include official congegational statements, or circulation of petitions among the members. It may include letters to city officials from the congregation and or from individual members. These actions to be accomplished by Sept. 30, 1988.

The Council will also at its May meeting consider a resolution that congregations in Redmond, Kirkland, and unicorporated King County should take steps to effect similar actions in the jurisdictions of their location.

Budget Recommendations from the Bellevue Human Services Commission were discussed. There seemed to be various understandings in the group. Dick reported after the meeting:

The current recommendations of the Human Services Commission are for 18 month grants. This is solely for the purpose of changing the grant cycle from its present July to June period to a calendar year—Jan. to Dec.— basis. In order to accomplish this changeover, the Commission has received a commitment from the Bellevue Council for a level of funding next year at least the equivalent to the present year's funding. This does not preclude the Commission from suggesting at a later time for funding for next year at a higher level.

<u>Begging Ordinance</u>- Dick. Interesting reaction to what? There are already harrassment laws on the books. Is this a general intimidation ordinance? Councilpeople Bozeman and Carpenter wonder about the need for this.

RE: Low/Income/Moderate Housing in Bellevue

The City of Bellevue plans to sell the "West Slope" of Wilburton Hills which it owns in order to pay for another land purchase in the Wilburton Hills area. The 11.4 acres is one of the few available sites in Bellevue which could be used at least in part for low/moderate housing and/or senior citizen housing. On May 25, in the evening, the Planning Commission will hold a hearing at City Hall on a new policy statement for the Wilburton Hills area. The current thinking of the Planning Staff does not envision using government money for the housing but rather a series or incentives.

I believe it is very important for the religious community to be present at this hearing and to strongly communicate to the commission that we favor a policy which allows the "West Slope" parcel to be zoned so that low/middle income and/or senior citizen housing can be built on it. In the past "community clubs," and developers wanting to build office buildings and those who oppose persons of lower income living in Bellevue, have spoken out strongly at such hearings and have presented other projects for low income and/or senior citizen housing.

#### Proposed Policy Statement:

The land east of 118th Avenue SE and commonly referred to as the "West Slope" is appropriate for multifamily medium density uses in accordance with the Land Use Diagram. Incentives such as density bonuses are appropriate to encourage construction of dwelling units for low and moderate income families/seniors. Development is subject to design review to insure that significant views westward from the park are preserved and that any development is similar in design, height and bulk to structures along the western portion of 118th Avenue SE.

#### REPORTS

Treasurer- Buzz Kahn. There is \$725.68 in the treasury. Is the list of paid members complete?

Homelessness Coalition— Beth Boyd. The coalition has been meeting for a year. The Bellevue City Council wants to consider multi-family housing for low income families or seniors on city property— west slope, Wilburton Hill. Beth urged people to be presented to tell planning commission that we see the need. Also, a different location is good so that low income housing will be spread across the city. May 25, City Hall, 7 pm, next meeting.

Following statement was approved unanimously (Drafted by Sally Wing.): In accordance with our continuing concern for low income persons, the members of the Eastside Interfaith Social Concerns Council support a policy which allows the "west slope" parcel of Wilburton Hill to be zoned so that low/middle income and/or senior citizen housing can be built on it.

Interfaith Dialogue- Walfred. Still considering reviving the National Council of Christians and Jews. Meeting last Sat. morning included the Mormons. Meeting is planned with Loren Arnett and Daryl Anderson next Friday morning. A Muslim seminar is set for May 28 at the U of W.

AIDS Task Force- Co-chairs, Yvonne Wyngaard and Iris Jewett. Confirmation of appointments by membership of EISCC. Yvonne suggested sending a questionnaire out to Eastside parishes to find out how to best serve.

Goals, Policies Task Force- Dick Jacke. Really not trying to set goals per se, but how do we make sure that the concerns here at our table get a proper airing at the congregational level?

Aggressive Begging Ordinance-Dick Jacke. Was told that this recently passed ordinance is probably in trouble. It is too broad in scope (giving lots of room for rights abuse) and does not describe what harassment is effectively.

Dick and Beth pointed to a weakness in our system to keep up with Bellevue Council's actions. The Aggressive Begging Ordinance passage was a very big surprise. We need to work on this the next meeting.

#### PROGRAM

Minimum Wage- Pat Alvarez, Steven Bauck. We will still get a speaker against the Minimum wage issue next meeting. All that follows is given in favor of the issue.

The current state minimum wage of \$2.30 per hour was set in 1976. To keep the wage even with inflation, \$4.35 would be the minimum wage today. Initiative 518 would move the wage to \$3.83 per hour in January 1989, and to \$4.25 in January 1990. 60% of the working poor would be affected by this initiative if is became law. There is no significant evidence that raising the minimum wage would affect nos. of jobs. The main job NOW is to get signatures. This is actually pretty easy because some many people are surprised that the minimum wage is so low. Churches can set up tables outside the building of worship. Notices put in church bulletins can announce the initiative's presence. A great big 'thank you' to Beth Boyd for getting initiative before people at Bellevue Square. Coming Sunday need workers 11:20-2:30 and 2:30-6:00 shift. 50,000 signatures have been obtained so far. Must work to get signatures!

Nadine Shannon went of the record for small farmers. We should be helping the farmers as well as the workers. We are importing so many fruits and vegetables. What about our 'bread basket' here at home? Walfred wanted to know abut take home work. Hmongs in Carnation are sewing and another family in Eastern Washington makes fishing tackle at home.

Directions on reading the back of initiatives: If wording crossed out it is legislation not included in suggested legislation by initiative. If wording is underlined, it is added to already existing legislation by initiative.

Sacred Heart Catholic Church- Pat Meehan. There are registered families. Fastor is Fr. Marlen Connole. Assistant Pastor is Fr. Hans Olson. The Pastoral Council includes the Pastor, School principal, Altar Society President, Business Administrator, 6 elected members for three years terms, one youth, two members appointed at large. There are 28 commissions and many of them deal in some way with charity concerns and justice concerns. Just to name a few and what they do: The Altar Society for volunteer women deals with emergencies such as child care, shopping for meals, assisting the elderly,. etc. The Gleaning Commission gleans 7 days a week for the Bellevue Food Bank, Crossroads, First Ave. Service Center, Talbot House, Francis House, Georgetown Service Center, Millionaire Club. There are funds raised for at least 25 emergency and self help ministries.

#### REPORTS

Treasurer's Report. \$727.68 is Balance. Still has no record of payment for Emergency Feeding Program, First Prebyterian, KIN, Bellevue Christian Church. If you have paid, please inform. If not, please pay now. Thanks. Pay cycle is September to September. Associate members pay \$10.00 or half of full membership. This money goes toward costs of mailings.

Coalition on Homelessness-Beth Boyd. The Livable Wage Campaign reached over 130,000 signatures. Remember that 200,000 are needed. If anyone wants to help gather signatures, call the office, 622-3442. Please everyone make a point to visit the next Coalition meeting, July 11, St. Margaret's. Ms. Solomon of Common Ground (Assistance for Non-Profit Housing Development) will be addressing how congregations can become involved in providing housing.

Eastside Mental Health planning to build an apartment house here on the Eastside for semi-dependent living people. They already operate three houses and an apartment house in Bothell. The latter helps people build up independent living skills.

M/S/P: We write a letter in support of EMH to secure housing for the mentally ill. The Eastside Family Haven was the group that obtained the first semi-independent living house for mentally ill.

Decided that each letter, statement arising from representatives in attendance any given EISCC meeting should carry the following: "Note: Due to time constraints official endorsement by congregations or denominational bodies has not occurred."

Walfred expressed concern about all these issues getting before the congregations.

Interfaith Dialogue: Meeting with the Islamic group cannot be considered any kind of big overture re: interfaith activity. This was one particular sect (Ahmadizya). It is very encouraging that different faiths were asked to participate. They need a place to meet. Can anyone help? Mormon-Christian dialogue efforts will be presented to the Bishops and Executives of the member denominations of WAC in the Fall.

AIDS Task Force- Yvonne Wyngaard. Had first meeting at Sacred Heart Parish. Fourteen attended. Good brainstorming of what our program might look like. Iris Jewet has to resign. Thinking of

sending a questionnaire to congregations to see what they might need in the way of helping educate and inform about AIDS and AIDS patients. Meeting third Monday of every month.

Wilburton Hill- Walfred for Dick. Statement in May meeting minutes given at Land Use Hearing by Dick Jacke. City Staff is very positive about working something out.

Human Services Commission has called for a child care hearing June 27, 6:30pm, Conference Room in City Hall. Want information about the need.

#### PROGRAM

Minimum Wage, Con Position- Cliff Finch. Business Lobbyist and attorney. 80% of the Washington Businesses have 50 employees or less. The problem with raising the minimum wage will not be felt in present times. Increasing the minimum wage will hurt the working poor. The job market will contract if the minimum wage is raised. There are unskilled workers, entry level workers who need to prove ability. There are poor people who need part time work. These people, Finch feels, will bear the brunt of this. The majority of these people are single and working part time. The minimum wage won't "hurt" these people.

Overlake Park Presbyterian Church- Betty Smith. OPPC has an Emergency Feeding Program Distribution Center in Cross Roads Area. Give out food 9-5 and information about other human services that people need. Through the Board of Deacons, OPPC works with Salvation Army, Overlake Service League (especially during Holidays) and the Bellevue Multi Service Center. Deacons support the Kairos Ministry (Monroe) and have been active in the workings of the Asian Resettlement Center.

BUSINESS

Bellevue Human Services Funding- Walfred Erickson. Nothing to report. There is no recommendation into 1989 yet.

Issaquah Trailer Court-Nadine Shannon. Statement included below. This is a study case in how people become homeless. If trailers are still there in Feb. 89 trailers will be moved to the streets. M/S/P to add EISCC to the statement. (An amendment passed to delete "Encourage municipalities on Eastside and King county to become advocates for early and sensible intervention.")

Eastside Coalition for the Homeless and Eastside Interfaith Social Concerns Council are concerned about the impact toward homelessness of 43 families being displaced from the Issaquah Trailer Court. Hence we have identified the following actions that are required:

Funds to assist in relocation Political support to encourage the City of Issaquah to intervene and provide a variance to Mr. Klaas so he can expand his trailer part to accept older trailers; and variance subject to Mr. Klaas providing trailer spaces at \$140-160 per month.

Election of Nominating Committee. Sally Wing, Nadine Shannon and Harry Applewhite elected.

AIDS Task Force- Pat for Yvonne. Rev. Dakshott (Archdio. Chaplain) discussed ways to help AIDS victims. If any of you have opinions about what might be done, please contact Yvonne. See "Interfaith Dialogue" for particulars.

Bellevue Emergency Services Fund- Mary Ann. Format is changed. Mary Ann only listed churches that have put money into the account recently. She is now including the BESF in her donations-possible listing. Highest demand for Puget Power. The Federal energy assistance has ended early this year. (Sacred Heart sent a check in MARCH of this year. Contribution amount given in Mary Ann's report stands.)

PROGRAM

Bellevue Human Services Commission- John Boespflug. completed second cycle of money allocations. Very common of people in Bellevue to not see our problems. EISCC really involved with people who are vulnerable. Good! Formed a year ago last Feb. to advise the City Council re: social/ human needs and to recommend allocations of \$750,000 in community block grants. Have tried to spread money. A few dollars here or a few dollars there is a difficult way to qo. Can't really tell what's going to happen. Might watch an agency falter and know that any more money allocated will not help. Policies are hard to make! Have entered an 18 mo. cycle to coordinate funding with the cities around us. So have an extra six months to work on policies. Also, members on the Commission are slowly visiting agencies to gain maximum familiarity. Would like to get to some areas in which needs are not being met; need to deal with child care and have to spend time planning for the future. There is a large question: Does the City of Bellevue spend enough on human need? There are two vacancies on commission. Cut off for applications received-Aug. 5. Meets twice a month, first and third Tuesdays, evenings. Remember: There is no way in which we get enough information.

Contact me, 455-3940. Questions: How do you meet people who have need? Commission has had three meetings out around the town. There was good attendance at Lake Hills and Cross Roads. Hall doesn't draw people. The Religious community has a network to get the word out. Re: Low income housing. Commission does deal with emergency. Council would likely deal with housing on city-owned property.

Bellevue Christian Church- Nancy Barr. Participates in Emergency Feeding Program, Friends of Youth, minority programming, Task Force on Aging (CCGS), Dress for Success, Yakima Indian Reservation medical/ education programming, Overlake Service League (Holiday Families), Special Olympics. Women of the church do the mending for residents at Bellevue Terrace.

#### BUSINESS

Policy of EISCC-Dick Jacke. What should our disclaimer say on a letter that receives the group's vote and not the vote of our congregations? See BYLAWS, #5. This is NOT emergency. The other issue involves the need to vote on something in which there is no time for congregational approval. Either way, we need a disclaimer. Only then it is very clear that we are voting as a group; and that our actions do not take the place of actions of congregations. (They should act on their own too.)

Minimum Wage Initiative-Beth Boyd. Should we take a position on the Minimum Wage Issue? The initiative will appear on the November ballot. The Livable Income Coalition needs money for advertising. Any business wishing to endorse the Minimum Wage should contact the Coalition. (See phone no. in last minutes.)

M/S/P: That Beth write a statement (with EISCC rationale) in favor of the minimum wage issue to accompany the July meeting minutes. (EISCC officers can help.)

Wilburton Hill- Dick, et al. A lot of fudging going on regarding "medium" to "low density" housing categories. It is now in City Council hands. Wilburton Hill folks are very opposed to any low income housing. Harry feels that the case was not made for the kind of housing being considered. The project might consist of a certain percentage of units designated for persons of lower income. Maybe the actual vision might be very acceptable to folks. We need to let Jean Carpenter know that her statements have suppport! M/S/P: We should continue to reaffirm our statement (as sent to the Planning Commission, see May minutes) to the Council before this coming Monday night (Study Session.) New Meeting Location. M/S/P- Thank you to St. Margaret's and Nadine for hosting EISCC. "We accept the gracious invitation of Grace Church graciously" (HA). PROGRAM

The Children's Initiative- Howard Fink, Robin Pasquerella. The State of Washington has a choice it seems if actions of the past decade are any indicator of things to come: Washington has doubled its number of prisons while the number of its children in risk from poverty, in risk from physical/mental abuse, in risk from decreased educational opportunity increase. The Washington State government has settled for cosmetic political "wins" while government tools become dull or stretched out from lack of funding and cooperation. Child advocates are trying to take matters to the desks (and attentions) of legislators. INITIATIVE an initiative to the Legislature. 151,000 valid signatures are needed by December 22. If the Init. is not acted upon in the Legislature, it will go onto the general ballot. If the Legislature proposes an alternative, both will be on the ballot. If the Legislature approves all, it becomes law. Official Ballot Title is: Shall the state support of children and family services and K-12 education programs be increased by \$360,000,000 in new taxes? More information (as handed out) in secretary's book.

Community School Success Program- Susan Jouflas. Designed to reach "at-risk" youth in the educational system. Uses adult

volunteers to support youth in making positive changes in their lives. Volunteers receive good training. Monthly in-service meetings provide supplemental training. Program has been laid down in all Bellevue School District high schools. Contact Susan, 340-2037 for more information.

#### BUSINESS

Minimum Wage- Beth Boyd. Statement approved as included in these minutes. It was M/S/P that this statement be released to the press.

Mechanism for Legislative Monitoring and Response- Dick Jacke. Need to get around to this.

Treasurer's Report. Balance is \$769.84. To date have received 10 full memberships and 5 associate memberships. Please check this out. Need to pay dues so that you can vote in October.

Coalition for the Homeless- Beth Boyd. Next meeting on October 17th. Want the group to endorse a national housing effort involving the need to reverse the past 8 years of federal pullout from low cost housing efforts. A Seattle rally is set for 12 October. National movement involves getting cities across the country involved. State will be issuing report on its homelessness. The event planners center on four principles: 1. That housing is a basic human right. 2. That the lack of housing and existence of homeless is a moral issue. 3. That the responsibility for housing rests with all levels of governments. 4. That the city of Seattle enforce all housing ordinances on the books that protect people from becoming homeless. Request that EISCC co-sponsor this effort and bring some of the ideas/ programming to the Eastside. Point made: We need to tell our folks about homelessness on the Eastside. M/S/P: That cosponsor the October 12 rally. Beth, Mary Ann, Betty Smith, Goeff, will meet weekly for a month to organize Eastside response.

AIDS Task Force- Yvonne Wyngaard. AIDS Task Force is energizing and enriching experience. We have set our deadline to accomplish our purposes by June 14, 1989. Our purpose is to help clergy and lay leaders re: AIDS; to emphasize the spiritual elements in the AIDS crisis; to encourage congregations to help AIDS victims. The goal: a seminar, shaped like the event at St. Mark's Cathedral under the sponsorship of the Church Council of Greater Seattle is being planned. A workshop is to be presented in May. The Health Information Network would do the planning. Task Force would need about \$200 at first. Church Council could do the accounting. Proposed \$15 for each attender. The St. Mark's event cost about \$4500 which included facility rental, speaker's fees, printing and mailing. (All of this was subcontracted to the Health Information Network. Yvonne suggested that EISCC send a letter in support of HIN so that HIN can get state funding.) Questions: Is it more important to concentrate on the Eastside? Do we want to open it up to the greater Seattle area. Can we generate this kind of funding? Suggestions: Could the clergy sign up to have congregations hear about AIDS through

a speaker? Does Overlake Hospital deal with AIDS? Feelings to date: the hospital is not very sensitive. Could the Task Force write a letter to find out what the local hospitals are doing? We appreciate the work of the task force. Any action was put off to the next meeting so that the task force could report further options re: funding (most congregations might not charge); present bibliography (speakers, etc.); appropriate dates for activities.

Interfaith Dialogue- Walfred Erickson. Mormons just offered to share their canning facilities with any congregation. Walfred visited their employment service in Renton-each congregation has an employment counselor and they have a powerful network. Walfred suggested the EISCC have some kind of "Holocaust Sunday". Will have to research this because there is a set Holocaust Monday. Buzz Kahn readying a bibliography. Carla felt the need for no motion because consensus has already been reached by the group in former minutes.

Nominating Committee. Slate follows: Chair, Goeff Ethelston; VC, Pat Meehan; Co-secs., Carol Hegg and Betty Smith; Treas., Dorothy Scott. M/S/P slate accepted.

#### **PROGRAM**

Marilyn Ham-Kay of Coalition for Citizens with disAbilities. City of Bellevue has funded this to carry on community education on the Eastside for meeting the needs of disabled people. ALSO in the program is room for the organization of networking for disabled people to meet their own needs. Always looking for resources— disAbled people who would speak or advocate for disAbled.

#### BUSINESS

Heifer Project International- Next May 20, an HPI rally planned at the site of First Pres. in Bellevue. First meeting, 29 Sept.

Minimum Wage and the JA. Carla and members from the Campaign for a Livable Wage attended an information exchange with the Editor. Carla presented the EISCC statement at this time. All statements given to any press contained the disclaimer.

## PFOPOSED CHANGES TO THE CONSTITUTION OF THE EASTSIDE INTERFAITH SOCIAL CONCERNS COUNCIL

The following changes are proposed in order to make it possible for the council to apply for tax exempt-status so that we may qualify for a third-class non-profit bulk mailing permit.

1. Add the following language to Article II, Section 1 (purpose):

The Council is organized and operated exclusively for religious, charitable, and educational purposes within the meaning of Section  $501\ (c)(3)$  of the United States Internal Revenue Code of 1954. The Council shall not engage in activities which are not permitted to tax-exempt organizations under the above mentioned code section.

2. Add a new article and section as follows:

#### ARTICLE VIII - DISSOLUTION

#### Section I

In the event of the dissolution of the EISCC, any assets remaining after the payment of all its obligations shall be distributed to another organization or organizations then tax-exempt as a charitable organization under Section  $501 \ (c)(3)$  of the United States Internal Revenue Service Code of 1954.

Chairperson Geoff Ethelston called the meeting to order with prayer led by Llano Thelin and self-introductions.

#### REPORTS

<u>Treasurer's Report</u> (Dorothy Scott). Balance, \$833.77. 27 congregations and 8 agencies have paid. Reminders were mailed with the minutes.

MSC to approve the minutes of the November 8, 1988 meeting as corrected: 1st line of item on Holocaust Commemoration, delete "Carla Vendeland noted that" and capitalize "Churches"; 2nd line of EISCC Officers item, correct spelling of "responsibilities."

AIDS\_Task\_Force (Yvonne Wyngaard). Registration forms have been mailed for the conference on February 2 at First Methodist Church. Promotion is requested and preregis-tration is recommended to provide seed money. Harry Apple-white has contacted UCC congregations to request prayer from the pulpit on Unity Sunday, January 22, and to send 5 delegates from each congregation. (An announcement/press release is included with these minutes.)

Pat Meehan reported a negative response from Overlake Hospital, whose representatives informed members of the Task Force that no AIDS patients have come from the East Side, most AIDS patients (of 8) have died, and they have no specific training procedures for dealing with AIDS patients. Representatives of social services and infection control are now training nurses and health care people, in response to legislative mandate. Since Chaplain John Shaw reported no plans for community education, Geoff Ethelston plans to contact him about his apparent insensitivity. Yvonne Wyngaard was asked to send a letter to the hospital administrator and the chairperson of the hospital board.

Elder Gift Boxes (Carla Vendeland). 150 boxes were assembled in November for low-income elderly or severely handicapped recipients. Boxes were distributed by visiting nurses, SnoValley Senior Center, and Multi-Service Center. 40% of the contents were donated, and others were obtained at low cost. Since some of the candy and playing cards were stolen, assembly procedures will be changed next year.

 $\underline{\text{MSC}}$  that EISCC sponsor the Elder Gift Boxes for the year  $\overline{1989}$  and contribute \$100 to the costs of the program.

Coalition for the Homeless (Beth Boyd). Four EISCC members, of whom Harry Applewhite, Geoff Ethelston, and Beth Boyd spoke, attended a Wilburton Hill hearing last night, at which no decision was made. On January 3, the City Council will discuss a policy for affordable housing. Local residents opposed large parks and multi-family housing, now designated as moderate income. David Bloom pointed out that a subsidy is now given to homeowners in the form of a deduction for mortgage interest.

A motion was made by Beth Boyd, and deferred to the January 10 meeting, to support the campaign gradually to raise the public assistance grant in Washington State for the AFDC, AFDC-E, and GA-U programs to 100% of standard of need; to support the campaign to raise the grant in the 1989-1991 biennium by 5% over inflation in each of the 2 years of the biennium (approximately 10% each year); and to commit ourselves to take part in public education efforts to do away with stereotypes and public misconceptions about welfare use.

#### ANNOUNCEMENTS

<u>Seattle Public Theater</u> presents "Show Me the Way to Go Home" (A play about home and its loss), at Kirkland Congregational Church, January 15, at 7:00 p.m. Other presentations can be scheduled through the Church Council of Greater Seattle.

Legislative Conference '89, sponsored by Washington Association of Churches (WAC), Washington State Catholic Conference, Church Council of Greater Seattle, and other church-related organizations, will be held Saturday, January 28, 1989, at the Tyee Hotel, Tumwater. Keynote speaker will be Jan Cate. Registration can be made through the WAC, 525-1988.

Asian Refugees. Nadine Shannon, following up on requests for assistance for Hmong families, thanked these churches for food and housing: Cross of Christ, St. Madeleine Sophie, St. Louise, and St. Margaret's.

Ecumenical Conference. Washington Association of Churches will sponsor local conferences on the subject, "Ecumenical decade: Churches in solidarity with women," in early spring 1990. Members expressed interest, and requested further discussion in January.

- 2. The Council recommends that congregations study the role of their municipalities in meeting those needs and find appropriate ways of influencing budgeting procedures and the allocations for human services.


#### Motions

The Council will have as an agenda item at its May meeting the adoption of a specific dollar goal for the Human Services allocation in the Bellevue 1989 budget.

The Council at the May meeting will also consider appropriate steps for enlisting congregations to use their influence in support of this goal. This may include official congegational statements, or circulation of petitions among the members. It may include letters to city officials from the congregation and or from individual members. These actions to be accomplished by Sept. 30, 1988.

The Council will also at its May meeting consider a resolution that congregations in Redmond, Kirkland, and unicorporated King County should take steps to effect similar actions in the jurisdictions of their location.



## CONSTITUTION AND BYLAWS OF THE EASTSIDE INTERFAITH SOCIAL CONCERNS COUNCIL Adopted 8/11/87

#### ARTICLE I -NAME

Section I

The name of the organization shall be the Eastside Interfaith Social Concerns Council.

#### ARTICLE II -PURPOSE

Section I

The purpose of the EISCC is to provide a means of communication between east-side congregations and the community in the field of social concerns. It will provide a means for developing cooperative interaction between congregations. The Council will endeavor to promote activities relating to human needs. Member congregations will also participate in various activities, including celebrations and opportunities for dialogue, to improve community awareness and service.

Section II

No part of the net earnings of this organization shall ever inure to or for the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be empowered to pay reasonable compensation for services rendered and to make distributions and payments in furtherance of the exempt purposes for which it was formed.

Section III

Notwithstanding any other provisions of these articles, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954.

#### ARTICLE III -MEMBERSHIP

Section I

Membership in EISCC is on a voluntary basis. Membership is open to all east-side congregations incorporated as "non-profit religious organizations" under the laws of Washington State. Membership shall be by congregational action. A roster of member congregations shall be established at the September meeting and maintained throughout the year.

Section II

Each member congregation shall select two (2) voting representatives, preferably one clergy and one lay representative.

Section III

Each member congregation shall contribute twenty dollars (\$20.00) annually to EISCC, prior to the October meeting.

### CONSTITUTION (Cont'd)

#### ARTICLE IV OFFICERS

Section I

The officers of the EISCC shall be Chairperson, Vicechairperson, Secretary and Treasurer, and these shall constitute the Executive Committee.

Section II

The election of the officers of the EISCC shall be made by the Council at the October annual meeting. A nominating committee elected by the Council at the May meeting shall propose a slate of officers to the September meeting. Further nominations may be made from the floor at the annual meeting. The terms of office shall be one (1) year.

Section III

Upon the occurrence of a vacancy within the term of an officer, the unexpired term shall be filled by appointment of the Chairperson from the remaining members of the EISCC, subject to confirmation by the membership.

#### ARTICLE V - MEETINGS

Section I

The EISCC will meet monthly. The Annual Meeting shall be the October meeting.

Section II

Special meetings may be called by the Chair with not less than ten (10) days notice of time, place and agenda being made to the congregational representatives.

Section III

A quorum shall be constituted when one-third (1/3) of the member congregations are represented.

Section IV

Actions and voting procedures of meetings shall be governed by Roberts Rules of Order except in the case where EISCC addresses issues of social concern with recommendation for local congregation or community policy or action. In this case, the Procedures contained in the Bylaws shall be followed.

#### ARTICLE VI - COMMITTEES

Section I

Standing committees and task forces will be appointed by the Chairperson, as required, to perform tasks of the EISCC.

#### ARTICLE VII -AMENDMENTS

Section I

The articles of this constitution may be amended by a two thirds (2/3) vote of the representatives present and voting from the member congregations provided that a thirty (30) day prior written notice of the amendment has been given.

#### ARTICLE VIII - DISSOLUTION

Section I
