MINUTES OF MEETING – JANUARY 8, 1991 Grace Lutheran Church Pearson Hall, Bellevue

Sack lunch.

12:05 The meeting was called to order by EISCC President and Pastor at Grace Lutheran Church, Llano Thelin

Opening prayer by Newell Christensen

Introductions

Minutes of the previous meeting approved with two clarifications.

1. The minutes omitted the information that the AIDS bulletin inserts which were given out at the December meeting were intended to be read by the members in order to vote at this Jan. meeting (about encouraging their use). See vote under reports.

2. The new shelter for single women by Catholic Community Services was incorrectly recorded to be in Bellevue. As pointed out by Stew Corbett, it is in Seattle at Cherry and Second – 233–5106 – can shelter 50 women from 5:30 p.m. to 7:00 a.m. and includes a warm supper.

PROGRAM "How One Church Cares for Those In Need" by Newell Christensen, The Church of Jesus Christ of Latter-Day Saints

Newell distributed and referred to a paper by Keith B. McMullin, Director of Welfare Services, LDS, which describes the emphasis on each person's responsibility but also an extensive system involving family and church to help people who have done everything they can, yet are still in need. This includes encouraging all members to provide a year's supply of food, clothing etc. for their own emergencies, also to contribute to the assistance program of the Church with time, talent, and money (some of which comes from what is saved by fasting one day a month). The local bishops are authorized to administer to individuals the Churches' resources (with the assistance of members). These include food, clothing, counseling, adoption services, job training and the payment of bills, and involve "an extensive system of farms, food processing and distribution facilities, social service agencies, job placement centers and sheltered workshops."

Newell invited us to arrange group tours of their Bishop's Store House and Cannery in Kent, the LDS Counseling and Employment Centers in Renton, and the Deseret Industries Thrift Store in Burien.which has a rehabilitation workshop. The tour would end with lunch at the Cannery with food prepared from the Bishop's Storehouse – about 3 hours in all. Wednesdays are best and about 10 in a group. If interested, call Newell at 454–5584.

REPORTS

Treasurer, Pat Meehan- reported a balance of \$2,277.73. This includes \$1,262.77 in the AIDS/HIV fund. There were two additions to the membership dues - First United Methodist and Cottage Lake Episcopal. Motion to approve the report passed.

AIDS/HIV Task Force -The Rev Bob Fitzgerald Bob referred to the bulletin inserts which Ruth Dundon distributed at the December meeting for our study, and brought the following Task Force motion "EISCC urges that all cooperative churches use the HIV-AIDS bulletin-newsletter inserts in their congregations." It was pointed out the Washington Association of Churches distributed these inserts to the Washington churches. They were prepared by the Multifaith AIDS Project of Seattle (MAPS) and the Catholic AIDS Ministry. Motion was passed. If your congregation has not received this mailing, contact Ruth Dundon (747-1695) or Bob Fitzgerald (at YES 747-4937) Bob is also very much interested in how this material is being used and in what actions are being taken.

Churches currently represented at the Eastside HIV-AIDS Task Force are: Bellevue 1st United Methodist, Newport Presbyterian, Overlake Metropolitan Church, Sacred Heart, St. Louise, St. Madeleine Sophie, St. Margaret's Episcopal and University Congregational United Church of Christ. Representation from all the Eastside churches is desired.

We were reminded of the AIDS VIGIL on Saturday, Feb.2, at noon and 7:00p.m. and on Sunday, Feb. 3, at 5:00p.m. at First Congregational Church, Bellevue.

Pat Meehan announced a drama and discussion about AIDS at Sacred Heart Church on January 23, 7:00p.m. with Father David Jaeger.

Housing/Homeless - Nadine Shannon

Regarding the HOPE II project, Nadine reported that participating churches would not have to get their own additional insurance. The plan would follow that of Palo Alto in which the managing agency (Red Cross?) would take this responsibility. (Item 5 in "Letter of Understanding")

Howard Johnson has further information (455-1271)

Multi Service Center, Bellevue -Carol Furrer for Mary Ann Yglesias. Carol spoke of a busy Christmas season with needs higher than ever, definitely indicating that this is a time for continued help from the churches. Llano suggested that a review of the EISCC Bellevue Emergency Services Fund for the membership would be helpful now. Nadine suggested that some of our members contact Mary Ann to prepare a report. The Rev. David Hackett and Carol Hegg were nominated to do this and bring their findings, if possible, to the March meeting

Carol also told the group after Newell's presentation that his church had, at one time, given almost \$12,000 to the combined funds of the Bellevue Multi-Service Center and Food Bank. (The EISCC fund is separate from these.)

Eastside Resettlement Center – The Rev. Walfred Erickson.

Walfred spoke to us from his perspective of many years of dedicated work with both the EISCC and the Eastside Resettlement Center, reminding us of the close relationship we have had, and of the Center's continuing need of help from the churches.. He sees "no let—up in the number of people who come for help" Consultations. with the State Refugee Office and Church World Service have revealed that at least as many refugees and immigrants will be coming in 1991 as there were in 1990.

Since one of the greatest needs for employment and survival is English language capability, the Center is improving classroom space and staffing for this. In light of all these factors, among others, there is even greater need for funding.

Carol Hegg raised the question of how to respond to the people who are one the streets with signs asking for help.

Discussion followed. Carol wondered about our having cards indicating resources available to give the people. Llano suggested that Newport Presbyterian try it and share the outcome with us.

Sack lunch.

12:05 The meeting was called to order by EISCC President and Pastor at Grace Lutheran Church, Llano Thelin.

Opening prayer by The Reverend David Hackett, First Presbyterian Church in Bellevue.

Self introductions.

Circulation of attendance roster.

Circulation of roster for names of members to contact, to share what their congregations (and agencies) are doing to assist their people in response to the Mid-East hostilities.

Minutes of the previous meeting.

There was a question of why the quarterly report from the Bellevue Emergency Services Fund wasn't included. It will be coming with the March review of what this fund is, and how it works, with the current guidelines.

There are also some typos on file.

Approval of minutes MSC

PROGRAM "Community Services by the Churches in Kirkland" by the Reverend Ron Hutchinson, Kirkland Congregational

Enclosed is the hand-out, "A Quick Glimpse of Kirkland for EISCC" which shows the various ways in which the churches minister to the Kirkland community and cooperate with each other. Also noted, was that in this cooperation, there have developed "close, powerful relationships". One example of this kind of relationship was described in the story of how the covenanting churches responded when Holy Family Catholic Parish lost its church to fire. Among other acts of caring, the member churches offered their sanctuaries and other facilities for weddings and various needs.

KIN is about 10 years old (some of us in EISCC remember Karin Frankenburger working with its beginnings). The covenant has been in existence since 1987 (some of us were also present at this historic event). KITH has the distinguishing characteristic of emphasizing partnership, "modeling a way of being, as the churches address the anguish of our time". To do this, KITH sees all involved as partners, those in need and those helping. For instance, when they provide a community meal, the providers and the recipients eat and visit together, do dishes together etc. The partnerships also involve covenanting and mini-retreats where problems and solutions are shared.

President Llano Thelin expressed our gratitude for this very interesting and encouraging presentation and the hope that the EISCC churches will keep in communication with the Kirkland churches for the future.

REPORTS

Interfaith Study: "The Continuing Journey" – Linda Neverman
Linda was asked to tell us about the interfaith program which is taking place at Bellevue's
First Congregational Church. It is part of an adult education series on the study of
religions. The curriculum touches upon the history, theology and especially how the
people live their faiths. Linda shared that in six months of phone conversations with
people of various faiths, they found Bellevue residents who were afraid to practice their
faith for fear of personal or professional retribution. Some even felt compelled by this to
change their name. The Interfaith Study has been provided to address this kind of
problem, "to educate all people interested in the diversity of humanity".

On the first Wednesday of every month through May, there is a lecture and discussion (2 1/2 hours) held in the chapel at 7:00 p.m. The following class visits the worship service or special event of that faith.

Treasurer's report
Pat Meehan reported a balance of \$1914.35. This includes \$924.17 in the AIDS/HIV fund. The motion for approval was passed.

AIDS/HIV Task Force – The Reverend Bob Fitzgerald
"Every day one person in King county dies of AIDS"
The AIDS Task Force of EISCC has allocated \$500.00 of the AIDS/HIV fund for the translation into Spanish and other languages of the bulletin inserts which we recently received. Fitz would still like to hear about the responses of the churches to these so far (747–4937 –YES office). The task force is also working on study guides for church groups. In addition, the Red Cross has a March series for caregivers of AIDS.
There is new information to share with EISCC by the task force and an AIDS/HIV case worker who has just been assigned to the Eastside by the NW AIDS Foundation. Fitz indicated that the April or May meeting would be the most helpful time for their presentation in terms of other things that are happening.

EISCC Housing Task Force (Coalition for the Homeless) Nadine Shannon and Don Prather

Nadine told of a mini-retreat of the City of Bellevue Housing Task Force of which she is a member. It dealt with the need for regional cooperation among the Eastside cities in the form of a regional development authority or agency. According to Stephanie Warren, City of Bellevue, the Task Force reached consensus on the following:

1. It is important to create an entity to focus on Eastside needs and concerns.

2. The entity should be specifically mandated to develop new affordable housing opportunities including preservation.

3. The entity should be insulated from changes in the priorities of individual cities by being separated from direct control of cities.

Nadine will have more about this.

Don spoke of a letter from the Red Cross which expressed concerns about having HOPE II be the name for the "Twelve churches for twelve months" proposed program. The reasoning was that it might jeopardize HOPE I (Homeless Outreach Partnership for the Eastside) Llano brought a meeting together of people involved to explore solutions with the thinking that, whatever the name, the project is worth our continuing efforts to bring it into reality.

Bellevue Emergency Services Fund of EISCC – Mary Ann Yglesias
Mary Ann reviewed, for the sake of new and "old" members, the history and nature of the BESFund. As she pointed out, it is an emergency fund of EISCC which originated in 1982 during a regular meeting. Pastors shared stories of people coming to their doors for emergency help. Often they were personally not in a position to respond adequately, yet wanted to help the truly needy people. At this meeting, they envisioned a fund from which EISCC churches' money could be disbursed, in a centrally located, accessible place, a place where people could also get other kinds of help besides money, a place which could assess the true degree of need.

Their solution was the Bellevue Food Bank – MultiService Center. Mary Ann was present at this meeting, was asked if she might administer this fund, and she agreed to do

it.

She noted that 100% of the dollars in the fund go to those in need, none to administration. Guidelines were developed then revised in 1987. With the help of Pat Meehan and Dave Hackett, we will get the latest version of the BESF guidelines at the March meeting.

Bellevue Emergency Service Fund (BESF) Guidelines Revised 2/20/91

I. NEED

- A. Primary assistance will be for rent, utilities, and emergency housing. Assistance is available for other unmet needs, such as medical help (prescriptions), transportation (gas, minor car repairs, bus tickets), shoes and clothing, etc.
- B. Total assistance per individual or family is limited to \$300 per year; assistance beyond this limit must be individually authorized by EISCC's standing BESF Monitoring Committee.

II. TARGET POPULATION

- A. The fund shall serve persons who have an obvious need, i.e., they have exhausted their personal resources.
- B. The first priority will be for residents of the Bellevue area (including Mercer Island), but transients may also be served.
- C. There will be no preference regarding age, sex, or family status. Families, single parent families, couples, single men and women, youth, and the elderly will all be eligible.

III. SERVICE AVAILABILITY AND REFERRAL

A. Access to the fund will be through the Bellevue Multi Service Center during Center hours based on a voucher system. No cash is kept on the premises.

B. Participation by congregations.

- 1. Congregations should make any direct donations which they wish to make before referring the clients to the Bellevue Multi Service Center. A telephone consultation with the staff of the Bellevue Multi Service Center can help with the decision-making needed to give assistance to specific clients.
- 2. Direct referrals should be made to the staff of the Bellevue Multi Service Center, which is authorized to draw upon the Emergency Services Fund. The staff can also network with other human service agencies to make available larger amounts of aid or to bring in specific expertise.
- C. The Bellevue Multi Service Center can accept referrals to the fund from sources other than EISCC members. The fund can be used at the discretion of the Bellevue Multi Service Center to network with other human services agencies to meet need.

IV. ADMINISTRATION

- A. The fund will be administered by the Bellevue Multi Service Center.
- B. Screening will be done at the Bellevue Multi Service Center. The Center staff will make the decisions to allocate the fund according to EISCC guidelines.

- C. Donations to the fund will be handled by the Bellevue Multi Service Center, which will also handle the bookkeeping and reporting and disperse funds upon the recommendation of staff.
- D. The Bellevue Multi Service Center will assist the EISCC's BESF Monitoring Committee in issuing twice-yearly reports to participating congregations.

V. DONATIONS

- A. Churches will be asked to make an annual pledge to the Emergency Services Fund.
- B. Congregations should make checks payable to the <u>Bellevue Emergency Services</u> Fund. Checks should then be sent to:

VI. MONITORING

- A. The EISCC shall establish a standing committee ("The BESF Monitoring Committee") to monitor the operation of the fund.
- B. This committee shall make twice-yearly reports to EISCC and to the participating congregations on contributions, dispersals, types of service provided, and other matters related to the fund's operation. One of the twice-yearly reports shall include an annual summary.
- C. EISCC will mail copies of these reports to the participating congregations.
- D. The committee will also assume responsibility for advising the Bellevue Multi Service Center on extraordinary requests which exceed the approved limit or the established rate of frequency.



YWCA'S WORKING WARDROBE

PROJECT DESCRIPTION

The YWCA is excited to announce the April opening of the YWCA's Working Wardrobe, a clothing bank in Bellevue for low-income job seekers. This YWCA project is a response to the growing need for services for low-income persons in East King County.

Many of these women and men are struggling to improve their lives through employment programs and services. They need work-appropriate clothing to successfully enter the job market and become self-sufficient. For homeless and low-income families, there is also a critical need for clothing for young children.

The wardrobe will offer free quality used work clothing for adults, and blankets and clothing for infants through preschool aged children. The YWCA's Working Wardrobe will serve individuals and families referred by Eastside social service agencies. These agencies will distribute vouchers to their clients. The voucher is an "invitation" to use the clothing bank and there is no cost to clients or agencies.

The wardrobe is located in Building E of Overlake Park Presbyterian Church at the corner of NE 156th & Northup Way. The project will be staffed by community volunteers and stocked through in-kind donations.

ROLE OF VOLUNTEERS


As a vital part of this project, volunteers will help clients select clothes, accept and sort donations, and arrange displays and items. Volunteers will accept vouchers and keep a record of clothing donations from the community. No cash will be handled as this is a free service. Volunteers will be a important link in maintaining good relations with Overlake Park Presbyterian Church and the community at large.

The YWCA is looking for volunteers to staff the project on a regular basis. Volunteers might choose to work on a weekly or monthly basis. At this point, the wardrobe will be open Tuesdays from 10:00 a.m.-1:00 p.m. and 6:00 p.m.-9:00 p.m., and Saturdays from 10:00 a.m.-1:00 p.m.

The YWCA plans to offers the service during day, evening, and weekend hours in order to optimize access by clients. If a group of volunteers is able to staff the project on a different day or different time, the YWCA is open to suggestions.

BELLEVUE EMERGENCY SERVICES FUND - Mary Ann Yglesias

She noted that requests exceed donations and that most dollars go for eviction prevention. (See enclosed report.) Clients are also helped in getting funds from other sources. MINUTES OF THE MEETING - MAY 14, 1991 GRACE LUTHERAN CHURCH, PEARSON HALL, BELLEVUE

Sack lunch.

The meeting was called to order about 12:05 p.m. and assembly welcomed by EISCC President and Pastor at Grace Lutheran Church, Llano Thelin.

Opening prayer by The Reverend Bob Fitzgerald.

Self introductions.

Minutes of the April meeting approved.

PROGRAM - AIDS/HIV - Bob Fitzgerald and Ruth Dundon

Bob and Ruth will be Co-Chairs for the EISCC AIDS/HIV Task Force for the coming year and Barbara Schlieper will be Secretary.

Ruth spoke of the many people who had AIDS whom she asked to speak to this EISCC meeting. All were very apprehensive. Only one young man, who prefers to have his name not included, who has been diagnosed HIV positive, agreed to come.

Bob Fitzgerald, Director of Education for Youth Eastside Services, who also teaches a course for counselors at Bellevue Community College, "Chemical Dependency in the Age of AIDS," opened his presentation with "There is no fear in love," and further developed our theological calling. He then proceeded to the basic information, starting with terms:

HIV = Human Immune-deficiency Virus A person may be HIV positive and function normally for years. He/she will have a lifetime infection (medication helps partially). No one knows how many people are infected with this virus.

AIDS = Acquired (not genetic) Immune Deficiency (the virus attacks the immune system) Syndrome
If a person has been diagnosed by a doctor as having AIDS, this is registered with health organizations. It basically means that the virus "inside the immune system"

keeps the immune system from protecting the body." It is the top killer of young people between ages 20 and 2%, especially of those in positions of inadequate information. Babies born of mothers who have AIDS have a 30% to 50% likelihood of becoming infected.

Some questions and answers:

If a person has been tested and found HIV negative, this means he doesn't have the virus.

AIDS isn't tested in routine blood tests (expense is a factor) The patient must request it.

Bob and Ruth then introduced the one person they knew who would share with us his experience of being diagnosed as HIV positive. This young man described some of the problems that arise for a person in his situation - how he was initially told, with very little help, who he can confide in now, etc. He's able to continue his job and feels healthy. There are check-ups every 6 months and treatment that he hopes will help him maintain his health until a cure for AIDS is found. He's inelligible for medical insurance and not hopeful about talking to a pastor. The group expressed gratitude to him for his willingness to come and for his honest sharing.

We were, then, asked to take distributed questionaires to our churches to get input toward future planning for the EISCC HIV/AIDS Task Force. These would be especially welcome if they reach the Task Force before their next meeting, Monday, June 10, at:

Newell said the local networks have already been approached, but replied that they are full. Newell observed that "they need to know there's a viewing audience." The Church Council of Greater Seattle has voted to support it, and Newell proposed that EISCC vote similarly. It was decided that he write a proposal for a vote at our June meeting. It is a follows:

Suggested proposal for EISCC EISCC: Moved, 2nd, Passed 6/11/91

It is proposed that EISCC advocate and support the bringing of VISN (VISION INTERFAITH SATELLITE NETWORK) to our community by doing the following:

- 1. Encourage all leaders of our churches, organizations, communities and agencies, to write letters on official letterheads to cable stations asking them to air VISN.
- 2. Encourage the members of our churches to write such letters, and if you have Cable now, include this letter or a note with your monthly payment.
- 3. Share the belief that VISN will promote more tolerance and understanding between the churches of our community and give it a needed moral influence.
- 4. Share the information that VISN's programming includes the following guidelines which distinguishes it from other religious channels.
 - a) No self-serving or on-air solicitation of funds.
 - b) No proselytizing
 - c) No attacking of other faith groups.

AT A GLANCE

I. WHAT AND WHERE IS VISN?

VISN is a full-time (24 hrs., 7 days) national faith and values cable TV network (with some local programming). VISN can be seen on the local cable channel assigned by the cable system which carries it. At the end of 1990, more than 400 systems carried VISN.

II. WHO IS VISN?

VISN is owned and operated by the National Interfaith Cable Coalition (NICC), a consortium of 27 members representing 54 national faith groups, including Catholic, Jewish, and Protestant and Eastern Orthodox. The effort of the faith groups in NICC is strongly supported by important segments of the cable industry through a separate organization called VGI (Vision Group Incorporated).

III. WHAT IS THE PURPOSE OF VISN?

VISN's purpose is to offer the nationwide viewing audience responsible and accountable TV programming about matters of faith and values. VISN's schedule gathers the best programming about religion and spirituality available -- from independent producers, from global sources (such as the BBC {British} and CBC {Canadian}) and VISN produces its own network specials (such as the Riverside Church prayer service with Nelson Mandela). VISN enables participating members to speak to their constituencies through specifically identified denominational programming. VISN also offers local clergy, congregations and interfaith groups 14 hours each week to preempt network programming for locally chosen programs.

IV. WHEN DID VISN START?

The concept of VISN emerged in 1986. NICC was formed in 1987. VISN began transmissions in September 1988. By the end of 1990 VISN was available to nearly 7 million U.S. households and 2.5 million satellite dish owners. VISN is also made available gratis to rest homes, hospitals and other care-giving institutions able to receive it by satellite dish.

V. How does VISN Differ from Other Religious Channels?

VISN is a joint project of the participating faith groups and is accountable to them through its Board of Trustees. VISN's programming follows three guiding principles which distinguish it from most other religious channels:

NO self-serving on-air solicitation of funds
 NO proselytizing
 NO attacking of other faith groups.

VISN's programming emphasizes humankind's profound religious concerns and the response of the major faith traditions to those concerns. Personalities are secondary. VISN is committed to the kind of quality which already causes people to look on it as "the PBS of religion."

VI. WHAT IS THE POTENTIAL OF VISN?

VISN is a fruit of the interfaith dialogues of this century and has the potential of serving as a major instrument of interfaith respect and collaboration in the 21st Century. VISN can enable our nation, local communities and interfaith families to grow in understanding of and tolerance for persons of other faiths and can help to engender cooperation on common concerns.

VISN's potential is enormous and is tied to the growth and influence of the mushrooming cable industry. About 58% of America's homes are connected to cable as of January 1991 and nearly 80% have access to cable. Cable TV now competes for audience with broadcast TV on an almost equal footing.

VII. How can a Community have VISN on Cable?

VISN can be brought into any community which has cable TV. It comes generally into communities where interested individuals and/or faith groups convince the local cable company (1) of its importance to the community and (2) of the support of local faith groups.

The medium of television is unmatched in its power to reach and inform vast numbers of people. It has power to motivate, to tell a story, to make a point and, of course, to entertain. A medium with such power is clearly an obvious choice for communicating faith and values.

That is why the following faith groups are working together to bring you VISN -- the Vision Interfaith Satellite Network. You are invited to join the effort by contacting VISN's Community Relations Director, Rev. Bob Bonnot.



Minutes of the meeting - June 11,1991 GRACE LUTHERAN CHURCH, PEARSON HALL, BELLEVUE

Sack lunch.

The meeting was called to order about 12:05 and the assembly welcomed by EISCC President and Pastor at Grace Lutheran, Llano Thelin.

Opening prayer by Pat Meehan.

Self-introductions.

Minutes of the May 14 meeting approved.

PROGRAM - EMERGENCY FEEDING PROGRAM - Hope Chapin

Hope gave a brief history of The Emergency Feeding Program since it began in 1977. As the name implies, its purpose is to provide short-term non-perishable emergency food. This is in the form of nutritionally balanced packets which offer-

-2 day supply

-1 week supply for babies

- boxes for small, medium and large families

- special boxes for low salt and diabetic needs.

- special boxes for Asian diets

- "Band Aid Packs" which don't need cooking (include can opener, cup, plate, and utensils).

Availability and structure

Churches are the main distribution centers. In Bellevue they are First Congregational Mon. - Fri. 9 a.m. - 12 noon
Overlake Park Presbyterian Mon. - Fri. 2 p.m. - 4:30 p.m.
Weekend referral program Sat. 10 a.m. - 3 p.m. and Sun. 1 p.m. - 3 p.m.
If a call comes to the Emergency Feeding Program on a weekend, it is
forwarded to a volunteer who arranges to bring a packet of food to the client
at a mutually convenient place in Bellevue (i.e. Bellevue Transit Center)

Kirkland, Redmond and Bothell also have Emergency Feeding distribution. It is King County wide.

People in need are identified by agencies and some churches who give the clients a card with statistics which indicate the amount and kind of food that would be best included in their packet. Hope indicated that church staff who would like to have referral cards to give to people in need, call her at 454-7353.

There are EFP packets of food kept at the Red Cross in Bellevue for people who need the motel help of Hope I. Joyce Thelin indicated that this food has been a great blessing to the people who are undergoing this kind of crisis.

Redmond is developing an experimental program to find the people who need help with food. It is called "Food Find" and consists mostly of brochures which are being distributed in schools, laundromats, any place where people in need might see them. Those who respond are put in touch with the resource that most fits their needs such as Emergency Feeding, Food Bank, Food Stamps etc. It was pointed out that the Emergency Feeding and Food Bank programs are complimentary and cooperative. EFP is in place for short term emergencies and the Food Bank is mostly for on-going help and includes perishable items.

Finances and history -

The organizational work on the Eastside was done on a volunteer basis by Trudy Schroeder, who is now directing the Redmond "Food Find" project. Most of the Emergency Feeding Program work is done by volunteers who pack, deliver and help purchase the food. Hope Chapin has the only paid position on the Eastside (which began four years ago).

Food for both the Emergency Feeding Program and for the food banks comes from donations from stores, churches and individuals, and from purchases through the Food Buying Service of the Washington Association of Churches. This buying service enables substantial savings in purchases from Associated Grocers.

The Emergency Feeding Program began in Seattle in 1977 with 2900 boxes and grew to 11,600 boxes in 1990. Each box contains 6 meals (a 2 day supply) for an average of 3.8 people.

In Bellevue there were 1,093 boxes in 1986 and 1,894 in 1990.

Funding comes mostly from churches, some city grants, FEMA funds, private individuals, schools and organizations.

Special Fund Raisers include --

1. Spring baby shower.

2. "Trick or Tuna" at Halloween in which young people going from door to door, ask for cans of tuna for the Emergency Feeding Program.

3. "Three Million Dimes" project - cans in grocery stores and some schools.

Sack lunch.

President Llano Thelin called the meeting to order at 12:10, allowing the members time to settle into their new surroundings. Also he expressed appreciation for this meeting room to our new host church.

The Reverend David Hackett extended his welcome and that of the Community Outreach Committee of First Presbyterian Church. He then offered the meeting prayer.

Self-introductions and circulation of attendance roster.

Minutes of the previous meeting, July 9 1991, approved with one correction. Under the report on HOPE PHASE II, it should be deleted at this time that Joyce Thelin will be the case manager.

PROGRAM - "YOUTH AT RISK" - The Reverend David Bloom, Church Council of Greater Seattle

David talked with us about the serious condition of many children and young adults, giving statistics such as these:

Every day in America -

* 27 children die from poverty.

*700 children are born at low- birth-rate.

*1,500 drop out of high school.

*Over 100,000 are homeless.

*135,000 bring a gun to school.

*The leading cause of death among young black males is homicide.

The breakdown of the family is seen in these ways -

*There are as many divorces as marriages.

*Abuse - one in four girls and one in seven boys are abused by age 18.

*There are more families in which both parents work.

*More than half of the poor children are from single parent families.

*In Seattle, there are 500 - 800 street kids.

The community breaks down when the family breaks down.

Today there is greater individualism, less concern for others, and connections are broken.

Agency budgets reflect lack of commitment by governments.

Some of the ways in which David recommends that churches can help and are helping youth (beyond supporting healthy family life) are:

*By developing a congregational response to school failure, foster care, teen

pregnancy and abuse.

*Being in touch with the Church Council, especially David, for programs and resources.

Three after- school programs that David observed in other cities are:

1. Project Spirit - regular volunteer program by caring adults.

2. Temple Baptist - includes recreation, instruction and nutrition.

3. Computer Learning Center - regular, caring, adult volunteers.

Other observed programs include Child SHARE and parent and child MELD.

Local programs include the U-District teen shelter, Open Door, Youth Service

Center, and Crossroads Community Center in Bellevue.

David emphasized that the common care for children offers an opportunity for churches, agencies and others to develop community and a sense of responsibility for each other.

An example of this cooperation was brought out in the discussion period, namely that Bob Fitzgerald is on David's "Youth at Risk" advisory committee. Already they are developing an on-going program for young teenagers at the Crossroads Community Center with a full-time staff person from YES and are looking for interested adult volunteers from the churches. How H.O.P.E. Works:

H.O.P.E. Staff will receive calls for screening of potential clients. If the clients(s) are qualified for the H.O.P.E. Project, the H.O.P.E. staff will arrange for housing for three nights at a hotel/motel. (This space is a donation of the Hotel Council of East King County and is subject to space available.) A trained H.O.P.E. volunteer will assist the client(s) to their accommodations, provide a three day supply of food (donated by the Emergency Feeding Program), and support decisions and plans for meeting the emergency needs of the client, including transportation. Volunteers will assist by reporting back to The H.O.P.E. Staff appropriate data and results of assistance to clients.

Welcome and prayer by President Llano Thelin.

DISCUSSION ITEMS

Future Programs

October meeting - Llano's invitation was accepted by both Ralph Mero of the Hemlock Society and Ned Dolejsi of the Washington State Catholic Conference to speak on Initiative 119, "Death With Dignity"

November - Possibility of looking at Eastside catastrophic disaster preparedness with City of Bellevue's new staff person who is due on October 1.

December - Focus on family - appropriate to Christmas-time. Hear from our new family task force?

Interest was expressed in the LDS family priority and the Family Home Evening. Newell said this is basically on Mondays. Other meetings aren't scheduled in their church on this evening to leave this evening open for families to do something together. If the family does have something else develop on this evening, they are free to choose another night. Newell said the children are assigned different roles, such as refreshments. Especially, it's a time for the parents to share their faith with their children.

Nadine recalled the Overlake Hospital "Strengthening the Family" program.

Suggested future programs include: Bridge Ministries, Senior programs, VORP, and Phil William's offer to share his experience (with another presenter?) of the grief process in losing a child especially to Infant Sudden Death Syndrome.

PHASE II

A letter was mentioned from Don Prather, (Chair?) of the East King County Hotel Council, commending Phase II especially for its team approach, for including the private sector, government, agencies, churches, funding from foundations etc.

To this date, the churches that were committed were Grace Lutheran, Cross of Christ Lutheran, Bellevue First Congregational (United Church of Christ) and breakfast support from the Church of Jesus Christ of Latter Day Saints. St. Louise is working toward either breakfast help or money or both.

EISCC elections at October meeting.

Llano recommended that the election take place at the end of the meeting. to allow the meeting to move smoothly. So Dorothy will do the minutes this last time and the new secretary will have time to transition in before the next meeting.

VISN

Newell called Cindy Laue, Director of Communications for the ELCA. She had met with TV executives in Tacoma and is willing to join our group in meeting with the key people for VISN. Newell also mentioned that Lloyd Cooney, former president of KIRO, is a friend of his and a member of his church and that he might be of help. Another possibility is that EISCC could be part of a larger delegation. The importance of being well prepared with the most essential information for such a meeting was stressed. An example would be something credible about how much interest there would be for religious programming.

Newell also pointed out that we don't need to ask for the full 24 hours; there could be shorter segments of time.

Agency cooperation

Nadine spoke of the difficulty some people experience when they go to an agency in a state of need. As she accompanied a woman in need of help, she found the problem of the person being sent from one agency to another without any apparent agency cooperation or follow up. There was discussion about what might help this situation. Llano said Larry Fraley is the current coordinator of the Eastside agency directors and had earlier offered to be what help he could. Llano will contact Larry about this.

ETHNIC STOCK: SHOW US THE WAY OVER

Nadine reminded us of this event on Sept 28 at Highlands Community Center. She said that Dorothy English has washed 40 cars to help meet the expenses of putting on this play. She will call Don Prather about the possibility of getting paper supplies for less. The Emergency Feeding Program will benefit from this event.

Minutes of the meeting - November 12, 1991 REVISED AND CORRECTED THE ROCK ROOM FIRST PRESBYTERIAN CHURCH OF BELLEVUE

The meeting was called to order at 12:07 and the assembly welcomed by EISCC Vice-President Nadine Shannon in the President's absence. Nadine gave the opening prayer.

The group gave self-introductions and the attendance roster was circulated.

Minutes of the previous meeting were approved as written.

PROGRAM: Mr. John Haley, President of the Board of Victim-Offender Reconciliation Program (VORP) and Professor of Law at the UW, program presenter.

VORP had its beginnings in Indiana. It operates from a stand of looking at reconciliation from two perspectives.

From the victim's point of view - grants victims the ability to participate, deal with their injuries, confront their offenders, ask them questions, and gain control of the process of restitution, insofar as it is within the means of the offender.

From the offender's point of view - allows for a process of acknowledging guilt, expressing remorse, accepting responsibility, and reconciling with their victims through a mutual contract.

VORP only deals with juveniles who acknowledge guilt within the court process. Those meeting this criterion are eligible for referral to VORP. VORP deals almost exclusively with 2nd, 3rd, and 4th time offenders. It will contact the victim and seek a willingness from them to move through the VORP process. In the end a contract is drawn up; this is monitored to see it is fulfilled, and then data are relayed to the court. VORP operates totally within the criminal justice system.

Around the world there are some 100 similar programs. VORP handles some 30-40 cases per year; the 1991 goal was to increase its caseload by 50% and this has been done. One of its policies is never to turn a case away. The time frame for contact to mediation is typically two weeks. The most common crime mediated is auto theft and similar crimes. VORP hopes to expand beyond juvenile cases in the future, while maintaining caseload worker quality and financial capacity. Success for VORP, as measured by victim satisfaction rate, is high (80-90%); as measured by reduction in recidivism, VORP's offenders have a rate of 80-90% contract fulfillment, vs. below 50% for the usual court rate.

Mediation training for VORP mediators is offered in January and September and is geared for those with full time jobs: Six weeks of evening training, an internship, evaluation precede rating as a mediator. Those wishing to be on the quarterly mailing list for VORP, please call VORP at 621-8871.

She said that a large refrigeration unit has been 50% donated; the remaining \$2500 is awaiting donations, with are welcomed.

Volunteer Chore Ministry - Michael Jackson

VCM has 17 local churches and 68-70 churches in the county now involved. With the state budget in disarray, the government has asked for a 25% reduction in budget for VCM. The VCM budget provides for the management group, insurance, liability, auto insurance for volunteers, etc. A crisis situation may arrive if VCM is written out of the budget; the large numbers of people referred to VCM would be left without assistance. Several churches have given their support to VCM by advocating its inclusion in the state budget.

It was MOVED, SECONDED, and APPROVED:

That the Eastside Interfaith Social Concerns Council affirms the value and importance of the Volunteer Chore Ministry, co-sponsored by the Church Council of Greater Seattle and Catholic Community Services King County, as a critical community-based service to low-income elderly and disabled;

That the Volunteer Chore Ministry is the safety-net for over 9,000 elderly and disabled statewide, with over 250 served through 17 congregations in East King county alone, enabling them to remain in their own homes without risk of premature institutionalization; and

That any reduction in state funding of this program will both place the elderly and disabled at great risk, as well as jeopardize the community-volunteer response inherent in this program.

BE IT FURTHER RESOLVED that the Council's Executive Committee be authorized to advocate on behalf of the Council, as required, for continued state funding of the program; and

That the members of the Council join in advocating for continued state funding of the program, both individually and through their churches and agencies, as they are able.

VISN - Vision Cable Network - Newell Christensen

Newell reported that VISN Puget Sound Chair Cindy Laue will meet in January with Cable Station Management along with various religious community leaders. Details to be forthcoming. He reviewed the VISN community support campaign and encouraged its support in our congregations.

AIDS/HIV Task Force - Ruth Dundon

Ruth reported that the task force met yesterday. Feb. 25th in the evening is its next meeting, exploring the topic "Sexuality" looking at the ELCA document as a resource. She explained that the purpose is not to look for a concensus, but to explore the issue together. More clergy are especially wanted to attend. The AIDS resource notebook is still available for congregations who have not picked one up yet.

Employer Forum: Dave Hackett gave word that the EISCC Cabinet is exploring the idea of sponsoring an Eastside Employer Forum. If you have ideas on possible participants/organizations, get word to Dave (First Presbyterian Church, 454-3082).

Membership Committee: Llano described the proposal to form a membership committee made up of representatives from each agency and denomination to extend invitations to others to join EISCC.

Other Reports: None.

PREVIOUS BUSINESS

Volunteer Chore Ministry: One month ago VCM was looking at a 25% reduction; this has come down to a 19.2% reduction with negotiations still underway. Particular items of concern are that the state is looking at a \$900,000 shortfall, even with the Governor's proposed budget making a 2.5% cut across the board, freezing a portion of the teachers' salaries, and invading the rainy day fund. Also, there is some movement to totally eliminate state funded human social service agencies. And these moves come at a unique time because this is an election year. At this point, VCM is still in the budget. The Legislature meets in January and at that time VCM will renew its negotiations.

Multi-Service Centers: Shelley Noble reported on the Holiday Baskey Program. Some 400 families have signed up and 240 have sponsors - 160 families are without sponsors. The MSCs will receive and distribute baskets this week to sponsored families and the MSCs will make up baskets for non-sponsored families.

Legislative concerns: Llano reported that he met with 20 other leaders and Tony Lee regarding state cuts. The plan is that the end of February is the prime time for a group to go to Olympia, hold a press conference and meet with legislators to advocate the concern about human services cuts. Llano also gave out information about the Legislative Conference 2, held Jan 25, 1992 at Des Moines United Methodist Church, 9th Ave S. and S. 223rd St., tel: 878-8301.

NEW BUSINESS
Religious Freedom Restoration Act: Joy Pocasangre of Temple De Hirsé Sinai spoke about the ramifications of the Religious Freedom Restoration Act: House Resolution #2797, introduced by Biden and Hatch, which is in reaction to an Oregon case. Action Alert is asking for our WA Representatives to co-sign this resolution, which currently has 144 co-signers nationally. Encluded in these minutes is a flyer on this topic.

SPEAK-OUT: Dave Hackett passed out a second edition of the SPEAK-OUT booklet on media addresses for grass-roots response regarding media content.

Condom Issue: Stew Corbet raised the issue of exploring EISCC comment and involvement in the current deliberations regarding condom distribution in schools. There was some discussion and it was noted that pps 12-14 in the AIDS Resource Notebook has some material on this. There was a suggestion that some guidance might be forthcoming from the AIDS/HIV Task Force; however, Ruth Dundon said that there is no concensus on the task force regarding this issue.
