WELCOME AND PRAYER. Co-Chairperson Bev Goucher opened the meeting with prayer led by Betty Smith at 12:05 p.m., February 11, 1997, in the Rock Room at the First Presbyterian Church, Bellevue. Twenty-two persons were present.

MINUTES of the January 14, 1997, meeting were approved as printed. (Sally Wing, 747-5924). (A typographical error of an additional digit on page 5, item # 13, was corrected.)

TREASURER'S REPORT. (Jim Palmer, 747-2977) (Attached). (Presented in the absence of the treasurer by Geoff Ethelston, Co-chairperson.) The treasurer reported a cash balance on January 31 of \$26,621. Congregations for the Homeless received a cash grant of \$4,000 and Project Home-Made Soups a cash grant of \$500 from St. Margaret's Thrift Shop. Gifts of \$650 from two congregations for the Emergency Service Fund have been forwarded to the Multi-Service Center. Payments have been made to Catholic Community Services through December 31, 1996, including an increased billing for December for the manager's extra time in caring for the men during the Christmas snowstorm.

PROGRAM. Eastside Sexual Assault Center for Children. Kerry Todd, MSW, ESACC social worker, stated that the program is directed by Deborah Doane, MSW, (who was unable to be present today) and managed by Harborview Sexual Assault Center. Space and other services are provided by Overlake Hospital. Local city governments and the Office of Crime Victims Advocacy provide financial support. Services began in the 1980s for young children. Evaluations determine presence of abuse and impact on the child. The program provides short-term therapy for children and education for parents, in particular, how to respond to children's questions. Two legal advocates may attend Family Court sessions with a family. Although most referrals come from Child Protective Services, others are welcome to call with concerns. Ms. Todd noted heightened awareness of sexual abuse, and many reports of children acting out with other children. Consultation in the community includes training for teachers and CPS workers. Volunteer opportunities include child

care, office assistance, fund raising, and advisory board membership. A videotape of Kids' Court depicted the program which helps more than 100 children each year to feel comfortable testifying through anticipating what will happen and learning to relax. ESACC serves about 200 children each year between the ages of three and 17, about one-half below the age of six. More girls are seen than boys.

Legislative Report. Joy Pocasangre (747-0877) reported on the Washington Association of Churches' Legislative Conference on January 25, when Nancy Amidei, MSW, offered education on how to talk to legislators. Geoff Ethelston noted emphasis on persons who are overlooked, and the opportunity at the conference for small group discussion and role play. EISCC members were urged to invite their clergy and lay staff to participate in Clergy Day, March 6, reminding them of a letter from the Revs. Paul Forman and Geoff Ethelston of the opportunity to present their concerns to legislators in Olympia.

<u>SELF-INTRODUCTIONS</u> were made by those present.

TASK FORCES AND COMMITTEES.

Legislation. Joy Pocasangre (747-0877) urged contact of Senators Slade Gorton and Patty Murray to question nominees for State Department appointments regarding their position on human rights. Because of EISCC'S non-profit status, it is not appropriate to support or oppose specific candidates.

Friday, March 20, 1997 will be Church Advocacy Day in Olympia, sponsored by the Washington Association of Churches as an opportunity for lay and clergy leaders to meet with legislators. Friday, April 4 will be Human Rights Day.

Ms. Pocasangre urged use of the Legislative Hot Line (1-800-562-6000) and e-mail to legislators.

Congregations for the Homeless. Nadine Shannon (746-6019) noted that Barbara Smith has recently been writing grants. There was good recent coverage in the Eastside Journal. Reports have been submitted to United Way and to the Secretary of State. An official audit is needed, for which a volunteer CPA is needed.

Newsletter. Betty Spohn (451-3651) reported that the newsletter and the revised EISCC brochure have been mailed.

MINUTES of the February 11, 1997, meeting were approved as printed. (Sally Wing, 747-5924).

TREASURER'S REPORT. (Jim Palmer, 747-2977) (Attached). Grants have been received from the cities of Bellevue and Kirkland. No bill has been received from Catholic Community Services for Congregations for the Homeless. The treasurer's report was accepted.

<u>SELF-INTRODUCTIONS</u> were made by those present.

PROGRAM. Housing & Homelessness Programs.

Eric Brown (746-1699) and Dale Nienow provided information on St. Andrew's Housing Group. In partnership with other non-profit organizations, they build and manage permanent housing for such persons as single parents with children and victims of catastrophic illness. Their goal is to provide quality housing, in a safe and secure physical place, to enable people to remain on the Eastside and be involved in the community. They now house about 100 people, having completed a 14-unit apartment complex in Issaquah and a 24-unit complex in Factoria. They are currently constructing 51 town home apartments in Klahanie, for occupancy in March, 1998, in partnership with InterIm Community Development Associates, which has

previously worked in the International District in Seattle. The group continues to seek partnerships to work on future development. Referrals have been made by A Coalition for Regional Housing and social service agencies, as well as through newspaper advertisements and community meetings.

Kal LeMaster (643-1008) presented information about Habitat for Humanity, a non-profit, non-denominational Christian housing ministry, which began in Georgia, and has expanded from the original seven congregations in this area. Their current project, Overlake Park Town Homes, near the Overlake Park Presbyterian Church, includes ten units, which are occupied by persons who commit 500 hours of "sweat equity," in addition to volunteer labor and donations from the community. Thanks were extended to Marilyn Canfield, Habitat representative to EISCC.

In describing Congregations for the Homeless, Nadine Bentsen indicated benefits to host and supporting congregations, including the opportunity to listen to the men who are provided overnight housing on a rotating basis in local congregations. The program served 137 men during 1996, resulting in employment for 67%. There were 17,484 meals served and 5,828 bed nights provided. Terry Kimber has coordinated eleven Latter Day Saints congregations to serve meals to the men in the program. (For further information, call Nadine Shannon, 746-6019.)

Donn Franklin, Episcopal Church of the Resurrection (746-7796), noted that 20 affordable units are being built on the church property, of which eight are already occupied.

WELCOME AND PRAYER. Co-Chairperson Bev Goucher opened the meeting with prayer at 12:05 p.m., April 8, 1997, in the Rock Room at the First Presbyterian Church, Bellevue. Twenty-eight persons were present.

MINUTES of the March 11, 1997, meeting were approved as printed. (Sally Wing, 747-5924).

TREASURER'S REPORT. (Jim Palmer, 747-2977) (Attached). Catholic Community Services has been paid for January and February services for Congregations for the Homeless. The organization has been registered with the Secretary of State, through attorney Terry Lukens. The treasurer's report was accepted.

Impact of welfare reform was noted by Geoff Ethelston, Co-Chair-person, and Joy Pocasangre, Legislative Task Force Chair. Tony Lee, lobbyist for Fair Budget Action, is predicting an increase in homelessness and hunger as a result of Federal Welfare Reform. He asked members to document results for the legislature, and to call legislators and Governor Locke. The plan of former Governor Lowry, not limiting welfare, has been registered with the U.S. Government, and will take effect if no other plan has been adopted by July. Nadine Shannon noted that the average stay on welfare on the Eastside is two and one-half years.

<u>SELF-INTRODUCTIONS</u> were made by those present. Richard Glenn and Linda McClenahan, representing Eastside Mental Health, announced a new Open Door program for outpatient chemical dependency treatment, and reminded participants of other mental health services.

Employment services, coordinated by the LDS church, are offered at no cost to those who either list or seek jobs. Job listings are updated weekly through the Renton office of the LDS Jobs Network (220 S. 3rd St., Renton, 682-3363 or 1-800-453-3860, ext. 3368). Seventy-five per cent of those interviewed during the past two years are now employed. Instructional videotapes include resumes, job applications, and interviewing. The service is available each Thursday evening, 7:30 p.m., LDS church, 14536 Main Street (just west of 148th Ave. SE), Bellevue.

Congregations for the Homeless assists persons in the program, during their two-month or sometimes longer stay, to write resumes and business plans. Congregations are encouraged to develop temporary jobs. Catholic Community Services also helps homeless families.

A non-profit foundation has been formed with a separate board and an on-site administrator to provide affordable housing for the elderly in Cambridge Court on three acres of the Church of the Resurrection property, with the aid of low-cost loans from the State and the City. Twenty units, one-story duplexes and triplexes, all occupied, include one-, two-, and three-bedroom homes.

ARTICLE I. NAME

Section I. The name of the organization shall be the Eastside Interfaith Social Concerns Council (EISCC).

Section I. Mission Statement.

We, Eastside Interfaith Social Concerns Council, are guided by the moving of God's spirit in our community to work together in a spirit of caring and celebration. We honor and respect each others' religious heritages, welcome and pray for each other, and share information about pressing community needs.

We provide a forum to educate, advocate, initiate, coordinate, support, and, through task forces and other means, work for the common good of the Eastside community to address human needs and improve the quality of life.

Section II. No part of the net earnings of this organization shall ever inure to or for the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be empowered to pay reasonable compensation for services rendered and to make distributions and payments in furtherance of the exempt purposes for which it was formed.

Section III. Notwithstanding any other provisions of these articles, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954.

Section IV. Our anti-discrimination policy prohibits discrimination on the basis of race, sex, color, age, national origin, political idealogy, marital status, sexual orientation, disability, handicap, or other protected characteristic.

ARTICLE III. MEMBERSHIP
Section I. Membership in EISCC is on a voluntary basis. Membership is open to all Eastside congregations incorporated as "non-profit religious organizations" under the laws of Washington State. Membership shall be by congregational action. A roster of member congregations shall be established at the September meeting and maintained throughout the year.

Section II. Each member congregation shall select two (2) voting representatives, preferably one clergy and one lay representative.

Section III. Each member congregation shall <u>pay annual dues to</u>
<u>EISCC in the contribute-an-amount to be determined by the membership annually to-EISCE</u>, prior to the January meeting. The fiscal year shall be January 1 through December 31. <u>Congregations in good standing are those which have paid their current dues</u>.

ARTICLE IV. ASSOCIATE MEMBERSHIPS

- 1. Associate memberships may be extended to constituent groups in the areas of social and health services whose philosophies are consistent with the purposes of the EISCC.
- 2. Associate members shall have voice but not vote.
- 3. Associate members shall pay annual dues to EISCC in an amount to be determined by the membership annually, prior to the January meeting, upon application and thereafter to cover administrative costs.
- 4. Associate members shall receive the monthly mailings of the EISCC.

ARTICLE FV_V. OFFICERS
Section I. The officers of the EISCC shall be Chairperson, Past
Chairperson, Vice-Chairperson, Secretary, and-Treasurer, and
Delegate-at-Large, and these shall constitute the Executive
Committee. Officers shall be members of congregations in good
standing. Offices of Chairperson and Secretary may be held jointly
by more than one person.

Section II. The election of the officers of the EISCC shall be made by the Council at the October annual meeting. They shall take office on November 1. A nominating committee elected by the Council at the June meeting shall propose a slate of officers to the September meeting. Further nominations may be made from the floor at the annual meeting. The terms of office shall be one (1) year. Change-of-Treasurer-will-follow-a-review-of-financial-records-by-an outside-independent-auditor-or-a-person-designated-or-appointed-by the-EISCC-Chairperson-at-the-time-of-the-change-

Section III. Upon the occurrence of a vacancy within the term of an officer, the unexpired term shall be filled by appointment of the Chairperson from the remaining members of the EISCC, subject to confirmation by the membership.

ARTICLE V.VI MEETINGS

Section I. EISCC will meet monthly regularly every month, except during the month of August. The Annual Meeting shall be the October meeting.

Section II. Special meetings may be called by the Chairperson with not less than ten (10) days notice of time, place and agenda being made to the congregational representatives.

Section III. A quorum shall be constituted when one-third (1/3) of the member congregations are represented.

Section IV. Actions and voting procedures of meetings shall be governed by Robert's Rules of Order except in the case where the EISCC addresses issues of social concern with recommendation for local congregation or community policy or action. In this case, the Procedures contained in the Bylaws shall be followed.

ARTICLE VI.VII. COMMITTEES

Section I. Standing committees and task forces will be appointed by the Chairperson, as required, to perform tasks of the EISCC.

ARTICLE VIII. AMENDMENTS
Section I. The articles of this constitution may be amended by a
two-thirds (2/3) vote of the representatives present and voting from
the member congregations provided that a thirty (30) day prior
written notice of the amendment has been given.

ARTICLE VIII. IX DISSOLUTION
Section I. In the event of the dissolution of the EISCC, any assets remaining after the payment of all its obligations shall be distributed to another organization or organizations then tax exempt as a charitable organization under Section 501(c)(3) of the United States Internal Revenue Code of 1954.

BYLAWS

- ARTICLE I. PROCEDURES FOR PUBLIC RECOMMENDATION AND ACTION
 The following procedures for public recommendation and action
 outline steps designed to encourage broad study, discussion of
 alternatives and consensus building prior to a vote of EISCC
 representatives and the reporting of their action.
- 1. Issue is raised by local congregation, social agency, or EISCC subcommittee at a regularly scheduled meeting. Alternative courses of action are considered. Where anticipated, a description of the issue to be discussed should be included in a meeting notice.
- 2. A proposed study statement is drafted and submitted to local congregations for discussion and action prior to the next meeting. (This statement is not for public release.)
- 3. Local congregations individually act upon the proposed study statement.
- 4. At the next EISCC meeting, the proposed statement is discussed, language tightened, amended and voted upon by EISCC representatives. A quorum being present, two-thirds (2/3) of the representatives assenting shall constitute approval.
- 5. Public release of the final statement should include the following:
- a) A "Disclaimer" stating that the statement represents the thinking of the EISCC board of local congregational representatives and does not imply official endorsement of the specific congregations or denominational bodies.
- b) A tally of the final vote indicating "for," "against" and "abstain."
- 6. When any issue requires urgent response by EISCC, a proposal may be presented to the council at a regular meeting. The proposal will be discussed, language tightened, amended as appropriate, and voted upon by the EISCC representatives. A unanimous assent of those present and voting shall be required for approval. Any release shall carry a notice that due to time constraints, the congregations have not yet voted upon this issue.

- 7. When any issue requires urgent response by the EISCC, but the draft proposal fails to receive unanimous consent of those present and voting, the officers may meet to draft a proposal which shall be sent to members with a notice of meeting, the date of said meeting to be no less than ten (10) days from the date of posting. The proposal shall be discussed and acted upon as described in Bylaws Article I. # 4. Any release shall carry a notice that due to time constraints the congregations have not yet voted upon this issue.
 - 8. These Bylaws may be amended by a two-thirds (2/3) vote of the representatives present and voting from the member congregations, provided that a thirty (30) day prior written notice of the proposed amendment has been given.

ARTICLE II. DUTIES OF OFFICERS.

SELF-INTRODUCTIONS were made by those present.

PROGRAM. "With Grace Training Foundation: Teaching Women Job Skills." (206-323-7541) Janet McCully, co-founder, and Christie Saito, staff member, presented information about their training program. Local supporters include St. Thomas Episcopal Church, Medina, which has provided funds, and Overlake Park Presbyterian Church, which has provided space. The program has trained mostly women in Snohomish, Pierce, and King counties, in a 75-hour course which emphasizes non-verbal communication, personal presentation, and self-marketing. With Grace also trains trainers. In 1996, 224 participants completed training. Most referrals come from the Department of Social & Health Services and the Department of Employment Security. With changes happening in welfare, training funds have been cut back drastically. Congregations were encouraged to mentor a student or sponsor a class.

TASK FORCES AND COMMITTEES.

<u>Collaborative Leadership</u>. Pam Toelle (425-746-8659) provided a handout from the Search Institute on ideas for congregations to build external and internal assets in young people. She reported

that the Bellevue School District has applied for a grant to expand family connection centers, add a worker for immigrants, and fund social workers who had been cut from the budget. Information on Youth Initiative Forums is available from Sherri Mill (425-747-0934). Peggy Cox, VIBES coordinator for Bellevue Schools, has indicated need for kitchen tables among low-income families (425-455-6062 before July 22; 425-456-4154 after July 22).

Legislative Task Force. Joy Pocasangre (425-747-0877) requested signatures on a Declaration of Independence from Special Interest Money, sponsored by American Association of Retired Persons, Children's Defense Fund, Common Cause, and other organizations. She noted a thank you from the Children's Alliance regarding group homes in Bellevue, recently approved by the City Council.

Strengthening the Family. Betty Spohn (425-451-3651) noted the availability of booklets prepared by the Task Force.

Congregations for the Homeless. Nadine Shannon (425-746-6019) provided information about costs of the program. For 1996, cost per person was \$16.44 per night for a safe, warm place to sleep, three meals daily, counseling as needed, and employment case management. Total cost for 60 nights was \$986.40.

BRIEF REPORT: Terry Kimber (425-644-1729) described the 150th anniversary of the trek by the Latter Day Saints Church from Illinois to Utah. July 19 has been designated as a worldwide pioneer heritage day of community service for the 9.3 million member church. Local projects include restoration of the Issaquah cemetery and recreation of the original trek by wagon train.

Marilyn Canfield, Habitat for Humanity (869-6007) reported that former Coast Guard property in Redmond has been donated for housing. The Overlake Park town homes project, in which at least 19 congregations have been involved, will be completed in 1998.

PROGRAM. "Family Development Program: Moving Families out of Poverty" a new program of the Multi-Service Centers, was described by Shelley Noble. A long-term (two years) family systems emphasis will include crisis prevention, recognizing and affirming cultural differences, client responsibility, and partnership of families with the agency. Two family development specialists will each work with up to 25 "at-risk" families on-site, in their homes, and at other locations, and in partnership with other agencies, to assist them to create a healthy, thriving family unit. The agency will also continue to meet emergency needs, and will distribute flyers announcing the new program at food banks. Noble noted that a similar program has operated successfully in Iowa for 15 years.

She has recently provided updated information for the City of Kirkland, expressing appreciation for their grant, noting service to 43 men from Kirkland during 1996 and 1997, at a cost of \$13.60 per night.

Human Services Collaborative Leadership. Pam Toelle (425-746-8659) announced a meeting September 17, 1 - 3 p.m.

TREASURER'S REPORT. (Jim Palmer, 425-747-2977) (Attached). Balance at the end of September was \$27,510. Catholic Community Services has not yet billed for services to Congregations for the Homeless in August and September. The treasurer's report was accepted.

<u>ELECTION OF 1997-1998 OFFICERS</u>. By unanimous vote, new officers were elected: Chair, Beverly Goucher; Vice-Chair, Terry Kimber; Co-Secretaries, Sally Wing and Michael Johnson; Treasurer, Jim Palmer; and Delegate at Large, Dorothy Scott.

<u>SELF-INTRODUCTIONS</u> were made by those present. A finger food luncheon was provided by the Executive Committee.

PROGRAM. Holiday season and winter needs of Eastside Agencies.

Eastside Sexual Assault Center for Children: Mary Ann Carlson (425-

688-5130). Services include evaluation and treatment of children exposed to sexual assault and other traumatic experiences. They also provide professional education and community education. Holiday gifts and dinners are requested, as well as wrapped gifts for family members.

Emergency Feeding Program: Catherine Hillard (425-562-0698). Services include a weekend referral program and five distribution centers on the Eastside. Opportunities for donations include a food-of-the-month club for congregational donations, Hallowe'en trick or tuna bags for children, and Christmas cards to recognize donations.

Habitat for Humanity: Jean French (425-869-6007). The fourth and fifth duplexes near Overlake Park Presbyterian Church are nearing completion. Redmond has donated 1.3 acres from the Federal government for 24 duplexes. Alternative giving options include cards recognizing monetary gifts.

Multi-Service Centers: Jennifer Cole-Wilson (425-747-4826). Services include food banks, which serve 500 families per week, and emergency assistance for heating, transportation, shelter, and other needs. Holiday needs include Holiday Baskets and gifts for families and children, especially teenagers.

Jewish Family Services: Carol Mullin (206-461-3240). Populations served include elderly refugees and disabled adults. Services include counseling, vocational guidance, family life education, emergency assistance, and a food bank. Bags were filled for the food bank at synagogues and temples during recent High Holy Days. For Hanukah, which begins December 23, children will be matched with donor families. B'nai Brith offers a program called Operation Brotherhood which replaces workers with Jewish volunteers at Christmas and other Christian holidays.

Catholic Community Services' Volunteer Chore Services: Paul Beals (Amy Meal, 206-324-5247). Elderly and disabled are served by volunteers through a partnership with churches, synagogues, and civic groups.

Eastside Baby Corner: Karen Ridlon (425-865-0234). This all-volunteer nearly eight-year old program uses free space in Issaquah, providing to agencies everything needed by children from birth to age 12. Donations include diapers, layettes, shoes, clothes, cribs, birthday toys, and new baby presents. They currently need more storage space and may need assistance with utilities.

Youth Eastside Services: Barbara Hunter (425-747-4937). TREASURER'S REPORT. (Jim Palmer, 425-747-2977) (Attached). Balance at the end of October was \$21,263. Catholic Community Services has been paid for services to Congregations for the Homeless in August. Project Home-Made Soups received a contribution of \$75. The treasurer's report was accepted.

<u>SELF-INTRODUCTIONS</u> were made by those present. Art Sullivan, who works with A Regional Coalition for Housing, was present.

PROGRAM. Congregational outreach/social action programs and intergenerational programs. Congregational representatives were asked to present five-minute reports and a one-page written handout on intergenerational programs, impact of welfare reform on congregational programs, outreach to ethnic communities, special outreach programs, or innovative outreach/social action programs. Many congregations are also participating in Congregations for the Homeless, feeding programs, Habitat for Humanity, etc.

Grace Lutheran Church. (Sally Wing, 425-747-5924) Youth and intergenerational programs have included "Christmas in July" to meet back-to-school needs of families that receive assistance from Overlake Service League. An innovative program is Club 24, a service of Columbia Lutheran Ministries which enables seniors to live at home by providing meals, housekeeping, home repairs, shopping and errands, and daily telephone calls. (206-547-2424)

St. Andrew's Lutheran Church. (Anne Porter. 425-746-2529) A hot meal is provided free of charge three evenings each week, Tuesday, Thursday, and Friday, 5:30 - 6:30 p.m. Churches, schools, and other groups, with assistance from the City of Bellevue, are providing food, clean up, etc., for an average of about 20 - 25 people.

<u>First Presbyterian Church</u>. (Carol Furrer, 425-452-9920) Eastside Urban Academy, sponored by Crista Ministries, serves 30 at-risk students with a high school program, lunches, and counseling.

Church of Jesus Christ of Latter Day Saints. (Terry Kimber, 425-644-1729) Outreach to ethnic communities includes curriculum materials in several languages, and classes for learning Spanish or English. There are monthly worship services for speakers of Japanese and Russian. Local missionaries write articles for Russian, Chinese, and Spanish newspapers.

Temple B'nai Torah. (Joy Pocasangre, 425-747-0877) The Mitzvah Corps visits the sick, provides meals, and offers emergency child care.

First Congregational Church. (Diana Roger, 425-277-6528) Through Habitat for Humanity, the congregation is building three houses in Kenya. The congregation is also working with the Church of Mary Magdalene for homeless women in Seattle. The congregation is open and affirming, publicly welcoming gay and lesbian people, losing no more members than an initial three and welcoming more, has cosponsored an advertisement in the Seattle Gay News, and will submit an article for the interdenominational Open Hands.

Newport Presbyterian Church. (Betty Spohn, 425-451-3651) An annual Alternative Gifts for Christmas Fair includes a giving tree, for purchase of items for Multi-Service Center's Holiday Basket project. Gift certificates can be purchased for agencies including Emergency Feeding Program and Congregations for the Homeless. Items for sale by Habitat for Humanity and the Heifer Project are also available.

Eastshore Unitarian Church. (Gwen Lewis, 206-232-2414) Of the nation's work force, 15% is functionally illiterate and 25% is only marginally literate. Volunteer participation has helped to overcome literacy by tutoring through a Washington Mutual program (1-800-433-0121) and at Lake Washington's Kamiakin Middle School. Training for tutoring is available through Seattle Central Community College.

Overlake Park Presbyterian Church. (Al Bagley, 425-885-0913) As part of the Bellevue Schools' VIBES program, volunteer mentors are working at Sherwood Forest Elementary School one-on-one or in small groups. The congregation is also working with Bosnian refugees, now numbering 24 in an extended family, with the assistance of other Presbyterian congregations and St. Peter's United Methodist Church.

St. Margaret's Episcopal Church. (Nadine Shannon, 425-746-6019) Members serve two hot meals each month at Bellevue Community Center, work with Habitat for Humanity, and with Congregations for the Homeless. Since September, 1993, Congregations for the Homeless has served 538 men, in collaboration with churches, agencies, city governments, businesses, and service organizations. Cost per client per night of \$13.76 includes counseling and employment case management, in addition to food and housing.

Bellevue Christian Church. (Barbara Smith, 425-883-7303) Members have assisted the feeding program at St. Andrew's Lutheran Church, Overlake Service League's food distribution and quilt-making and distribution, and monthly service at a Seattle teen shelter. The congregation is interested in dialogue toward "claiming the promise," a denominational program studying justice for gay and lesbian persons.

Temple De Hirsch Sinai. (Carol Meisels, 425-277-5005) Congregation members do a wide variety of volunteer service both in Seattle and on the Eastside, conducting a toy drive in December and collecting food all year for the Jewish Family Service. In addition to hosting Congregations for the Homeless one month each year, they house ten women each weeknight during the winter in Seattle. As members of the African American/Jewish Coalition for Justice, they host a Passover dinner and a December holiday celebration. They also house choir practice and a food bank for New Hope Baptist Church, whose facilities are being rebuilt after a fire. There is a monthly family intergenerational worship service, and an annual seniors' dinner, hosted by high school students.

St. Louise Catholic Church. (Alicia Martinez, 425-747-4450) Hispanic outreach includes English as a second language classes, educational and service programs, and a Spanish language mass attended by 800 people each week. They also do programs with Vietnamese and Eastern European persons. Through St. Vincent de Paul they provide energy and rent assistance, clothing, and furniture.

Cross of Christ Lutheran Church. (Nadine Bentsen, 425-747-1543) Programs include Kids at the Crossroads, which now has a coordinator. Intergenerational activities, entitled Thank God It's Wednesday (TGIW) include music, a simple meal, junior high and high school confirmation classes, parent education, time for homework, and a brief worship service.

Episcopal Church of the Redeemer, Kenmore. (Rev. Geoff Ethelston, 425-486-5665) The congregation supports the Multi-Service Center shelter, and is engaged in dialogue about gay and lesbian issues.

St. Thomas Episcopal Church, Medina. (Bev Goucher, 206-232-1030) The Eastside chapter of Christmas in April, housed at the church, is gathering names of low-income elderly or disabled persons who need

help keeping up their homes. Volunteer contractors and subcontractors rehabilitated seven houses on the Eastside last year, and are preparing for a one-day event on April 25, 1998.

Catholic Community Services has been paid for services to Congregations for the Homeless in September. Contributions have been received for Congregations for the Homeless from cities of Bellevue, Kirkland, and Redmond, and from United Way. Dues statements have been mailed. The treasurer's report was accepted.

SELF-INTRODUCTIONS were made by those present.

"International Zones of Peace: A Buddhist Perspective on Interfaith Action to Promote Peace, Equality, and Respect" was presented by Ivanka Vana Jakic (253-874-2619), a Croatian (former Yugoslavia), founder and president of Zones of Peace International Foundation. She has resided in the United States for 20 years, and has worked as a social worker with refugees in India. The Foundation has a Board of Directors from five countries, as well as a local King County Board of Directors. She emphasized establishing and recognizing sacred sites to be preserved as local, national, and international zones of peace. Religious leaders have the responsibility to bring peace and reconciliation to the world, as a global family. Ms. Jakic's communications with world leaders, including Mother Teresa and the Dalai Lama, have emphasized seeing God in one another. She noted reference in all Scriptures to peace, which she believes begins with respect for each others' faiths and traditions.

Tom Gilmer presented information about British Traditional Wicca, which, among other pagan or earth religions, has continued to practice pre-Christian religious forms. Wiccans are recognized as having considerable training and as leading Sabbath services. Each person is expected to find his/her own truths, based on belief in a creator, and to serve others. They maintain secrecy about names of gods and goddesses, names of members, and meeting places. They do not proselytize and do not accept money for ministerial works. They worship in one another's homes and other places, where they create sacred space. A life-affirming religion, they are often misunderstood and persecuted by communities in which they live. Gilmer noted that Satanists are not considered part of their faith community, and that Wiccan beliefs do not include a devil.
