OPENING & INTRODUCTIONS

EISCC Co-Chair Lloyd Van Vactor opened the meeting with a prayer by Karen Mae Smith. All introduced themselves.

CONGREGATION REPORT

Overlake Park Presbyterian: Al Bagley (425-885-0913) reported on the church's successful February 2001 peace program, which will be repeated in February 2002.

Muslim Community Islamic Center (14700 Main Street, Bellevue): Fazl Hassan (425-746-0398) reported on this Islamic Center. It also has a small Medina Academy at the old Redmond School House. Most members are from India and Pakistan. There is a fund for unfortunate people. Visitors are welcome at all services, which are conducted daily at noon, 3 p.m., 4:45 p.m. and 7:30 p.m. On Fridays there are services at 2:30 p.m. and 5 p.m.

PROGRAM: CONGREGATIONS FOR THE HOMELESS (CFH)

Nadine Shannon, chair of the CFH program, introduced its history. It was started in 1993. It is the only program for homeless men on the Eastside. Many temporarily homeless men would not have made it without CFH. It meets their 3 fundamental needs: housing, meals, and counseling. Professional counseling and full-time on-site management are contracted out to Eastside Catholic Community Services (CCS). Mail and voice mail are accessible at CCS. Clothing, bus tickets, haircuts, and medical help are also provided.

Patricia Kuderer of Sacred Heart Catholic reported that as a support congregation in November 2001, Sacred Heart involved 240 volunteers, including youth and Brownies. A menu plan provided variety. Live classical music was provided extemporaneously. Sometimes situations require out-of-the-box thinking.

Marilyn Haymond of Jesus Christ of Latter Day Saints, Bellevue Stake (LDS) reported that as a liaison of support services for LDS, she was on site every night during LDS months and was often thanked for the provisions. The program is an excellent example of people helping people, who when able turn around and help other people. If there is extra food, she takes it to Hopelink.

Jim Palmer, Treasurer of EISCC and CFH, reported on what it costs to run the program. The majority of the cost pays for CCS staffing. We operate out of a post office box. We have a \$2 million liability insurance coverage. The budget was \$117,000 for 2001, and \$123,000 for 2002. We provided about 6,000 bed nights in 2001. The average cost was therefore \$20 per person per day for housing, 3 meals, and professional counseling and on-site management for 365 days a year. This is possible due to the generous gift of time, food, and facilities from congregations. Last year, total collections were \$131,000, total expenses \$118,000, to a surplus of about \$13,000.

EMERGENCY SERVICES FUND REPORT (ESF)

Jennifer Cole-Wilson of Hopelink reported on gifts to the ESF and its usage. 194 households were assisted in the last quarter of 2001.

MINUTES

TREASURER'S REPORT

Jim Palmer reported on financial activities for December and reminded delegates that dues are due. A detailed financial report is included as part of these minutes.

MINUTES OF THE EISCC MEETING HELD MARCH 12, 2002

Conducting: EISCC Co-Chair Paul Hunsberger Opening Prayer: Emily Woodson, (206) 232-0222

Introductions: Introduction of all attending including Unitarian Congregation visitors from Romania.

Minutes of previous meeting were read & approved as mailed with only editorial corrections.

Agency Presentations: Marilyn Haymond coordinated the Program on "Disaster Preparedness".

Jo Ann Jordon, (425) 452-7923, of Bellevue Fire Department gave the first presentation. The focus was on Earthquake Disasters Preparedness because Washington State is the third highest threat in the U.S. in Earthquake Disaster probably. Further, of Disasters, Earthquakes are the most survivable. We survive by being prepared. She said do not run to a doorway because one-third of all injuries during an Earthquake are to leg bones. The most important to remember is **DROP** where you are, take **COVER** under something such as a table, HOLD ON to the table legs or anything reachable and STAY IN PLACE until the shacking stops! "What if" answers are: 1) If no table reachable in 3-4 seconds, sit with back against inside wall with no windows. 2) If on bus, hold on to seat in front of you and follow bus driver directions. 3) If in car, pull over and stop. Stay in car. 4) If on top of bridge, drive to end of bridge and then stop. 5) If in bed, stay there with covers over your head. Keep flashlight and shoes under bed to put on because of broken glass & then move outside after shacking stops. 6) If in bathroom, turn off water and sit down. If seated, stay put. Bathroom is the safest place in the building because it is small. 7) If small kids around, act calm. They do not know there is danger unless you become upset. If kids are at school, this is the safest place for them because they are trained as to what to do there. Give the school one hour before you drive to pick them up. 8) If on the phone, put it back on the hook. Do not call 911 to report an Earthquake - They know! Stay off the telephone for 3-5 hours unless there is a life-threatening emergency. 9) Disasters impact utilities. Know how to turn off gas, water & power. What to do: 1) Take care of your own needs first then those around you. 2) Prepare disaster supplies (the American Red Cross: "Family Disaster Supplies Kit" samples & brochures were passed around.) 3) Have a 72-hour kit of food, first aid supplies, water, and clothing readily available. 4) Develop a Family Reunion Plan such as where to meet and ask an out of state friend or relative to be your "family contact". After a disaster it is often easier to call long distance. Other family members should call this contact person and tell them where they are and to find out where you are. Share this information with your friends, neighbors, relatives, children's schools, and your employer. Everyone must know your contact's phone number.

David Swan, (425) 785-3297, of LDS Disaster Preparedness Services gave the second presentation. He said use local fire department materials and to make a list of possible local hazards such as fire, earthquake, flood, etc. Place a first aid kit in each car. Place a 24-hour food and warm clothing kit in each car in case you get stranded in the car. He handed out a recommended list of items for a 72-hour kit for your home. Items included where: the container, water, shelter, cooking equipment, fuel & lighting items, first aid kit items, hygiene items, clothing, fun items such as books, pens, pencils, games for children and other supplies such as cash and spare keys. This kit should be kept at home, near the door. In addition he said everyone should be prepared with six "Self-Reliance Steps": 1) Education, 2) Physical Health, 3) Employment, 4) Home Storage, 5) Resource Management, and 6) Spiritual, emotional and social skills.

Congregational Reports:

MINUTES OF THE EISCC MEETING HELD APRIL 9, 2001

Conducting: Co-chair, Lloyd Van Vactor, (425) 885-6993

Opening Prayer by Dr. Sally Wing, (425) 747-5924

Introductions: All present introduced themselves. Special welcome to visitors

Minutes - The minutes were approved as mailed with editorial corrections.

Program: "Safe Transition for Sex Offenders" presented by William Ruddell, Executive Director of Providence House, (425) 653-1613. He introduced their Board of Directors and Mission Statement. Public safety is a primary priority of Providence House which contributes to community safety by utilizing group supervision, support and accountability in a structured environment. They maintain shared housing with six adult, low risk sex offenders in each unit. They are supervised by the Department of Corrections and registered with the King County Sheriff. Offenders in the program must be currently in treatment and have signed a contract to abide by the requirements and regulations of a shared housing unit. They have an attorney, clinical psychologist and risk management specialist on their board of directors. Dr. Dick Leon of the board of directors held a question and answer period on how churches can play a part in this effort. 1) Churches can help redeem broken lives. 2) Help create location for Providence Houses. 3) Provide a welcoming environment for offenders. 4) Provide financial support for the program. 5) Invite Providence House speakers to your congregation. 6) Be a host group for an offender. He said their efforts are to help humanize community relationships.

The next speaker was Victoria Roberts, (360) 753-1678, head of the Community Protection Unit, Department of Corrections, in Olympia. Her fact sheet was very informative. There are 16,298 sex offenders registered in Washington State with less than 20% under the Department of Corrections Supervision. In the five largest counties there are 276 offenders registered as transient with an additional 1,345 offenders registered but no longer residing at their address. In the last two years, their department has spent \$192,661 for housing; \$5,607 for transportation; \$17,020 for Treatment: \$4,518 for Medication; and \$14,699 for other (misc.) costs.

Reports:

<u>Eastside Emergency Services Fund Quarterly Report</u> – Jennifer Cole-Wilson, (425) 943-7559, said EISCC provided 100% of the \$7,872 funding, needed to meet their expenditures from 1-1-02 to 3-31-02. They served 106 households.

MINUTES OF THE EISCC MEETING HELD May 14, 2002

Conducting: Co-chair, Paul Hunsberger, (425) 454-1556.

Prayer & Response by Louise Wong, (425) 637-0822, "The gift I have received, I will give as a gift".

Introductions: All present introduced themselves.

Program: "Mental Health Issues: Community Support" was coordinated and introduced by Dr. Sally Wing, (425) 747-5927. A panel discussion was held focusing on answers to the following questions: (1) What information do congregations need to respond to mental illness issues? (2) What would be helpful for congregation members to know in dealing with the mentally ill? (3) What can congregations do to show support and remove stigma? Panel members were Beth Hammonds, clinical department manager, Seattle Mental Health in Bellevue, (425) 602-4400 extension 1401; Sue Wuhrman, (NAMI) National Alliance for the Mentally Ill – Eastside, (425) 455-4236; Carol Green, a NAMI consumer; and Cassandra Jackson, Director of Northwest Counseling Institute, an outpatient therapy program for seniors, adults and children which is a part of Adult Community Support, Seattle Mental Health.

Beth Hammonds said they have 6 case managers and a caseload of 75-80, they provide many long term-care, residential homes for 5 persons each. Their funding is from Medicare through King County. They provide medications (donated by vendors), educational and health wellness forums, \$2.00 lunches, school base programs, mentors, outings, picnics and a buddy system society. They need volunteers.

<u>Sue Wuhrman</u> said they need churches to purchase appropriate journals and books on mental illness for their libraries. They need prayers for strength, understanding and the ability to cope for those with mental illness. They teach family classes on mental health in a monthly forum. They need volunteers and free space in churches for their meetings, forums and activities. She introduced Carol Green.

<u>Carol Green</u> spoke as a receiver of church services, food, free medication. She said it is most important for the church to let her contribute and participate.

<u>Cassandra Jackson</u> said they administer shelter plus care programs for the homeless which are HUD funded. They have more demand for housing than supply. They maintain a suicide crisis line.

Congregational Reports:

Rev. Geoffrey Ethelston, Church of The Redeemer, Kenmore, (425) 486-5665 explained Pentecost as a major holiday and the birthday of the church. It is held 50 days after Easter.

<u>Joy Pocasangre</u>, Temple B'Nai Torah, (425) 603-9677 explained the Jewish Shavu-ot holiday. It is held 7 weeks after Passover. They have a week of feasts, celebrations, and read the Book of Ruth.

Emily Woodson, Emmanuel Episcopal, Mercer Island, (206) 232-0222 reported that their donation funds are growing. They are happy to contribute to EISCC projects. They are participating in Habitat for Humanity and Congregations for the Homeless. They had a project to deliver supplies to tent city.

Here, she worked for Public Health for 28 years as a nurse and retired 15 years ago. She was raised a Lutheran and is now an elder at St. Luke's Lutheran church.

JIM PALMER, First Presbyterian Church-Bellevue: Jim was born in Spokane, Washington, the last of 9 children. His mother was an immigrant from Norway at age 19. Jim married and went to school in Spokane, graduating in 1934 during the depression. He worked as a grease monkey and then joined the Navy where he never was in harm's way. Program: Head Start presented by Bellevue School District.

Heather Duncan is a Head Start Family Support Specialist at Sherwood Forest Elementary School. They have pre-school programs during the normal school year for children 3-4 years old from low-income families, families receiving public assistance grants, and children in foster care. Low-income families are defined as having annual income of \$17,650 for 4 in the family and \$14,350 for 3 in the family. This program includes free bus transportation for sessions 8:30 a.m. to noon and noon to 3:30 p.m. plus free snacks and a nutritional meal. They support their families by referrals to food banks, housing, and community services. They also have nominal health and nutritional services for older children and home-based counseling, job training and employment programs for families. For more information contact Heather Duncan at (425) 456-5766 or heather.duncan@bsd405.com, or contact Nicole Lindwall, Stevenson Head Start Center Coordinator at (425) 456-6062 or nicole.lindwall@bsd405.com.

Kara Zordel is a Head Start Family Advocate and Social Worker based at Stevenson Elementary School Head Start, (425) 456-6057 or kara.Zordel@bsd405.com. She runs a year-round, full day childcare program from 6:30 a.m. until 6:00 p.m. This is a subsidized program using \$10 coupons plus co-pay amounts depending on the parent's ability. Government Funds are limited to children born in the USA or U.S. Citizens. Those who do not qualify for the funded program, can use the childcare services for \$600 per month. Also the school district has scholarship programs to help families just over the minimum income limits. These families can make a co-payment from \$10 to \$340, depending upon their need. Head Start provides breakfast, lunch, 2 snacks and transportation to school and doctors. They offer services for children from newborn to 5 years old. They need volunteers to give one-on-one attention to the children in the program, and as interpreters for Spanish, French, Korean, Russian, and Vietnamese children.

Congregational Reports:

Jim Palmer, First Presbyterian Church, (425) 688-0433, handed out a report on their community outreach program. He stressed three programs which focus on raising people out of poverty. These are: (1) KidREACH which tutors at-risk children 2 nights a week. They need volunteers as tutors, substitute tutors, prayer partners, or nutritious snack providers. Contact Sheryle Nelson at (425) 885-0223. (2) Talk Time Classes for adults who speak English as a second language. This program teaches basic conversational English for life situations. They need volunteers, contact Patty Hirz at (425) 746-8224. (3) Eastside Academy gives at-risk high school students a safe and loving environment to learn and gain hope and skills for the future. Tutors are needed in history, language, science, math and the arts.

<u>Louise Wong, Sacred Heart Catholic Church</u>, (425) 637-0822, said St. Louise Catholic School also has similar after-school programs for children.

<u>JoAnne Way, East Shore Unitarian Church</u>, (425) 747-3031, said they have funds available to help needy children. Write need and requests to Bob Lewis, c/o East Shore Unitarian Church, 12700 SE 32nd, Believue, WA 98005. They try to fill needs not covered by an agency or DSHS.

Kevin Henry, (425) 452-4100, City of Bellevue, Parks & Community Services, Cultural Diversity Program Coordinator, said their main goal is to bring ethnic peoples together. He said our strength is in our diversity. Their outreach is through focus groups. They encourage all EISCC members and their congregations to attend ethnic events and become involved in the City of Bellevue Cultural Diversity Programs. A list of programs and events was handed out. They have informed speakers, groups and "Living Voices" available for church presentations. Living Voice Productions are one-actor plays focusing on racial and historical themes.

Troi Coram, (425) 869-6490, extension 315, is the manager of Friends of Youth Emergency Shelters and Street Outreach Programs. They are a large agency with 19 sites. She works with needy youth and young adults, ages 11 to 17. They are, or are at risk to be, runaways or homeless. Their agency has punseling services and group therapy. They have case managers to help meet pasic needs of finding food, shelter, clothing, and employment. They have volunteers opportunities with their outreach programs, shelters, and teen feed services.

WELCOME AND PRAYER. Co-Chairperson Paul Hunsberger (425-454-1556) opened the meeting with prayer by Nadine Shannon (425-746-6019) at 12:09 p.m., October 8, 2002, in the Chapel Lounge at the First Presbyterian Church, Bellevue. Hunsberger thanked Betty Spohn, Marilyn Haymond, and the rest of the Executive Committee for preparing the luncheon meeting.

SELF-INTRODUCTIONS were made by those present.

PROGRAM. AGENCY HOLIDAY NEEDS, PART I.

Salvation Army. Bob Giuliano (425-827-1930). The agency hopes to move to Crossroads Park next year. They provide emergency financial aid such as food, shelter, utilities, and clothing. During the holidays they prepare Christmas baskets and have an adopt-a-family program. They provide grocery vouchers and a Toy 'n Joy shop for children up to 12 for families at 125% or less of the federal poverty level. Sharing Trees, adopt-a-family, bell-ringing, and meal service are volunteer opportunities.

Seattle Mental Health. Carolyn Anderson (206-324-2243). They serve severely mentally ill persons, and persons with grief and stress-related issues. Serving the entire King County area, they have two offices in Bellevue and one in Redmond, and last year served 3000 persons on the Eastside. Ninety-eight per cent of their clients are on Medicare or Medicaid assistance. In order to recognize all cultures and faiths, they are seeking \$25 gift certificates from stores for groceries, gifts for children, etc.

Eastside Baby Corner. Karen Ridlon (425-865-0234). They provide everything children through age 12 need, distributing items through 50 local agencies, a total last year of \$3.3 million. Current needs for children include diapers, baby food, infant sweater, children's socks and underwear, children's sweatshirts and pants.

Habitat for Humanity. Aliya Nylander (425-869-6007). They provide homes year-round, based on contributions from churches, organizations, and individuals of all faiths working together. They recommend as a gift alternative, donating home furnishings in memory or honor of someone.

Hopelink. Jennifer Cole-Wilson (425-943-7555). They hold food banks weekly, as well as for holidays, and have a gift room for selection of presents. Last year they served 1300 families. Rota-Care continues to provide medical services on Saturdays between 9:30 and 11:30 a.m. Volunteers are needed to wrap gifts.

Emergency Feeding Program. Catherine Hillard (425-391-1196). They provide year-round nutritional food for emergency situations, such as unemployment, at 37 distribution sites in King County, including six on the Eastside. Food packs, a two-day supply of food, include special dietary needs. Gifts can be made through a "Food of the Month Club."

Multifaith Works. Bev Coco (206-324-1520, ext. 221. The agency, which began with service to AIDS patients, offers housing, emotional spiritual support, and educational outreach. An AIDS care team program trains teams of 12-14 persons for hands-on care. They sponsor houses for low-income persons and for patients with multiple sclerosis. Part of their program is the Multifaith Alliance of Reconciling Communities, bridging faith communities with the gay/lesbian/bisexual/transgendered/questioning community. Volunteers and food donations are needed for a Christmas dinner.

<u>Jewish Family Service</u>. Carol Mullen (206-861-3176). Based in Seattle, they offer basic social services, emergency financial assistance, and a food bank. On the Eastside, they provide a multiethnic center and counseling, as well as a monthly food bank. Gifts for a gift matching program can include gift certificates, toiletries, Chanukah candles and menorahs.

Agencies unable to send representatives were Catholic Community Services (425-562-6864) and Youth Eastside Services (425-747-4937).

LEGISLATIVE ANNOUNCEMENT. Joy Pocasangre (425-747-0877). She provided information about a rally for human services in King County, and budget hearings. She will seek further information about scheduled lobby days in Olympia in 2003.

Geoff Ethelston (425-486-5665) noted that King County expects to cut 50% in human services next year, and reduce funding to zero in three years. He requested calls to King County Council members to seek State legislation for other resources.

Program: Interfaith Habitat for Humanity, Jim Paget of Bellevue Christian, (425) 828-1654, (web site: Together we build.org), presented a news release video which represented a first time coalition of five religions working together to build four homes on Snoqualmie Ridge. He told of an Arabic prayer translated by a Jewish congregation and repeated by Christians who were working together with Buddhists and Hindus. The project was very successful due to generous donations and the involvement of 3500 families. This was a tremendous demonstration of successful interfaith involvement. We were challenged to each invite someone from a different religion into our home for dinner during this next year. The next build will be in Calcutta. They already have the land to build either a school, hospital or houses.

Reports: Nadine Shannon, (425) 746-6019, gave an update on Congregations for the Homeless. They have a new location and telephone number, (425) 284-2211. There were originally 12 post congregations providing overnight housing, now they have 12 post congregations plus 54 support congregations who prepare, deliver and serve meals each night. There are now 130 homeless men in the program.

<u>Marilyn Haymond</u>, (425) 641-1497, gave an example of how the program for feeding the eastside homeless men works. It has been very successful for their congregations. She donates the extra food to Hopelink and needy families.

<u>Jim Palmer</u>, (425) 747-2977, reported the cost of the program for Congregations for the Homeless. \$123,000 was spent for the year for personnel, site managers, and Catholic Community Services who provide screening, employment interviews, counseling, telephone access, bus tickets and gas for travel to employment interviews, clothing, and backpacks. Overhead for running the program is less than 1% of the total operating costs. Their objective is to remove homeless men from the street by getting them a job. 60 days is the maximum time for men in the program.

Minutes of the previous meeting were accepted with editorial corrections. Introductions of EISCC members: All present introduced themselves. Treasurer's Report (see below) was accepted as presented.
