WELCOME AND PRAYER. Vice-Chairperson Lloyd Van Vactor (425-885-6993) opened the meeting with prayer by Karen Mae Smith (425-644-2064) at 12:05 p.m., Tuesday, January 13, 2004, in the Chapel Lounge at the First Presbyterian Church, Bellevue.

<u>SELF-INTRODUCTIONS</u> were made by those present. There were 23 members and guests present.

PROGRAM. "Emergency Feeding Programs on the Eastside." Hopelink. Jennifer Cole-Wilson (425) 943-7555. Hopelink has six food banks in North and East King County, which have evening and senior food banks. From January to November, they served 58,000 households, 2000 - 2200 each week. Three meals per day for six days, for each family member, are provided twice each month. are targeted food drives, for example, tuna and rice. They are moving toward a holistic approach, including signing people up for the state food bank program; and inquiring about income and residence, in order to refer to other resources. Nutrition programs in some centers are run by volunteers, who hand out recipes. Clients speak 15 different languages, and have many dietary needs, based on health, religion, and culture. Sources of funding include food donations, which have decreased by 15% from 2002, despite an increased population of seniors and people exhausting unemployment Donations may be made to Hopelink or to specific programs benefits. (92% of donations). A free Rota-Care medical clinic is available every Saturday. For people who lack insurance, there is a dental clinic in Bothell on three weekends and Bellevue on one weekend each month.

Emergency Feeding Program. Catherine Hillard. (425) 391-1196. The program is sponsored by Church Council of Greater Seattle and Black United Clergy for Action. They provide nutritional food. including food to meet special dietary needs, such as diabetic, low salt, liquid high-calorie, Asian, and vegetarian. There are 36 distribution centers, in churches, six on the Eastside, including First Congregational, Overlake Park Presbyterian, St. Andrew's Lutheran, in Bellevue; Kirkland Congregational; Inglewood Presbyterian, Bothell; and Redmond First Methodist. Teen snack packs are available at Youth Eastside Services and Friends of Youth. Referrals are made by any of 200 social agencies; and referrals are made to others on the EISCC emergency services list. Demand last year was fairly level, with more seniors and Hispanics. The program

is funded by cities, which collect information about zip code, income, and ages. Ways to contribute include food-of-the-month; specific food items, such as tuna and macaroni; and food bags on site at many agencies.

Catholic Community Services. Linda Verbel. (425) 284-2211.

A hot meal program is prepared by volunteers five days per week in the Crossroads Community Center in Bellevue, serving 75 people per night, including seniors and Eastern European immigrants, for whom referral resources are available. A similar program in Issaquah, located on Sunset Way near the fire station, serves 35 people per night, mostly single, in a family atmosphere. They do not collect demographic information, but sometimes spot check to ensure Bellevue or Issaquah residents. Children can participate as volunteers.

Other meal programs include a hot meal on Thursday night at St. Andrew's Lutheran Church, Bellevue; a weekly Hispanic meal at the North Bellevue Senior Center; a weekly lunch at St. Louise Catholic Church, Bellevue; and a twice-monthly lunch in Carnmation. In response to a question, it was noted that Northwest Harvest provides food East of the mountains and in Seattle.

City Ministries, City Church, Kirkland. Joel Pike. (425) 881-0366. Perishable food is provided, from grocery stores, bakeries, etc., with no requirements. Three refrigerated trucks distribute to 35 outlets on the Eastside and in Seattle. The program started in 1992 with distribution from a bakery, and now reaches 20,000 or more persons each week. Every Saturday, 20 - 30 churches pick up food from the Redmond warehouse/distribution center (which has coolers and freezers). There are no requirements to be part of a church, although people are invited to pray if they want. There are also clothing and home furnishing pickups. Their strategy includes distribution to individuals and families, networking and partnering with churches, and training other ministries with a seminar program.

EISCC EASTSIDE EMERGENCY SERVICES FUND ANNUAL REPORT. Jennifer Cole-Wilson, Hopelink (425) 943-7555.

In 2003, \$34,615 assisted 331 households with rent (first month or eviction prevention), water (to avert disconnection), prescriptions (necessary); and utilities (avert electric or gas disconnection). Other needs included medical/dental bills and education and storage costs. Fourteen congregations donated \$22, 282. These congregations were: Aldersgate United Methodist, Bellevue Christian, Church of the Resurrection, Cross of Christ Lutheran, Eastshore Unitarian, Eastside Friends Meeting, First Presbyterian, Grace Lutheran, Holy Cross Lutheran, Overlake Park Presbyterian, St. Andrew's Lutheran, St. Louise Catholic, St. Margaret's Thrift Shop, and St. Madeleine Sophie.

CONGREGATIONAL REPORT. Sacred Heart Catholic Church. Dr. Gretchen Gundrum, Pastoral Associate. (425) 454-9536. Gundrum assists people with chronic illnesses. She has worked at

Harborview Medical Center and teaches at the Seattle University School of Theology and Ministry. She oversees the parish social concerns commission, which has an annual services day, basically a "band-aid" approach, which it is trying to expand to longer-term service. The parish offers opportunities like Habitat for Humanity, and is looking at more systemic change, including reaching out and educating people; and serving in home, parish, and community. The parish school includes making sandwiches for Crossroads in their social justice work; bringing in athletic shoes for children, which they took to First Place School. Other groups within the parish do outreach, including Crossroads meals, and the St. Vincent de Paul Society, to provide temporary assistance. There is interest in travel, such as mission trips to Nicaraugua and the Dominican Republic, to build houses and churches.

Legislative Report. (Joy Pocasangre (425) 747-0877, and Sally Wing (425) 747-5924).

A handout was provided on the legislative agenda of the Washington Association of Churches, which includes a fair and equitable tax system, adequate support for human services, welfare policies that lift families out of povery, and access to health care. Another handout provided information about a Western Washington Legislative Briefing later this month. Members were urged to use the legislative hot line to contact legislators. (1-800-562-6000)

MINUTES. (Sally Wing, 425-747-5924). Minutes of the December 9, 2003, meeting were approved as printed.

TREASURER'S REPORT. (Nadine Bentsen, 425-747-1543) (attached). Seventeen congregations and agencies have paid dues. Expenses have included printing and postage for minutes. Contributions have included United Way funding for Congregations for the Homeless. Balance on hand is \$70,384.

#### ANNOUNCEMENTS.

Congregations for the Homeless. (Nadine Shannon, (425) 746-6019. Shannon and Louise Wong have reviewed treasurer's reports. Thirty men were served in December. For the year, there were 6606 bednights, and 18,000+ meals served.

Van Vactor announced Martin Luther King Day programs, including Christian, Jewish, and Buddhist sponsorship of a walk.

Services include a conference on immigrant voices, to share information about needs and services.

Valerie Stoury, Human Services Specialist (425-456-5342), stated that five part-time staff members serve the district's elementary schools, funded by a city grant, the Bellevue school district, the Bellevue Schools Foundation, and some Title I funds. Services include information and referral for families, and advocacy (transportation, school supplies, clothing, food, English classes, summer school, after-school activities). Family involvement is encouraged, including visiting classes and networking with each other.

Sue Hanlon, Bellevue School District Volunteer Coordinator for VIBES (Volunteers in Bellevue's Education System) (425-456-4454), trains and coordinates the work of 450 volunteers in the 27 Bellevue district schools, who provide such services as tutoring and reading to students.

Isobel Rostykus, VIBES volunteer (425-746-3682), has worked with individual students on a one-to-one basis.

CONGREGATIONAL REPORT. Tom Shepard (425-454-2146) introduced a report on the First Congregational Church, whose outreach includes World Vision and two AIDS outreach teams. Michelle Allen-Kaehler (425-869-5243) described Bradford House, a community center for non-profit groups, scheduled through Sue Wright (425-454-5001).

The Task Force encourages the King County Council to maintain human service There was considerable discussion about Tent City 4, which funding. is currently seeking county space for homeless persons, and has been offered space by two congregations in Bothell. There is also a national effort to end homelessness in ten years.

MSC that EISCC have representation on the Religious Task Force.

EASTSIDE EMERGENCY SERVICES FUND. (Jennifer Cole-Wilson, (425-943-7559), Hopelink, reported total donations from three EISCC congregations and St. Margaret's Thrift Shop of \$4,575 between January 1 and March 31, 2004; and expenditures of \$8,106, for rent, prescriptions, water, medical, gasoline, and garbage. The largest group of recipients were single mothers with children. There is more shortterm case management, e.g., budgeting. There was a request for a list of congregations who contributed during the year, and for an annual report in both English and Spanish to be sent to all Bellevue

congregations. Cole-Wilson noted that children in the North End are similarly assisted by local organizations.

Cole-Wilson noted that Congregations for Kids sponsors Good Start Back to School, supplying children in Bellevue schools with backpacks and school supplies; and that Hopelink serves children outside of the Bellevue School District or who are otherwise not served. Further information on Congregations for Kids, which includes faith communities and the Bellevue School District, is available from Nancy Jacobs (425-883-6406). She announced a summer reading program, which also includes activities, with further information available from Anna (425-943-7558).

WELCOME AND PRAYER. Co-Chairperson Lloyd Van Vactor (425-885-6993) opened the meeting with prayer by Geoff Ethelston (425-486-5665) at 12:02 p.m., Tuesday, September 14, 2004, in the Chapel Lounge at First Presbyterian Church, Bellevue.

SELF-INTRODUCTIONS were made by the members and guests present.

REFLECTIONS on the life of Nadine Shannon, who was instrumental in developing Congregations for the Homeless, were offered by Dorothy Shindler (425-455-1864) and Steve Roberts (206-295-7803).

PROGRAM. "The Human Side of Congregations for the Homeless." Steve Roberts, Chairperson, presented highlights of the eleven-year history of the program, which in 2004 has provided 6800 bednights and 21,000 meals to 125 individual men, some for four or five months. During the history of the program, more than 700 men have been served. There are 12 host congregations, one of which has requested replacement, and 24 support congregations. New features of the program include weekly job and career counseling with a resource person; and weekly medical services by a nurse practitioner, supplemented by parish nurses and referrals to RotaCare or hospital emergency rooms. Some congregations have provided showers and washers and dryors. Life coaching teams have been helping with the transition to transitional and permanent housing.

Dan Velez, who has been a staff member since 1998, was previously a client, who shares his experience with clients. Through prayer and Bible reading, he came to appreciate the source of his trust, and has been giving back to a program he appreciates.

Dave Mullin, a current client, has found in Congregations for the Homeless breathing space, mutual support, and willingness to police each other if necessary. He noted that, "clean body, clean spirit, clean clothes, there isn't anything you can't do." He played his guitar and sang a song he had composed. Steve Roberts, noting the stigma of homelessness, also noted the need for life coaches, for which training will be offered at the Woodinville Alliance Church (425-486-0367) beginning September 23. He also requested counters for the One Night Count of the Homeless, Friday morning, October 22, beginning at 2:00 a.m., at First Presbyterian Church, Bellevue, with training and breakfast provided (206-461-3777). He has been able to locate a site for transitional housing, but not for a permanent shelter.

Ann Olds, Catholic Community Services, noted a growing population of single homeless women, and lack funding for a program.

EISCC EASTSIDE EMERGENCY SERVICES FUND. The quarterly report was presented by Betty Spohn (425-451-3651), as prepared by Rochelle Clayton at Hopelink (425-943-7559), who is replacing Jennifer Cole-Wilson, in providing that service. Expenditures included eviction prevention and first month's rent, prescriptions, avoidance of water disconnection, and payment of other bills. Financial assistance was provided to 109 households. EISCC members provided 14% of the \$12,255.32 expended between April 1 and August 31. Spohn emphasized that gifts directed to Hopelink must specify EISCC Eastside Emergency Services Fund in order to be credited to this fund.

<u>PROGRAM</u>. "Winter and Holiday Needs of Social Service Agencies." All agencies are seeking volunteer and financial assistance, as well as food, clothing, and gift cards for persons they serve.

Childrens' Response Center. Beverly Jacobson, Advisory Board Member (425-455-2524) (Agency: 425-688-5130). The agency works with children from birth to age 18 and their families who have been sexually assaulted or experienced other trauma. They provide legal advocacy, education, and awareness. Needs, which are year-round, include food, clothing, certificates for movies and other events, phone cards and cell phones. A silent and live auction will be held Saturday, November 13.

Emergency Feeding Program. Catherine Hillard, EastSide Coordinator (425-391-1196). Nutritional food is provided for emergencies on a referral basis from 150 King County agencies. There is a food-of-the-month club for donations of basic nutritional food items.

East King County Habitat for Humanity. Mary Martin, Resource Development (425-869-6007, ext. 233). A recent mini-blitz build was held at Snoqualmie Ridge, completing two more single-family homes. At Patterson Park the first five-unit bulding has been completed and occupied; three more buildings are planned. Alternative gift fairs and holiday gift cards can provide donations.

Hopelink. Rochelle Clayton (425-943-7559). This agency is the largest non-profit social service provider in North King County. They provide traditional holiday foods to low-income families, as well as new and unwrapped gifts, toys, and books, which are

. The agency facilitates inclusion of persons with disabilities into the life of congregations by training ushers and fostering welcome. They recycle equipment, such as wheelchairs. They train facilitators of support groups, which number 16 Circles of Friends. For the past seven years on the fourth Sunday evening of each month a congregation hosts a gathering of people with disabilities, providing a meal and entertainment. There are two chaplains on the staff; and their speakers' bureau includes people with disabilities.

Catholic Community Services. Courtney Lyon, Volunteer Coordinator, East King County Family Center (425-284-2288; or 425-284-2211, Agency). The agency provides volunteer chore services, such as housework, laundry, and shopping; emergency support services, including meal and hotel vouchers; family support, including advocacy; homesharing; and counseling for adults and children. Their transition housing program includes skills training for parenting and for the work force. Holiday programs include Shoe Boxes of Joy for low income persons and people with disabilities.

An all-volunteer agency results in no overhead. Their more than 150 care provider partners work

with families, and can now order online. They are the last safety net, collecting and distributing items to their partner agencies that children use from birth to age 12. Items they collect and distribute include food, clothing, furniture, school supplies, and toys.

Puget Sound Blood Center. Leigh Chapman (425-462-4395). The agency needs 900 pints of blood each week, for the 90% of the population who will need blood during their lifetime. The need is critical during holidays and summer. There is a rare donor program for people of color, and a national register for bone marrow. Fewer than five per cent of the population donate blood.
