SELF-INTRODUCTIONS were made by the 22 people present including three visitors.

PROGRAM: "A Secret Revealed" was presented by Beverly Jacobson and Dayle Zawaideh of the Children's Response Center on the Overlake Hospital campus (425-688-5130 and web site:

) The "secret" is prevalent sexual abuse of children. It is estimated that by age 18, 1 in 5 girls and 1 in 10 boys will be sexually assaulted by a trusted person. Both physical and emotional damage occur with feelings of betrayal, loss of trust, fear, and shame. Five hundred families were served last year by the Response Center. There are 10 full-time staff and many volunteers. Funding is by government grants, insurance, fees, and donations. The annual fundraiser breakfast will be held on May 13th at Meydenbauer Center with a speaker on internet sexual abuse.

WELCOME AND PRAYER: Chairperson Rabbi Jim Mirel (425-603-9677) opened the meeting with prayer at 12:05 PM, Tuesday, February 8, 2005, in the Chapel Lounge at First Presbyterian Church, Bellevue.

SELF-INTRODUCTIONS: were made by 17 members and 3 guests.

MINUTES: Minutes of the January 11, 2005 (Catherine Swadley, 425-392-7753) meeting were accepted as printed.

PROGRAM: "I Make a Difference in the Life of a Child". Saul Drevitch (206-763-9060 ext 228) of the Big Brother, Big Sister Agency explained that they served 1500 young people last year in King and Pierce Counties by matching each youth with a mentor. They found that 80,000 youth would benefit from such a mentorship. The program includes referrals from counselors in Kirkland schools and a Redmond school. The organization received a Federal grant to work with children of incarcerated parents. Mr. Drevitch would welcome more male mentors. There is a special need for men to mentor boys who are potential dropouts. Mentors spend one or two hours per week with a child or youth.

Joy Pocasangre (425-747-0877) of Temple de Hirsch Sinai described the NESES (Children Studying El Salvador) program. She and her husband take children from orphanages in El Salvador on seven-day trips exploring the country's parks, ruins, and museums. Since public school ends at 9th grade, many children need scholarships to attend high school. Faith communities can sponsor a child for \$1200 a year.

Others attending the meeting shared how they have or are "making a difference in the lives of children."

TREASURER'S REPORT: Pat McDermott (425-643-7759) reported that receipts for the month of January exceeded disbursements by \$6,173. Cash balances increased to a month end total of \$73,798. The Nadine Shannon Memorial Fund now totals \$4,296.

ANNOUNCEMENTS: NAMI (National Alliance for the Mentally III) has started a program for parents of the mentally ill.

WELCOME AND PRAYER: Chairperson Rabbi Jim Mirel (425-603-9677) opened the meeting Tuesday, March 8th, 2005 at 12:05 P.M. in the Chapel Lounge at First Presbyterian Church, Bellevue. A prayer was given by Louise Wong.

MINUTES: Catherine Swadley (425-392-7753) offered minutes of the February 8th, 2005 meeting and they were accepted as corrected: "Faith communities can sponsor a child for \$400 a year" in the El Salvadoran program, not \$1200 a year as originally reported.

TREASURER's REPORT: Pat McDermott (425-643-7759) reported that February receipts exceeded disbursements by \$6,883. The month end cash balance was \$80,827.

CONGREGATIONS FOR THE HOMELESS: Steve Roberts (206-295-7803) reported that the 27 men currently in the program are housed at St. Matthews Lutheran Church, Renton. In April the program will move to Westminster Chapel. We are looking into the possibility of a collaboration with Hopelink for a Life Coach, who will work with the men and train others in Life Coaching skills. Louise has applied for a grant to fund a half time person.

Tent City 4 is presently at the Kirkland Congregational Church United Church of Christ.

Hopelink is sponsoring a conversation: on "What is possible when everyone is talking and working together to end homelessness?" This event will be held Wednesday, April 27th, 2005, from 8:00 AM.to 2:00 PM at Meydenbauer Center, Bellevue. The guest speaker will be Rev. Robert Taylor, Co-Chair of the Committee to End Homelessness. He will talk about the Ten Year Plan to End Homelessness. Small group discussions and action planning will also occur at this event.

SELF INTRODUCTIONS were made by 18 members and 5 guests.

PROGRAM: "Social Justice Actions in Greater Seattle" Dr. Sally Wing introduced two speakers from the Church Council of Greater Seattle; Rev. Sanford Brown, Executive Director and Michael Ramos, Director of Social Justice Ministries. Organized in 1920, the Council includes 418 congregations of 17 Christian denominations. The goals of the Council are unity, social justice action and ministries of compassion. Some events planned are "Service of Hope" in Rainier Beach on March 11th, a Peace March on March 19th; a Walk for the Homeless on March 25th in Bellevue; and Commemoration Days for Archbishop Romero the week of April 3rd through 10th.

The Council sponsors nine transitional buildings housing 150 people. The buildings are managed by the residents with case management services provided. They have an 89% success rate of moving persons to permanent housing.

"A Walk with Workers" project convinced Aramark Corporation to allow a union for hotel and restaurant

workers and janitors. Another successful project was the preparation and publication of a Ten Year Plan to End Homelessness which was adopted 2005 with end -goal of 2015. Causes of homelessness were found to be economic, cultural and legislative.

ANNOUNCEMENTS: Jessica Ivey from Kirkland Hopelink requested financial help of \$75/week to provide Tuesday evening meals for the 65 Tent City residents presently camped at Kirkland Congregational Church.

Joy Pocasangre announced that as part of Commemoration Days for Oscar Romero at Temple de Hirsch Sinai the graphic film "Roses in December" will be shown on April 8th . It is not recommended for young children. The film is sponsored by the Temple and the Sisters of Joseph of Peace.

The City of Bellevue asks that faith congregations indicate what they are doing for the needy. There will be both written and phone surveys.

There will be an Interfaith Fair at Bellevue Community College on April 9th from 9:00 AM to 4:00 PM which will include workshops.

The Bellevue Crop Walk will be held May 14th beginning at 9:30 AM. Materials will be handed out on April 2nd at 9:30 at Bellevue First Congregational Church.

Jean Ann French announced that Acres of Diamonds, will hold a spring Open House on April 3rd from 2:00 PM to 5:00 PM at 26326 Kennedy Dr., Duvall WA. Acres of Diamonds is a transitional home preparing homeless women for independence.

The Alliance for Human Services is promoting petition signings in cities and counties to raise sales taxes to help close the funding gap for criminal justice and other services to the needy.

ADJOURNMENT: The meeting was adjourned after prayer by Marilyn Rands.

PROGRAM: The "Ten Year Plan to End Homelessness in King County" was introduced and explained by Bill Kirlin-Hackett, Interfaith Task Force on Homelessness Coordinator. Contact information: 425-442-5418, email itth@comcast.net and Web page: http://itthomeless.org. The Federal "Religious Land Use and Institutional Persons Act of 2000" asked government to show the risk of homelessness. In King County 8000 persons are homeless including 400 youth and young adults and 2400 families. The basic goal of the plan is to provide a way for religious communities to exert moral leadership among the public, business, nonprofit, and private sectors and to encourage formation of regional solutions that end homelessness and create affordable supportive housing. The moral response to this problem is "Do no harm! Offer help with compassion, charity and justice." A governing board, a Consumer Advisory board and an Interagency Council will be formed

Tent City 3 and 4 and Congregations for the Homeless are now in operation. Nine transitional housing projects are in place. Any faith congregation could buy a house where five to six persons could live. Church Council of Seattle would provide a management program. 9500 units of housing are needed. 40% of the homeless are families and 14% are single women.

City officials and faith community leaders are invited to a FORUM ON HOMELESSNESS to be held on Wednesday, April 27th from 8 AM to 2 PM. at Meydenbauer Center, Bellevue, (free breakfast and lunch). RSVP 425-869-6000-ext. 835. Mr. Kirlin-Hackert may be invited to speak to any congregation on homelessness.

The CFH trailer will move July 1st to St. Thomas Episcopal Church in Medina.

PROGRAM: The East King County projects of Habitat for Humanity were described by Mary Martin (425-869-6007). Patterson Park housing in Redmond has been remodeled into town houses which are already occupied. The next Eastside "build" is planned for September 11-18 in Redmond. Twenty skilled volunteers are needed for each "build." (Call to find out the need for volunteers before that date.) This organization sustains its partnership with the selected families by providing counseling on family problems. Habitat for Humanity also will sponsor Camp Brotherhood, a leadership camp for social activists on July 12th in Arlington. This camp experience is called "Faith Forward."

Phil Gerson (home phone 425--898-0836 or cell 425-890-8685) described another housing project called "Together We Build." Following the terrorist attacks on 9/11/01 an interfaith alliance was formed of Iman Mosque, Bellevue Christian Church, Sacred Heart Catholic Church, Temple B'nai Torah, and St. Joseph Catholic Church of Issaquah. This alliance has built seven houses. The next "build" is planned for September 7-11 following an interfaith service. Youth are welcome as volunteers. WELCOME: Chairman Rabbi Jim Mirel (425-603-9677) opened the meeting at 12:05 P M at the First Presbyterian Church Chapel Lounge. The opening prayer was given by Sandy Lewis.

SELF INTRODUCTIONS were made by the 40 persons present, including 10 guests.

MINUTES: Catherine Swadley (425-392-7753). The minutes for the July meeting were approved as printed.

TREASURER'S REPORT was given during the report of the Congregations for the Homeless.

PROGRAM: Steve Roberts (206-295-7803) introduced the representatives of the Congregations for the Homeless staff and Hopelink Life Coaching staff. He reviewed the history saying that EISCC started making plans for the shelter in 1993. Forty host churches agreed to house the trailer and homeless and/or provide support. Currently 12 congregations provide sleeping space and many of

them have showers and laundry facilities. Other congregations provide food and financial assistance. There is an on-site manager Three meals a day are provided including a sack lunch. There have been few problems.

A nurse practioner visits once a week. The number of men in the program has increased 20% from last year. Men are allowed to stay 60 days. Longer stays are permitted if the client is making progress.

- The Hopelink Shelter Management Team consists of Jan Dickerman, Meghan Altimore, and Ken Kerron. David John Bowling (425-749-8369) is Congregations for the Homeless Shelter Supervisor. Dan Galaz, David Carbajal, and Habib Siddiqui are the site coordinators.
- New to the program are the volunteers are being trained to be Life Coaches. Through a two-year contract with Hopelink, Mark Brown, Lynda Wolf, and Bruce Borremans (Family Development Specialists) will train 30-40 volunteers. There are both male and female volunteers but only males will be used as Life Coaches for CFH. The training consists of four 2-hour sessions to develop conversational skills, understand reasons why persons resist change, learn what helpful actions to take, and how to help people move to permanent housing. The goal of the Life Coaching Program is to promote self-sufficiency and make lasting changes for homeless persons.

TREASURER'S REPORT by Pat McDermott (425-643-7759) indicated that disbursements for the month of August exceeded receipts by \$10,803. Cash balance decreased to a month-end total of \$79,524. Three monthly payments to Catholic Community Services were made in August, bringing EISCC current through June 2005. Two more payments are to be made to CCS. EISCC's contract with Hopelink begins September 1. The insurance issue with the City of Bellevue (COB) has been resolved and the COB first quarter payment was received in August. The COB second quarter payment of \$ 9,043 is expected to be sent in September. Congregations are requested to increase their contributions to CFH by 5% in addition to their EISCC dues. Steve Roberts (206-295-7803) is willing to talk to congregations about the CFH program.

Life Coaches are working with fourteen men . There will be an Open House of CFH on December 6th at the First Presbyterian Church of Bellevue. There is an ongoing need for more affordable transitional housing for the men. A person to act as a director of transitional housing is also needed.

TREASURER'S REPORT: Pat McDermott (425-643-7759) reported that receipts for the month of October exceeded disbursements by \$12,531. Cash balances increased to a month end total of \$91,375. The second quarter payment from the City of Bellevue was received during the month. During November EISCC will close out our account with Catholic Community Services. Approximately \$17,500 is owed this agency.

PROGRAM: Agency Winter and Holiday Needs were presented by seven agencies.

Bridges Ministries is the legal guardian for 46 developmentally-disabled individuals who have no family and often lack speech. Volunteers are needed to manage durable medical equipment. The "Circle of Friends" welcomes new members. A chairman for the "Rock'n Roll Dance" and more church partnerships are also needed. Contact Rev. Bruce Knofel or Brooke Patten at 425-828-1431.

The Community Information Line is open five days a week to provide help for those seeking shelter and food. The Crisis website www.crisisclinic.org has a current listing of 8000 resources. The "Where to Turn Directory" is available for \$30. (The Eastside and Southside Supplement will be printed in June.) A "TeenLink" phone line is manned by 21-year olds from 6-10 p.m. seven days/week for youth suicide prevention. Amanda Woodland provides information for 540,000 caregivers in King County and to those seeking disabilities information.
