CONGREGATIONS FOR THE HOMELESS

Information: Nadine Shannon (746-6019)

Regular meeting: 3rd Tuesday, 12 noon - 1:30 p.m., Temple DeHirsch Sinai, 556 - 124th Avenue NE, Bellevue.

The purpose of Congregations for the Homeless is to provide stability in homeless men's lives and to return them to being members of the community. Shelter and nutritious meals are offered, in a collaborative atmosphere of volunteers with professional counselors and site managers.

The Task Force is in its third year of providing shelter, three meals per day, and social services for homeless men at congregational facilities. Host congregations, who provide facilities for a month, are assisted by support congregations with financial and volunteer support. Catholic Community Services provides social services.

Between September, 1993, and December, 1994, 181 men were assisted. Permanent housing was located for 72 men and other housing for 46. The program provided 5,437 bed nights and 12,985 meals. Ninety-four men have gained employment. Between 80 and 300 volunteers participate each month.

Of the \$100,000 annual budget, 40% must come from local congregations, to supplement grant and other funding. Volunteer support is also needed for smaller host congregations.

Meetings are held the second Tuesday of each month (except August), 12:00 noon - 1:30 p.m. (bring your sack lunch; beverages are available), at the Rock Room of the First Presbyterian Church, 1717 Bellevue Way NE, Bellevue. At each meeting, community representatives present information about resources and programs; and congregations, agencies, and task forces share information and ideas.

Priority issues are: housing/homelessness; employment; HIV/AIDS; strengthening the family; hunger; cultural diversity; and health care/mental health. The Council publishes annually an Emergency Services Directory, which is distributed to congregations and agencies.
