WELCOME TO EASTSIDE INTERFAITH

Welcome, visitors and members, to Eastside Interfaith Social Concerns Council (EISCC). The Council provides exchange of information among Eastside congregations, in order to improve the quality of life for all on the Eastside. We trust that EISCC was called into being and is guided by the moving of God's spirit in our community. EISCC encourages interfaith dialogue.

Membership is voluntary, open to all Eastside congregations of all faiths and creeds. There are currently 42 member churches and social agencies. Member congregations contribute \$25.00 annually to EISCC and select two voting delegates (clergy and/or lay).

Associate members are social and health service programs whose purposes and activities are consistent with the purposes of EISCC. Each pays a fee of \$10.00 annually, and has voice but does not vote.

Meetings are held the second Tuesday of each month (except August), 12:00 noon - 1:30 p.m. (bring your sack lunch; beverages are available), at the Rock Room of the First Presbyterian Church, 1717 Bellevue Way NE, Bellevue. At each meeting, community representatives present information about resources and programs; and congregations, agencies, and task forces share information and ideas.

Priority issues are: housing/homelessness; employment; HIV/AIDS; strengthening the family; hunger; cultural diversity; and health care/mental health. The Council publishes annually an Emergency Services Directory, which is distributed to congregations and agencies.

The Task Force is in its third year of providing shelter, three meals per day, and social services for homeless men at congregational facilities. Host congregations, who provide facilities for a month, are assisted by support congregations and other volunteers with financial and volunteer support. Catholic Community Services provides social services.

Quarterly meetings are held on the first Wednesday in the Bellevue Public Schools Board Room. The Task Force encourages partnership among the religious community, City of Bellevue, Bellevue Public Schools, and human service providers, working together to provide services to Bellevue school-children and their families.

"A good start back to school" will be a workshop on Wednesday, July 10, at First Methodist Church, 1934 - 108th Ave. NE, Bellevue. The workshop will focus on how-to ideas to prepare low-income children for school with new school supplies and clothing. The Bellevue Public Schools and the Bellevue Multi-Service Center will administer the program, with assistance from congregational volunteers. FINANCE TASK FORCE: STEWARD OF FUNDS

Eastside Interfaith Social Concerns Council budget includes both a general fund and a separate fund for each task force, which the treasurer reports at each month's general meeting.

The general fund includes operating expenses: printing and postage for minutes, newsletter, Human Services Directory, and brochures; incorporation filing fee; mailing permit; Post Office box rental; and office supplies.

Each task force has funds specifically donated to accomplish its purposes. Both grants and donations are essential to maintain Congregations for the Homeless, which has the largest budget, based on high expenses.

Current activities of the Finance Task Force include fund-raising and grant writing for Congregations for the Homeless.

Volunteers are needed to assist the treasurer in preparing the budget and seeking additional sources of funds. Development experience is not necessary; the Task Force will provide training.
