WELCOME TO EASTSIDE INTERFAITH

Welcome, visitors and members, to Eastside Interfaith Social Concerns Council (EISCC). The Council provides exchange of information among Eastside congregations, and encourages interfaith dialogue.

Membership is voluntary, open to all Eastside congregations of all faiths and creeds. There are currently 42 member churches and social agencies. Member congregations contribute \$25.00 annually to EISCC and select two voting delegates (clergy and/or lay).

Associate members are social and health service programs whose purposes and activities are consistent with the purposes of EISCC. Each pays a fee of \$10.00 annually, and has voice but does not vote.

Meetings are held the second Tuesday of each month (except August), 12:00 noon - 1:30 p.m. (bring your sack lunch; beverages are available), at the Rock Room of the First Presbyterian Church, 1717 Bellevue Way NE, Bellevue. At each meeting, community representatives present information about resources and programs; and congregations, agencies, and task forces share information and ideas. The Council publishes annually an Emergency Services Directory, which is distributed to congregations and agencies.
