October 10, 2017 Meeting Minutes

The meeting was held in Bristol Hall of St. Margaret's Episcopal Church; it began at 12:00 noon and ended at 1:40 PM.

WELCOME: People helped themselves to lunch and conversation. The meeting was called to order at 12:15 PM and conducted by EISCC President Tony Copes.

OPENING PRAYER: Khizer Sheriff

SELF-INTRODUCTIONS were made by 21 representatives, including 9 congregations.

MINUTES July 11th and September 9th minutes were approved by the membership.

TREASURER'S REPORT

Treasurer Warren Marquardson reported our account balance is available on the website; about \$124,000. Approximately \$66,000 Backpack Meals, \$40,000 Congregations for Kids and \$18,300 EISCC.

Reminder: Only EISCC dues paying congregations can vote in EISCC elections; dues paying social service organizations cannot vote in EISCC elections.

PROGRAM:

Affordable Housing Strategy for City of Bellevue: Mike Katterman and **Janet Lewine**, City of Bellevue, Department of Planning and Community Development.

- The need for affordable housing affects everyone!
- A survey of Bellevue residents and businesses found that in 2017, 77% of the households find affordable housing
 is the #1 community problem. In 2015, 68% and in 2013, 51%.
- People cannot afford to live here, in this city or King County.
- Bellevue School District loses 1/4 of its teachers after teaching for a year. Teachers commute for a year and quit.
- Cost is financial and human quality of life.
- The housing market is insane here. Median rent is \$2,700 per month. Median sale price is \$1.95 million.
- Workers earning \$10 to \$20 per hour are the most at risk of losing housing or being homeless.
- Workers earning \$15/hour earn \$31,000/year and can only afford to pay \$800 per month for rent.
- Workers earning \$20/hour earn \$42,000/year and can only afford to pay \$1,000 per month for rent.
- Washington minimum wage is \$9/hour.
- "AMI" is Area Medium income.
- "Affordable" is **30%** household income spent on rent and utilities.
- Transportation is the #2 expense.
- 9,100 households (17%) or 22,000 people earn <50% of the AMI.
- About 3,100 units (6%) are affordable.
- 2/3 or 65% of Bellevue residents make > AMI. 1/3 or 31% of Bellevue residents make < AMI.
- 16% are senior citizens spending >50% of their income on rent.
- Hence, we see REAL impacts are on food and prescription drugs.
- Bellevue has been working for decades but the issue has gotten much worse.
- ARCH is in 15 cities and directs funding and density bonuses and direct assistance.
- ARCH has only produced 2,500 units since 1990. Unclear if this is the number in Bellevue alone or in all 15 cities.
- As part of Bellevue's Affordable Housing Plan, a Technical Advisory Group =TEG was created to (1) identify and test, (2) no recommendations, and (3) create guidance.

- The TAG said that insanity requires BOLD actions. Some Types of Actions the City of Bellevue is taking:
 - o June 2017 Bellevue's Affordable Housing Plan approved
 - Saving Highland Village maintained affordable housing for >80 kids
 - Trying to identify and anticipate buildings that may be redeveloped
 - King County Regional Affordable Housing Taskforce is doing for King County wide what we did for Bellevue
 - o Micro-housing will have kitchens, unlike the units built in Seattle, which taught us people need kitchens.
 - o Biggest obstacle is non-profit land. Faith-based land is an option.
 - o Comprehensive plan amendments and rezoning takes years.
 - Development on public lands near transit.
 - Update MFTE.
 - o Eastgate rezone is done. Extra density for affordable housing.
 - o Families can never set aside to save money to buy with rents as high as they are.
 - Tap additional funding sources.
 - o Bellevue General Fund is flat at \$450,000 a year.
 - o \$3.5 million over 10 years so an additional \$500,000 a year.
 - o Implementation: goal of 2,500 New affordable homes over 10 years.
