Announcement: Ryan Murk, Porchlight, reported on upcoming hearing for proposed new affordable housing project in Redmond by Plymouth Crossing. Hearing is at City Hall in Redmond, April 16th 6:00PM. Individuals were encouraged to show support, as outside groups are mounting a strong misinformation campaign.

Main Presentation Marc Vermouth, Exec Director, The Sophia Way (TSW)

Marc is the new executive director, beginning in January of this year. TSW provides wrap-around services for women experiencing homelessness. Shared values and commitment to equity.

Seattle/King County homeless, 13,368 individuals experiencing homelessness in 2022, a 30% increase in five years. Continues to disproportionately affect minorities. Ultimate fix, wage and income equity. Cost of housing in Western King County (2 bedroom apartment) requires an income level of \$98,000 per year. Only 5% of homeless in area are from out of state. Cornerstone values: Shelter, safety, stability.

TSW now provides behavioral health counseling and case management. 90% of clients served are still in permanent housing after six months.

Of the women served, 30% are over 55, 46% are POC, 48% suffer disability, 70% are domestic violence survivors, 92% have an annual income of less than \$40K. Only half of sheltered individuals are actually unemployed, many of which are unable to work for various reasons.

Marc shared a video of one woman's experience getting into permanent housing via TSW. TSW provides multiple services – Housing, rental assistance, vehicle repair outreach, a day center providing breakfast and lunch, and safe parking, Over the last three years, 374 women found permanent housing through TSW. Finances, \$3,273,231 revenue, \$3,448,550 expenses. 40% of revenue come from individuals and corporations, with the balance from civic, government, and faith organizations. There are many possibilities for interfaith communities to bring congregants into TSW for support.
